~~SECRET~~**PART TWO: NARRATIVE SUMMARY**

Marine Aircraft Group-13 continued its support of III MAF and all other free world Armed Forces in the I Corps Tactical Zone, Laos and the Gulf of Tonkin. Operations supported were SCOTLAND II, KENTUCKY, TAYLOR COMMON, FAYETTE CANYON, VERMION LAKE, NEVADA EAGLE, VICTORY DRAGON VII, DAWSON RIVER, DEWEY CANYON, MARSHALL MOUNTAIN, BOLD MARINER, AND RUSSEL BEACH. Flying a wide variety of missions, MAG-13 aircraft provided support for the First and Third Marine Divisions, Task Force Hotel, U. S. Army, Republic of Korea Marines, ARVN Forces, Task Force 77, and the 7th Air Force.

MAG-13's Air-to-Ground effort of 1495 sorties resulted in 158 bunkers destroyed, 245 structures destroyed, 705 meters of trenchline destroyed, 17 confirmed KBA, 4 sampans and an assortment of gun positions, automatic weapons sites, mortar positions, and 1 water buffalo destroyed.

MAG-13 Phantoms logged 107 Fighter sorties over the waters off North Vietnam as a Barrier Cap in support of air operations in the Gulf of Tonkin. During the same period 16 MIG CAP and 4 Fighter Escort sorties were provided for B-52 Arc Light missions. There were no engagements with enemy aircraft.

The first Marine F-4J squadron in WestPac, VMFA-334, commanded by LtCol. J. R. SHERMAN, joined MAG-13 from MAG-11 on 24 January 1969. The transfer went smoothly and VMFA-334 continued to conduct combat operations throughout the transition period.

MAG-13 lost one aircraft as a result of enemy action during January. The pilot was rescued and suffered injuries requiring MEDEVAC out of country. The RIO was killed by the enemy before rescue could be accomplished.

VMFA-334, "The BLACK KNIGHTS" commanded by LtCol. F. B. PETERSEN, was presented the CNO Aviation Safety Award for FY-68 by General L. F. CHAPMAN, CMC, on 12 January 1969.

PART THREE; SIGNIFICANT EVENTS**1. Personnel**

4. Civic Action

a. 1-7 Jan: In Vietnamese custom, MAC-13 Civic Action Team was presented with a gift of Vietnamese art by the Long Phu I Hamlet Chief. The gift was in appreciation for efforts, to date, in his hamlet. The Civic Action Office was relocated and is operating as a separate function from Industrial Relations. Monthly scholarship payments were made in the hamlets of Long Phu I, II and Chu Lai New Life. One girl was med-evacuated to Tam Ky Province Hospital due to blindness in one eye. Consultation was given and referred to Da Nang. An operation restored partial vision and assured vision in the other eye.

b. 8 Jan: Three new MAC-13 Civic Action Projects were brought to Ly Tin District Headquarters for approval. The projects are a temple in Long Phu I, a hamlet headquarters building, and an additional two-room school building in Chu Lai New Life Hamlet.

c. 10-14 Jan: A Vietnamese child from Long Phu I was given consultation at the MAC-13 An Tan Dispensary for a hare-lip condition. Approval for corrective surgery was given by 312th Evacuation Hospital and a successful operation was performed.

d. 15 Jan: The Civic Action Officer escorted two Vietnamese representatives from the Chu Lai area to Da Nang to observe recent agricultural developments being conducted on an experimental basis by Vietnamese farmers. Ideas were brought back for improvements in local farming areas along with seeds for several vegetables not available in this area. A small farm has been set up to determine how these crops will grow in the local climate and soil conditions. If development is properly conducted, the local agricultural economy could be substantially bolstered.

e. 18-25 Jan: MAG-13 and MAG-12 were the recipients of awards at a ceremony given by the Province Education Superintendent. The awards were given for efforts in assisting the Ly Tin District Schools. The Civic Action Officer attended the Wing Civic Action Meeting. Civic Action emphasis is on more self-help and less give-a-way projects. Also objectives are geared to involve and utilize the local political system in all activities and try to show the people that their government can work for them.

f. 26-31 Jan: A meeting was held with the Long Phu I hamlet chief to discuss future plans of his hamlet. A buddist Temple is planned to be constructed in Long Phu I. MEDCAP Activities in Long Phu I and II have been revised and results have been more beneficial to the people this month.

5. Intelligence

General

a. During the month of January 1969 MAG-13 was enlarged by the joining of WIPA-334. The S-2 in particular was helped by the transfer of 1stLt G. A. GIBCOX and Sgt J. D. PAGANINI, JR.

b. The S-2 continued to brief all air crews prior to a flight and debrief same immediately upon return to the Chu Lai Air Base. Also during the month the tactical brief and Commanding Officer's Brief were presented weekly to provide both the Command and the commanded with pertinent information about the ever changing situation in I Corps and specifically the local area. The Staff NCO Brief continued to be held on Thursdays at 1530 for all Staff NCO's and Officers, in the MAG-13 Staff NCO Club.

Administration

a. Administratively, the S-2 has accomplished the compiling and publication of the Group Access List on 15 January 1969. While on 30 January 1969, the S-2 published a bulletin indicating that all flight officers must have a top secret clearance. Another bulletin that was composed during the month, but not published until 1 February 1969, deals with the use of enemy jamming or intrusion of our communications systems. (GruBul 02000)

b. During the month a total of 10 personnel were granted a clearance, while 25 personnel either had investigations submitted or request for verification of an already completed investigation.

c. The largest amount of man hours during the month was used to complete the semi-annual inventory of classified material as well as the preparation for turning over all classified material to the new S-2 Officer, upon departure of the existing S-2. Well over 100 hours were spent ensuring that all materials were up to date and in accord with the list of charged documents held by the S & C.
