PART TWO: NARRATIVE SUMMARY

Marine Aircraft Group-13 continued its support of III MAF and all other free world Armed Forces in the I Corps Tactical Zone, Laos and the Gulf of Tonkin. Operations supported were EAGER PURSUIT, KENTUCKY JUMPER, RUSSEL BEACH, MASSACHUSETTS STRIKER, DEWEY CANYON, VICTORY DRAGON IX, IRON MOUNTAIN, MAINE CRAIG, GENEVA PARK, FREDERICK HILL, OKLAHOMA HILLS AND PURPLE MARTIN.

MAG-13 Air-to-Ground effort of 2013 sorties expending 4370 tons of ordnance resulted in 293 bunkers destroyed, 622 structures destroyed, 79 secondary explosions, 226 secondary fires, 48 confirmed KBA and 4 Chieu Hoi's.

MAG-13 Phantoms logged 168 BARCAP sorties over the waters of North Vietnam in support of the Seventh Fleet air operations in the Gulf of Tonkin. In support of the Seventh Air Force, 18 F4 Escort Missions were flown for protection of the B-52 Arc Light Flights. There were no engagements with enemy aircrafts.

Highlighting the month of March, MAG-13 changed command on 5 March 1969 with Col N. W. GOURLEY being relieved by Col R. S. RASH. The ceremony held on the MAG-13 flight line was attended by many distinguished guests.

On 2 March an F-4J of VMFA-334, flown by LtCol S. E. D'ANGELO and 1stLt DALY took a hit during a CAS mission south west of Danang. The aircraft burst into flames forcing the crew to eject. Rescue was completed without injury despite heavy hostile action.

VMFA-314 changed command on 9 March 1969 with LtCol T. R. MORGAN being relieved by Major J. W. BLACK.

On 21 March VMFA-314 was designated the "Most Outstanding Marine Fighter Squadron" in the Marine Corps with the presentation of the Robert M. Hanson award.

VMFA-323 "Death Rattlers", a veteran of Vietnam with more than 17,000 combat sorties and 21,000 combat hours was relieved by VMFA-232 on 30 March 1969, in one of the most successful Transpacs in history.

4. Civic Action

- a. 1-10 March: Work on the Information Center in Long Phu II is nearly complete.
- b. 10-13 March: Meetings were held with 1st Lt KING of 9th Engineers and the three hamlet chiefs of Ky Lien Village. 9th Engineer responsibilities and pending projects were discussed. They will complete all unfinished projects.
- c. 13 March: The 1969 Attitude Survey was conducted to determine problem areas in intercultural relationships between the Americans and the Vietnamese. From the survey a training program will be developed to increase positive attitudes between the Americans and the Vietnamese.
- d. 14-31 March: MAG-13 Civic Action met with Binh San District Officials to coordinate new areas and discuss needed projects. Plans were made to meet with Binh Sa Village Chief and Hamlet Councils in the near future.

5. Intelligence

- a. During the month of March the S-2 Section continued to brief and debrief all flight crews. The section also continued to brief the CO daily as well as the CO's conference each week. The Staff NCO's were briefed each Thursday at 1500 on the local situation.
- b. Also this past month VMFA-232 personnel were briefed upon their arrival at Chu Lai. The squadron's advanced party was briefed on the 20th and the remainder of the squadron was briefed on the 31st of March 1969.
- c. A Group SERE brief was conducted on the 6th and 7th of March with a guest speaker from the Wing G-2. Also during the month the S-2 in conjunction with the S-3 continued to brief all new flight personnel every Monday and Friday at 1300, on SERE and other related subjects.


