6. Intelligence

a. On 8 and 15 October 1969, the S-2 Officer and a representative from MAG-13 S-3, attended ZIPPO Briefs for the coordination of operations conducted southwest of Danang. Upon returning, maps were prepared and briefs given to crews flying in support of these operations.

b. During the month of October 1969, the Chu Lai Air Base complex came under rocket attack one time. This attack took place on 29 October at 1245 when 4X122mm rockets impacted. One rocket landed in the MAG-13 bomb dump with a direct hit on a Conex box, destroying twenty-four fire extinguishers and minor damage to another Conex box plus the bomb dump office. There were no casualties as all personnel were eating lunch. Two rockets landed near the east runway causing one damaged helo with one Army wounded. The fourth rocket caused no damage or casualties.

c. The S-2 section continued to accomplish its mission of supporting MAG-13 with intelligence information by preparing daily briefs to the aircrew members, as well as for the Commanding Officer and Executive Officer. All incoming flight personnel received their in-country brief from the SERE Officer. During the month of October a total of thirty-two briefs were given by this section to newly arrived crew members.
