PART II

NARRATIVE SUMMARY

1. (S) On 6 April 1972, Marine Aircraft Group 15 began a period of combat support for South Vietnamese ground forces against the invasion of that country by the North Vietnamese Army. Both VMFA-232, and VMFA-115 deployed to DaNang Air Base, Republic of Vietnam with supporting elements of H&MS-15, and MABS-15. A detachment of five EA-6A aircraft from VMCJ-1 deployed to NAS Cubi Point, Republic of the Philippines in support of CTF 77. H&MS-15 deployed 5 TA4 aircraft to Danang AB, RVN on 15 April 1972. Details of these deployments will be contained in separate chronologies.

- H. Equipment (C) Most H&MS-15 and MARS-15 equipment deployed in support of MAG-15 commencing 7 April 1972.
- I. Logistics (C) Air Force C-141's and Marine Corps C-130's heavily supported the deployment to DaNang AB. The First Marine Aircraft Wing established a Marlog to provide logistical support to units in RVN.
- J. Community Relations (U) No significant events to report
- K. Communications (S) 95% of this organization's communications assets deployed to DaNang AB.
- L. Activations/Deactivations/Redesignations (C) The Command Element of MAG-15 was designated the task designator of CTU 79.3.0 on 25 April 1972.

- O. Readiness (S) This organization deployed two F-4 squadrons, supporting elements of the H&MS and the MARS, and a detachment of VMCI EA-6A aircraft within a period of less than one week. VMFA-115 responded to contingency deployment in less than 24 hours.
