One KC-130 inbnd fm Iwakuni to Danang received hit on rt stabilizer. Damage consisted of ruptured hyd lines. Repaired at Danang. No crew injuries. Efforts of Security Detachment were directed toward improvement of defensive posture and living conditions on airstrip and within the compound. Barbed wire and sandbagged defensive positions were erected on eastern side of compound to effectively provide security for new centralized motor transport installation. Head facilities, office working spaces, and living areas improved. (See employment of Engineer Squad.)

PERIOD 1-15 FEB 65

Operations of the detachment during the period saw an intensification in the overall security effort at Marine Unit, Vietnam. Recent terrorist activities and attacks upon U.S. airfields and facilities elsewhere in the Republic have signalled a reassessment of responsibility for the safeguard of property and the lives of Marines in this area. Additionally, the arrival in Danang of elements of the 1st Light Anti-Aircraft Missile Battalion, while enhancing the air defense posture of this facility, presents not only an additional, but a highly remunerative target to ground fire and possible mortar attack.

Incidents of ground fire have occurred with greater frequency than was reported in the previous period, while a corresponding increase in infiltrator activity was evident (reference, in particular, Summary of Ground Fire Incidents, 1 February 1965, 2250 entry.)

The frequency with which such incidents have occurred in the runway, apron, and hangar complex in the recent past, and the apparent present threat of their continuance, necessitated emplacement of two ambush sites on 2 Feb 65, and the transfer of the post of Officer of the Day from the compound to the hangar facility between the hours of 1830 and 0630. Ambush sites A and B are situated near the relatively unprotected southwest portion of the main runway, and are manned between the hours of 2200 and 0200 nightly. Site A consists of three men, two of which are armed with 12 Gauge riot guns, the other with a .45 caliber submachine gun. Site B is manned by two men, one with a .45 caliber submachine gun, and the other with a 12 Gauge riot gun. An extensive network of recently placed trip flares provides the early warning necessary to alert the counter-mortar radar section to an impending infiltration effort and/or attack, provide the illumination necessary for the proper deployment of either ambush A or B, and alert other sentries in the area. Communication between the ambush sites and the Officer of the Day/Sgt of the Guard is maintained with the PRC-6 radio. Ambush sites were established to prevent or discourage further attempts at infiltration and ground fire into the UH-34D and UH1B parking aprons, at the same time attempting to capture and, if necessary, disable by fire, persons attempting to gain entry. On at least two occasions since this procedure has been adopted, an unidentified person has tripped the illumination and fled before any response was initiated. It appears that through the adoption of the preceding precautions, further attempts of this nature may be discouraged.

The occasion of Tet, a three day holiday signalling the commencement of the Vietnamese New Year, gave rise to many incidents wherein ARVN, Regional Force units, and Popular Forces, in celebration, fired great quantities of small arms ammunition, including mortar illumination, in and around the Danang airfield complex, many of which impacted on or near the airstrip and hangar facilities. Sentries, however, were alerted to the situation constantly, and fire discipline was observed and accidents averted.

With the exception of the return fire incident involving a Security Detachment sentry and one confirmed infiltrator on 1 Feb, no other firing incidents involving members of the Command have occurred, either accidentally or intentionally, since assumption of security responsibilities. Detachment security requirements are currently under reassessment in light of the arrival at Danang of the 1st Light Anti-Aircraft Missile Battalion (1st LAAMB). The battalion, under the command of LtCol B. E. COOK, is composed of three missile firing batteries and a Headquarters and Service battery and possesses an operational strength of 546 officers and men. A sea-tail comprised of at least an additional battery and the Headquarters and Services battery is scheduled for arrival and unloading at the port of Danang during the period of 15-16 Feb 65. Firing batteries will be operationally employed, initially in the Danang airfield complex with the H&S battery situated in a former French compound immediately west of the runway.

Realignment of security measures to include creation of additional, as well as modification of existing posts in the airfield complex is currently under study and is scheduled for implementation not later than 18 Feb 65. With regards to the security of the battery, now operational, the following special security measures have been immediately assumed by the Security Detachment for initial protection against infiltration, ground and mortar fire.

- a. Assignment of six sentries on the perimeter of the battery site.
- b. Emplacement of two M-60 machine guns, one of which has been mounted in an M38A1 jeep for motorized capability.
- c. ANPRC-6 communication between sentries; the net is monitored with an ANPRC-10 by the Security Detachment Officer of the Day.
- d. The eventual filling and emplacement of 50,000 sandbags to provide protection to six battery missile launchers and CWR and PAR radars. Several hundred 55 gallon drums filled with sand will provide additional fortification to other equipment of the battery.
- e. Emplacement of a network of trip flares on the perimeter of each battery is anticipated.

The introduction of this battalion (LAAMB) is not expected to have a depreciating effect on the security posture now maintained under the present security in-country strength ceiling of 260 officers and men. The eventual relocation and permanent installation of battery firing sites in rather far-flung areas of the sensitive DANANG periphery, however, will require a satelliting of security elements from the Security Detachment Headquarters to each of the firing sites and additionally require serious reassessment of the parent unit's ability to perform it's mission under the presently established ceiling. Strength and composition of such security satellites will, if necessity, depend upon configuration of the battery site, topography, availability of other support forces in event of attack, installation of fences, alarms, and fortifications, re-supply considerations and the degree of security, if any, to be provided by the battery itself. It is therefore axiomatic that a study of the preceding considerations should be conducted concurrently with the layout and design of each site and that subsequent construction should develop from a blueprint reflecting, among features, a design not only for effective operational employment of the battery, but for the security of its personnel as well.

#### TRAINING ACTIVITIES

The Security Detachment is currently engaged in preparation for, and conduct of, the following activities.

1. French Language Class: Classes commenced Monday, 8 Feb. with an enrollment of 44 personnel; periods on a 1 hour basis.

The class is run on a 6 day per week schedule. Initial response is considered excellent. Commencing Monday, 15 Feb, classes in Vietnamese will commence for 34 personnel of this command. Classes are scheduled for a period of one hour per day, 6 days per week. The class instructor is a Marine Sergeant assigned as interpreter for Sub Unit #2, will orient such instruction to the teaching of military and other language phrases necessary to the encouragement of communication between U.S. service personnel and the Vietnamese.

2. Commencing this week, a recapitulation of current events, to include significant military actions in this area, latest news on local and international situations, and other items of general interest is to be presented in the form of an hourly briefing to personnel of this command on Friday of each week. Classes are to be presented by an officer of this unit.

3. Contingent upon the availability of a small arms range, under operational control of I Corps, this detachment proposes to conduct familiarization firing for M-14, .45 caliber pistol, and shotgun in the near future; simultaneously, it will provide necessary range personnel, instructors, and a safety officer for fam firing of SU#2 personnel.

4. Daily guard school continues, being conducted by the Commander of the Guard, under the supervision of the Officer of the Day. Recent incidents involving sleeping on the post have been cause for considerable concern to the command with the result that efforts are being immediately intensified toward exposing the problem. On at least three occasions since arrival, Commanding Officer's briefings to the Detachment have stressed the vital requirements for the uninterrupted security in this area and the penalties attached to offenses committed while posted as a sentinel. It is believed that a recently instituted policy of hourly inspections of the guard, availability of coffee or other beverages to sentries, immediate relief of those who appear incapacitated, and thorough indoctrination of sentries concerning preventative measures necessary when the likelihood of sleep becomes evident, as well as constant attention to avoid prolonged periods of watch for any one sentry, will substantially reduce the probability of reoccurrence of these offenses.

5. Regularly scheduled organized athletics continue as a part of normal training program. In addition, recent approval was granted the command by Commander, Task Unit 79.3.5 to conduct a series of platoon sized recreational outings in a secure beach site in the DaNang area; parties are to commence at such time as the current military crisis becomes less sensitive.

6. 5 Feb was highlighted by the visit of LtGen V. J. KRULAK, CG, FMFPAC and Staff to the Marine Unit, Vietnam. Armed escorts from the detachment were provided and accompanied the General during his tour of the Marine compound, HMM-365 facility, and briefing at I Corps Headquarters. The same security measures will be provided during the visits of LtGen Nguyen KHANH on 11 Feb. and CINCPACFLT on 13 Feb.

7. Weapons restriction. Of interest to the relieving detachment is the receipt of a recent 1stMAW directive providing, in part, "All persons traveling on board aircraft of the 1st MAW which will land in the Republic of Vietnam are prohibited from taking on board or causing to be taken on board the following weapons: any weapon not issued to the individual by the U.S. including firearms, knives, with blades in excess of three inches, switchblades of any lengths, explosives, compression guns, knuckles, blackjack", etc. Task Unit Order 8110.1 of 3 Feb 65 additionally provides the following guidance "... MUV personnel are not authorized to import into Vietnam privately owned or souvenir weapons..." for purpose of this order, a privately owned weapon is defined as any weapon which has not been issued to the individual by any of the United States Armed Forces or the Military Forces of the Republic of Vietnam. In view of the preceding directive, it is imperative that the incoming detachment screen all personnel prior to departure for Vietnam to insure that all personal weapons are confiscated.

## ENGINEER OPERATIONS AND WORK PROJECTS COMPLETED.

The following projects were completed during the period 1-15 Feb 1965.

1. Relocated 60 MM mortar positions within the compound; constructed and sandbagged new firing positions.
2. Constructed three new bunkers in the motor transport facility; constructed new machine gun bunker.
3. Rebuilt parapets in area of Staff NCO quarters.
4. Relocated urinals and repaired head at airstrip.
5. Located additional fire barrels in tent area.
6. Constructed new fighting trench reinforced with sandbags for protection of Counter-Mortar Radar personnel.
7. Placed decking in two guard tents at airstrip.
8. Wired supply tent for lighting.
9. Constructed a sandbagged protective wall at entrance to Guard Office.
10. Rebuilt three mortar shelters utilizing CONEX containers and sandbag reinforcements.
11. Constructed four fighting holes for 81MM mortars personnel.
12. Constructed a series of charts for briefing purposes.
13. Constructed a screen partition between the guard office and library. Installation of a dutch door provides control necessary for dispensing of arms and ammunition and establishes a more restricted area.

Rehabilitation of the security unit tent area through construction of decking, strongbacks, doors, screens, and head facility is expected to proceed as planned with the recent approval of CG, 3dMarDiv for local open purchase of lumber and hardware materials. Actual construction should begin not later than 15 Feb. Additional materials, not available through local open purchase, are expected to arrive Danang 12 Feb 65. Other projects under construction include:

1. Construction of drainage ditches within the compound.
2. Construction of additional fighting bunkers and mortar shelters in airstrip and compound area.
3. Construction of two permanent bulletin boards.
4. Rehabilitation of an unoccupied compound to accomodate Headquarters Battery, 1st Light Anti-Aircraft Missile Battalion.

At 0300, 11 Feb, in response to an appeal for assistance in connection with rescue operations, the attached Engineer squad was air-lifted by Army Caribou to Qui Nhon, Vietnam. Accompanying the squad were elements of the utilities section, SU #2, the Executive Officer, 3dEngrBn, 3dMarDiv, and an additional officer and enlisted engineer representative. It is anticipated that the squad will remain in Qui Nhon until victim recovery operations are completed.

#### COUNTER MORTAR RADAR OPERATIONS

During this reporting period, communications were established between the Counter Mortar Unit and the Operations Center, Danang Special Sector. Communications thus established will insure immediate response by ARVN artillery and mortar units to target information passed from Counter Mortar. On 9 Feb, the section went on a full alert, having been informed of possible mortar attack; no unusual incidents occurred nor were tracks and plots established.

On the night of 10 Feb, between the hours of 2000 and 2130, several tracks and plots were made of rounds fired 3000-4000 meters south-east of the main runway. This information was transmitted to the Danang Special Sector. No other unusual events occurred during the period nor were any major electronic failures recorded.

Operations of the Security Detachment, Marine Unit, Vietnam during this period saw an increase in the overall security effort. Arrival of the 1st Light Anti-Aircraft Missile Battalion (LAAMB) and Company C (Rein), 7th Engineers, during the reporting period, signalled a necessity for rapid realignment of security measures in this area without interruption or substantial decrease in already existing security requirements. In the interests of achieving optimum security of Marine units at Danang with those security forces available (260), the guard force has been recently apportioned among the following units and facilities.

1. Battery "A", 1st LAAMB
2. Battery "B", 1st LAAMB
3. Compound, Marine Unit, Vietnam
4. Helicopter hanger and apron complex, Danang Airfield
5. Special Guard

## TRAINING ACTIVITIES

The Security Detachment is currently engaged in preparation for, and conduct of, the following activities.

1. French Language Class. Classes commenced on Monday, 8 Feb and are scheduled daily except Sundays, for a one hour period. Attendance, although voluntary, has been appreciably reduced with the increase in security commitments. Initial enrollment of 44 persons has been reduced by three-quarters while the Detachment was forced to cancel scheduled Vietnamese classes.

2. Weapons Firing. On 26 Feb, a two hour machine gun school was conducted by weapons platoon personnel for members of Sub Unit #2, MABS-16, MUW. Upon completion of instruction, Security Detachment Squad leaders, gunners, and assistant gunners accompanied 14 members of the Sub Unit to an Army Special Forces firing range and conducted a fam-fire exercise employing fire at fixed targets, searching & traversing, and applying immediate action.

3. Familiarization firing of the 60MM mortar is scheduled during an all day period on 1 Mar. A two hour lecture and gun drill to be conducted by the NCOIC, 81MM mortar section, will precede fam-firing. Instruction will include basic nomenclature, functioning, firing techniques, ammunition handling, and adjusting fire. Actual familiarization firing employing two 60MM mortars will be conducted at an ARVN range between 1330 - 1630 on 1 Mar.

4. Fam firing of the M-79 grenade launcher is scheduled to be conducted Friday, 5 Mar. Details to be included in next report.

5. Guard School. Guard schools continue to be conducted at three separate intervals daily, all of which are supervised by the Officer of the Day and the Commander of the Guard. Incidents involving sleeping on post continue to be a cause of considerable concern to this command. To date, the Detachment has experienced five such cases, one of which was a repeat offense. While continuing to pursue those measures reported in previous summaries, it appears that the underlying basis of the problem may be more directly attributable to matters over which the individual sentry has little or no control than to a failure to properly supervise functioning of the guard. Statistics provided depict that the assumption of security responsibilities, with the arrival of 1st LAAMB, has resulted in the commitment of approximately 75% of this command for security duties three night out of four with liberty accruing to the individual on an average of two nights out of six. The minimum watch for any one sentry is six hours with only two reliefs available for a twelve hour period. Apparently, prolonged periods where the sleep process is reversed has a depreciating affect on the individual, regardless of the moderately relaxing training and work program.

6. **Visitors.** General W. C. WESTMORELAND, COMUSMACV, visited Marine Unit Vietnam on 21 Feb, and U.S. Ambassador Maxwell TAYLOR on 27 Feb. CG, 9th MEB and members of his executive and special staff spent the night of the 21st at MUV and departed via Flight 5 on 22 Feb, while LtCols COTHRAN and HOLT, and Maj BAITY, 3dMarDiv representatives, arrives 16 Feb and departed the 19th. Transportation and armed escorts were provided by the Detachment as required.

7. **Athletics.** Regularly scheduled organized athletics continue as a part of the normal training program.

#### Counter Mortar Radar Operations.

During the reporting period a wire line was established as the primary source of communications between the Counter Mortar Radar unit and the Operations Center, Danang Special Sector. Installation of wire effectively decreased reaction time necessary to transmit information. The radio communications, presently used as an alternate communications system, were improved by erection of an RC-292 radio antenna at the Counter Mortar site. The Counter Mortar Radar unit received one PU 344/G generator on temporary loan from 1st MAW to be used as primary power source for AN/KPQ-1 (counter mortar radar set). On 16 Feb, a mechanical failure occurred which prevented correct plotting information to be produced. On 22 Feb a repair part arrived and the discrepancy was corrected. Also, on 22 Feb, an electronics failure in the radar set decreased the operational effectiveness of the unit. Repair parts were requested and received on 26 Feb. The unit is presently fully operational. During this period, no unusual incidents occurred and no tracks or plots were established.

B. Poured concrete flooring for CTU laundry and replaced screens on windows and doors.

C. Strongbacked, screened, and constructed doors for two guard tents. Constructed four new tent decks and pre-cut materials for at least six additional units. Rehabilitation of the Security Detachment tent area to include construction of sixteen new tent decks, strongbacks, doors, and screens, is progressing as scheduled and will be completed by 15 Mar. Approximately 30% of open purchase lumber and hardware materials was delivered on 24 Feb; remaining materials are available for immediate delivery.

D. Engineers are also currently engaged in installation of plumbing necessary to restore a shower and toilet unit located in a building adjacent to the tent area. Procurement of basins, installation of a hot water heater, and replacement of screening and doors are included in plans for renovating this facility. Completion and use of this head and shower unit will obviate the necessity of constructing a less desirable portable head in the tent area and substantially reduce consumption of water pumped from the well which now serves the Marine compound.

2125 Sub Unit #2 corpsman accidentally fired one round in aig station while cleaning .45 caliber weapon. Commander of the Guard investigated. Security Officer, CO, Security Detachment notified. No injuries. Round was recovered.

8 Feb 2345 Five tracer rounds reported fired south of the runway.

9 Feb 1900 Six sentries, two M-60 machine guns and roving patrol with ANPRC-6 posted on the perimeter of the arriving LAAMB battery.

The Heavy Equipment Section performed normal camp maintenance, continued work in new Motor Transport area. Conducted routine heavy equipment maintenance repair and checks.

Normal laundry operations continued in the Laundry Section. 7704 lbs of laundry were handled during this period.

The Electrical Section throughout this period continued to perform routine camp electrical maintenance. In addition, wired the new Motor Transport building and completed electrical work in hangar area.

Routine camp maintenance was performed by Plumbing Section.

Combat Engineers were employed in construction work in new Motor Transport during this period. Minor repairs made in Compound area.

PERIOD 1-15 FEB.

Heavy Equipment Section continued routine camp maintenance. Graded compound roads and parking area. Graded outlying roads and began leveling campsite area for additional security troops. Began work in old French compound, preparing it for 1st LAAMS arrival.

Laundry Section continued normal operations. 7,239 lbs laundry were processed during this period.

Daily maintenance conducted on all generators and refrigeration units. These sections are continuing a vigorous "trouble shooting" program, thereby reducing unit outage time.

Routine camp maintenance by plumbing section. Also working in French compound for 1st LAAMS.

Combat Engineers completed construction in Motor Transport area and began work in French compound. Emergency repairs were made as necessary in the Marine compound.

PERIOD 16-28 FEB.

Heavy Equipment Section continued work in 1st LAAMS area. Routine camp maintenance performed daily.

Laundry Section continued routine operations. 7,706 lbs laundry were processed.

Electrical Section performed routine electrical maintenance and trouble shooting during this period. Various light fixtures were either repaired or replaced throughout Marine living and working areas.

All other Utility Sections were engaged in routine camp maintenance and construction.

PERIOD 1-15 MAR.

Heavy Equipment Section continued routine maintenance and service checks on all equipment. Performed normal and camp maintenance tasks.

Laundry Section continued normal operation. Processed 8,628 lbs of laundry this period.

All other Utility Sections were engaged in renovating 9th MEB living and working areas during major portion of this period. Routine camp maintenance was also continued during this reporting period.

PERIOD 16-31 MAR.

In addition to routine camp maintenance, the Heavy Equipment Section graded a new Motor Transport parking area, performed maintenance checks and repairs on heavy equipment assigned to their section.

Laundry Section continued normal operations. Processed 6,245 lbs laundry during this period.

All other Utilities Sections were engaged in routine camp maintenance during this period.

COMMUNICATIONSPERIOD 15 JAN 65 - 31 MAR 65PERIOD 15-30 JAN 1965

During this reporting period the overall communications have been generally fair to satisfactory, major problem being 1st Comms Hi Comm Net. Tech assistance was asked from SRF Yokosuka and provided when ET1 SAWICKI arrived on the 26th. Progress was made to correct the difficulties, through the diligent efforts and knowledge of ET1 SAWICKI. A letter was forwarded to Commanding Officer MOTU-13 concerning the above mentioned Navyman.

Liason visit made by Capt FRY, Communications, 1st MAW. Work continued on improving the area in and around the Comm Center. Under the present T/O, the Communications section is seven men under strength, six 2541's, one 2561. This does not include 1st Comm personnel.

1. Wire Section: This section during this period installed three 30 pair cables on the switchboard, and changed three key shelf section on board. A new rod was installed for board and all incoming cables outside of switchboard room were cabled. Installation of new TA-125's were made in compound area. Trouble shooting continued on lines 215, 104, and T.O.C. line. A line was installed to the 81 MM section. Preventative maintenance of equipment was continued.

2. Radio Section: The Wing Liason Net was operated with 82 incoming, and 73 outgoing phone patches, for a total of 155. Plans are being made for extending receiver antennas on the Hi Comm Net. Tests with the helo-mounted PRC-47 will continue as committments permit.

3. Message Center: Due to the request of Avionics, the working air-conditioner had to be returned. Existing air conditioner is not working due to lack of spare parts which have been on order for 6 months. Steps are now being taken to ship complete unit back to supply officer, MAG-16, for replacement or repair. Circuit outage factors are as follows; 102 hours transmitting and receiving, frequency trouble, and the passing of QSY's via the phone. Message traffic for this period ran 928 incoming, 864 outgoing, for a total of 1,792 for an average of 118 per day.

1st Comm maintaining operations with difficulties described in opening statement. Repair section has done excellent work through long hours to maintain existing equipment of MUV Operative. Supply requisitions are also being handled by this section.

PERIOD 1-15 FEB 1965

Communications have been good to excellent despite the influx of traffic in all sections during this reporting period. Arriving for duty with the Command was 1 Sgt, 2632, and departing the Command were 1 Cpl, 2611, and 1 LCpl, 6621.

Under the present T/O, the Communications Section is 9 men under strength, 5 2541's, 2 2543's, 1 2533, and 1 2561. Liaison with the 1st LAAM Bn has been accomplished, support and requirements have been met to a satisfactory degree despite the overload of work.

1. Wire Section: During this reporting period a 26 pair cable was installed from the Air Force Security to LAAM Bn area. The LAAM Battery was tied into our switchboard and two lines were laid from Alfa Battery to the terminal strip at the end of the runway for communications to the radar site on Monkey Mountain. The alert system within the compound was tested and proved satisfactory. On 12 February, a check was made on the number of calls with the following results; 0830-0930, 130 calls. 0930-1030, 142 calls, an increase of about 20 calls per hour from the previous tests made. The speakers in the public address system were checked and phones in the Senior BOQ, Junior BOQ, S-1B, and Radio Central were removed and replaced. Trouble shooting and preventative maintenance of equipment was continued.

2. Radio Section: This section continued operations with watch extended to 7 days a week on a 24 hour basis on the Wing Liaison Nets. During this period, there were 70 incoming, and 82 outgoing phone patches, for a total of 152. The receiver antenna on the RATT Circuit was extended, increasing reception at least 30%. Radio is now in the process of installing a permanent antenna for Liaison Net.

3. Message Center: Center operations continued with steady and expedient means. There were 1490 incoming and 532 outgoing messages during this period. We are anticipating augmentation of personnel from 1st LAAM Bn upon arrival at this headquarters. Circuit outage factors; 47 hours transmitting, 56 hours receiving while excessive heat caused KWT-26 failure. A breakdown of the alternating current line filter which leads to the electrolyte and started leaking on the AC input plug, was ignited by a surge of current and caused a small fire. The end results were two special purpose cable assemblies being burned. Extent of damage is such to deadline equipment until replacement parts are available. Air conditioner still at MAG-16 under repair.

1st Comm maintaining normal operations with satisfactory results. Repair section is on a 24 hour working status to keep equipment in a state of combat readiness. Spare parts being built up, but a shortage still exists in certain areas.

PERIOD 16-28 FEB 1965

During this reporting period the overall communications in all sections have been satisfactory. Arriving for duty with the Command was Capt T.J. HILL, 2502. Under the present T/O, the Communications section is 14 men under strength. Action is being taken to relieve the situation. Despite the heavy influx of traffic in all sections, and shortage of personnel, the Communicators of CTG 79.4 have done an outstanding job of continuing to get the job done.

1. Radio Section: Operations continue on a 24 hour basis on the Wing Liaison Net. There were 70 incoming and 62 outgoing phone patches, for a total of 132. The guy lines were changed in the antenna farm to steel wire to prevent any future cutting. Equipment loaned out to the Air Force was returned. Radio checks with all subordinate units were made to insure our alert capability from the new CP bunker.

2. Message Center: Operations continued with 578 outgoing and 1,146 incoming messages, a total of 1724 for the 14 day period. Circuit outage factors; 32 hours and 42 minutes of transmitting and 39 hours 40 minutes receiving. Major outage of transmit and receive due to radio transmitter in 1st Comm, power failures and frequency difficulties encountered. Area in and around the Comm Center was improved for protective measures.

3. Wire Section: Normal switchboard operations were continued during this period. Lines were laid for Alfa and Bravo batteries of the LAAM Bn. Line was also laid to "C" Co of the 7th Eng Bn. Trouble shooting continued on various lines and SB-22 switchboard at HMM-163 Operations. The alert phone system was tested again and proved satisfactory. The terminal box at the Air Force Security was cleaned up and at same position a new terminal strip was installed.

1st Comm continued operations with difficulties due to the shortage of repair parts which have been on order. The Repair Section during this reporting period had over 25 troubles in equipments which were processed. A total of 20 requisitions were handled by the Supply Section. A report from the repair section chief stated that equipment being down is due mostly to the waiting time between the ordering and receiving of spare parts. 4 pieces of equipment were evacuated for repair work.

PERIOD 1-15 MAR 1965

During this period, communications in all sections have been satisfactory. Arriving for duty with the command were 1 Sgt 2561, 1 LCpl 2511. Departing the command were 2 2531's, 3 2543's, and 1 GySgt 2561. Augmentation of the 9th MEB personnel has been accomplished in the Comm Center with some difficulties, but smoothness within the communication center has been worked out. The air conditioner has been installed and is operating efficiently. Required communications within the 9th MEB at this time have been established and functioning.

1. Radio Section for this period had a total of 156 phone patches, breakdown as follows; 91 incoming, 65 outgoing.
2. Operations in the Comm Center continued with the following results on message traffic; 860 outgoing, 2198 incoming, for a total of 3,058 for the period. Circuit outage factors noted receive 30 hours 30 minutes, outage due to switchover of generators, power failures and some difficulties encountered with frequencies.

3. Wire Section ran an additional 25 pair cable from Air Force Security to the 9th MEB. As the situation continues to change the wire section has constantly been on the job of running new lines and trouble shooting. And the continuation of handling additional traffic through the switchboard.

4. 1st Comm continued operations without the service of the HICOM Net, due to the shortage of spare parts.

5. Repair Section continued to maintain the operational readiness of equipment within the compound, plus additional work as required by other units of 9th MEB, until establishment of other repair sections.

PERIOD 16-31 MAR 1965

During this reporting period the relocation and activation of other Squadrons was accomplished. The transmitting and receiving agency of the 9th MEB is still being operated at MAG-16(-) Comm Center by MAG-16(-) personnel. The strength of the Comm Section of MAG-16(-) stands now at 46 enlisted and 1 officer. MAG-16 (Rear) at this time stands at 10 enlisted and 1 officer. The overall communications for MAG-16(-) has been excellent despite long and tedious hours put in by all sections to keep up with the pace of the 9th MEB.

1. The Message Center continued operations with the following results noted on msg traffic; incoming - 2,576, outgoing - 1,111, an increase of approximately 700 over the last period. Circuit outage factors, receive 42 hours, 5 minutes, transmit 33 hours, 35 minutes.

2. Repair Section processed 141 supply requisitions. 10 pieces of gear were shipped to higher echelon for repair and 77 pieces of gear were processed at this level. Spare parts for HICOM Net put on order 22 Feb, have not yet arrived at this position.

3. Radio Section continued phone patch capabilities on the Wing Liaison Net with the following results noted; incoming-108, outgoing-114.

4. First Comm continued operations without the services of the HICOM Net due to shortage of spare parts.

5. Wire Section installed an additional SB-86 switchboard to handle the increasing telephone system within and about the compound. A new wire diagram and telephone directory are in the process of being made.

4. On 20 March, SSgt Richard A. PRICE, USA, MACV Team #2 was brought to the dispensary via helicopter after being wounded in both legs by small arms fire in the Din Van sector. Patient was transferred directly to the Field Hospital, "C" Med Bn.

5. On 22 March, a Marine was brought to the dispensary via helicopter from Hill #327, suffering from heat exhaustion. The patient was taken to the Field Hospital, "C" Med Bn, for further treatment.

6. On 28 March, Capt W.D. REYNOLDS, USMC, HMM-163, was brought to the dispensary via helicopter. The patient was dead on arrival at this activity. He had been partially decapitated by a helicopter rotor after his craft had crashed. The remains were taken to the Field Hospital, "C" Med Bn, for preparation, prior to being shipped to Saigon.

7. On 31 March, a mass casualty situation was declared at this dispensary as a result of enemy ground fire taken by the helicopters of HMM-163 while on a sortie in the area of Viet An. All told, there were seventeen personnel wounded, six of whom were immediately evacuated to the 8th Army Field Hospital in Nha Trang after being initially treated at the Field Hospital, "C" Med Bn, two personnel were evacuated the following morning to 8th Army Field Hospital, Nha Trang for further definitive care, the remainder of the wounded personnel were treated and returned to duty. There were two personnel fatally wounded in this action; (1) MAGEL, James E., 1st Lt, USMC, HMM-163, and (2) ELIASON, Wendall T., 1st Lt, USMC, HMM-163. Both men were dead on arrival at the dispensary and the remains were taken to "C" Med Bn Field Hospital for further disposition. In addition to the seventeen wounded in action were two personnel from the 7th Aviation Platoon. These two patients also were evacuated to the 8th Army Field Hospital at Nha Trang after being rendered initial treatment at the Field Hospital here.

Liason contacted the 5th Inf Regt (ARVN) Security several times concerning small arms fire, new employees, permission for messmen to enter ARVN gate during early morning hours, placing of a Marine sentry at ARVN gate during rush hours to aid in shaking down incoming employees, installation of barbed wire and turning lights around. Payday for government employees was held on 27 Feb. Corrective action was taken to stop the female employees of the BOQs and the base laundry from collecting the empty beer bottles out of the trash dump every morning; these were apparently being stockpiled and taken off the base one at a time and sold in town. At 1600 hours, 23 Feb, worker #52 reported that his pass was missing from it's place on the pass rack. No one could account for the whereabouts of the pass, so the worker was subsequently issued pass no. 119, and the appropriate departments notified of the incident. Security Company was informed and advised to have their sentry on duty at the ARVN gate informed to be on the look-out for this pass, and also to watch carefully for erasures. Issued three passes to laundry boys for LAAMS. Settled a dispute between two bar-maids from the Officer's Lounge. Hired two additional workers for the base laundry. Requested and received permission from the Security Officer, Sub Unit #2 to hire a female employee with the ability to speak either French or English who would shakedown all female employees each time they enter or depart the compound.

The Liaison section contacted 5th ARVN Security on several occasions for: permission to post a Marine sentry on the ARVN gate between the hours of 0700-2000 daily; a background check on all club girls; investigated the unauthorized use of electrical appliances in the ARVN compound at night which were overloading our generators; cautioned the ARVNs about movement in the Marine compound at night; obtained permission to install new lights along the dividing wire; instituted a means of speeding up processing of security clearances for new employees; at approximately 2100, 24 Feb, verified the identification of 4 ARVN soldiers found near the airstrip; handed over four letters which were turned in by a pilot of HMM-163 for ARVN personnel.

During this period this office interpreted for the CO Sub Unit #2, Security Officer S.U. #2, S-4, Utilities, Messhall, S-2 of HMM-163, Chaplain, Security Company, LAAMS, Officer Lounge, SNCO Lounge, EM Lounge, and various officers and enlisted men of this command.

Regt. (ARVN) Security for permission for the two trucks delivering sand and gravel to pass through their gate; (3) 5th Inf. Regt. (ARVN) Security for new employees and the vacating of three buildings for occupation by 9th MEB; (4) 5th Inf. Regt. (ARVN) Utilities concerning permission for the USMC to obtain water from the 5th Regt's water supply point during the change over period of our water pumps; (5) 9th MEB concerning the employment of Vietnamese employees in the 9th MEB area; (6) 41st Tactical Wing (VNAF) Security concerning private laundry service for the 9th MEB Units.

## GENERAL COMMENTS

1. General Situation.

The time period of 15 January 1965 to 31 March 1965 has shown a varying but decreasing number of Viet Cong initiated incidents. The highest VC initiated incident week was the last week in February 1965 when 161 such incidents were conducted. This is considerably less than the VC high incident week of the previous reporting period - the third week of December 1964 when over 200 such incidents were experienced in the I Corps area.

Although the VC initiated incident rate has decreased, the strength of VC "Hard Core" units continues to build up.

The kill ratio for the reporting period is approximately 3 to 1 as compared to 7 to 1 in the first half of the month of January 1965.

Throughout this period there have been repeated rumors of large units (up to division in size) moving down the Ho Chi Minh Trail into the I Corps area but none of this has been confirmed. The most significant increase by the VC has been in their local force units and guerrilla forces.

## 2. Tactics / Techniques.

The "Strike" concept of tactical deployment of helicopterborne troops has proved to be very efficient and effective. The system consists of a preliminary briefing in which the overall tactical scheme of maneuver, probable landing zones and alternate plans are considered. If possible, the strike commander conducts a seemingly routine flight at a distance and altitude which will provide him with visual and/or photographic coverage of the landing zones. Utilizing this information gained, a detailed briefing is conducted for key personnel of all services involved in the operation, thereby producing a final plan which is jointly acceptable. The Marine Strike Commander then has a pre-flight briefing of his pilots and loadmasters and the action is conducted. This series of planning commences the day before the strike is conducted. Should an instant reaction requirement exist, phases such as phone coverage, general briefing, etc. may be eliminated by the representatives of the service affected.
