PART TWO

Narrative Summary

1. This report covers the period 1-30 September 1968. During this period MABS-16 continued to support the facilities at Marble Mountain Air Facility and An Hoa Airfield.

Significant Events

- 1. Personnel. Three (3) Marine Officers, Sixty-two (62) Marine Enlisted, and Two (2) Navy Officers were joined. Four (4) Marine Officers, Thirty-nine (39) Marine Enlisted, One (1) Navy Officer and Four (4) Navy Enlisted were dropped. There was One (1) promotion to SSgt, Eighteen (18) to Cpl, Four (4) to LCpl and Four (4) to PFC.
- 2. Administration. On 11 September 1968, Lieutenant Colonel L. W. PARISH relieved Lieutenant Colonel R. F. RICK, as Squadron Commanding Officer. On 20 September 1968, Major W. H. SHAUER was appointed as Squadron Executive Officer. On 4 September 1968, First Lieutenant P. K. ROMMEY was appointed as Executive Officer of Zulu Company. On 27 September 1968, First Lieutenant R. E. KELLY relieved First Lieutenant R. T. TAUNT as Squadron Supply Officer.
- 3. Awards. During the month of September 1968, there was eight (8) Good Conduct Medals, Two (2) Air Medals awarded to MABS-16 personnel.
- 4. Casualties. The following casualties were reported during the month of September 1968.
- HM2 Charles E. HAWKINS B603710, USN, WIA, 18 September 1968, Hoi Ahn
- 5. <u>Civic Action</u>. The MAG-16 Med-Cap Team went to the following places on a weekly basis: Stella Maris Orphanage/Dispensary, Protestant Orphanage, Boys Town Orphanage and the Hoa Long Village Dispensary. A total of 1,966 patients were rendered medical assistance. A Vietnamese nurse working aboard MAG-16 assists in the Med-Caps. Every Thursday Vietnamese employees of MAG-16 receive medical check-ups.
- 6. Ground Defense. During the month of September 1968, at Marble Mountain Air Facility, additional bunkers and defense positions were constantly worked on and improved.
- 7. Supply/Materiel. The following occurred in the Materiel Section during the month of September 1968:
- a. A letter was submitted to Group Supply (Navy Section) which contained the projected requirements of all office machines for FY-69 & 70 for MABS-16.
- b. An emergency grant of \$25,000.00 for BFN-11 (Navy) was required for operations through the remainder of 1st quarter FY-69.
- c. The Group Billeting Officer and his NCOIC now have office space in the Materiel Section.

- d. The Materiel Section no longer has transportation due to the fact that this section's truck was salvaged because of over-age. No replacement is forseeable in the near future.
- 8. Motor Transport. During the Month of September 1968, the Motor Transport Section traveled 62,702 miles, transported 36,921 passengers, hauled 152,200 gallons of water, hauled 20,280 gallons of MOGAS, hauled 16,201 Gallons of Diesel Fuel, hauled 1,265 Gallons of A/C oil and hauled 1,921 short tons of cargo.
- 9. TAFDS. During the month of September 1968, this section issued the following amount of fuel at the locations indicated:

- On 23 September 1968, An Hoa increased its capacity of JP-4 Fuel from 40,000 Gallons to 50,000 Gallons, and decreased its capacity of 115/145 Fuel from 20,000 Gallons to 10,000 Gallons.
- 10. Base Operations. During the month of September 1968, the following has been accomplished:
- a. MMAF revised Operations Manual has been submitted to the Group Commander for comments and approval.
- b. A flight check has been made on MMAF GCA unit with satisfactory results. Paperwork on final approval is expected soon.
- c. 14 VRC-77 radios have been received and are in the process of being installed in the crash vehicles and the control tower. Arrangements have been made with H&MS-16 to install and maintain the radios.
 - d. The runway crack has been repaired by Public Works.
- e. Arrangements have been made with Motor Transport to assign a mebhanic on a full time basis to An Hoa Airfield to aid in maintaining the crash vehicles.

2. Other projects pending completion:

- a. The crash barn is almost completed but an access road from the barn to the runway is needed before crash vehicles can be assigned their new location. Work on the road has not commenced.
- b. An attempt is being made to acquire a southeast Asia hut to be positioned at the GCA site to serve as living quarters and training room for GCA personnel.

3. Damages:

a. At 0200 on 22 September 1968 MMAF received approximately 25-30 mortar rounds. The asphalt and PSP of both east and west parking aprons received minor damage and has been repaired by the Seabees. Several helicopters received minor shrapnel damage. One hangar took two direct hits.

- 3. MMAF 1Sep68 2110 Tower informed Crash Crew of a fire in head, rear of Base Operations Building. Crash Crew responded. The fire was immediately extinguished. Minor damage to head. 20 Gallons of water used.
- 4. MMAF 2Sep68 0040 Tower operator informed Crash Crew of a fire in head, rear of Base Operations Building. Crash Crew responded, fire was extinguished immediately. Major damage to head. A container with a small amount of gasoline was found nearby. It is believed gasoline was used by an unknown person or persons to start the fire.
- 5. An Hoa 3Sep68 0420 Mess personnel informed Crash Crew of a fire in a head near the mess hall. Crash Crew responded, the fire was extinguished immediately. Major damage to head. 200 gallons of water and 15 gallons of foam used. Fire was started by unknown causes.
- 6. MMAF 18Sep68 2201 Crash Crew informed of a fire in storage tent South East corner of mess hall. Crash Crew responded, and upon arrival at the scene found fire in a bundle of sandbags. Fire was immediately extinguished. Damage one (1) bundle of sandbags. 50 gallons of water used.
- 7. An Hoa 24Sep68 2100 persons in S-4, 5th Marines informed Crash Crew of a fire in Division dump. Crash Crew responded, fire was immediately extinguished. No damage to government property. 600 gallons of water and 25 Gallons of Foam were used.
- 8. An Hoa 28 Sep68 2100 Persons in S-4, 5th Marines informed Crash Crew of a fire in Division dump. Crash Crew responded, and the fire was immediately extinguished. No damage to government property. 400 gallons of water and 25 gallons of foam used.

11. Food Services

- a. There were approximately 249,695 meals fed at the Marble Mountain Air Facility Messhalls during the month of September. Bread for the month of September was issued from the Read Beach Bakery. The messhall in addition used 9,000 pounds of flour for the preparation of breakfast pastry, pie, cake, etc. There was no damage to the Mess equipment due to hostile fire. Minor damage was done by the typhoon, but the repairs were taken care of immediately.
- b. Public Works has completed the re-wiring of the Enlisted Messhall. A second 36 gallon hot water heater was installed and tied into the system for additional hot water and a back up for repair and maintenance. Messhall exterior was prepared for re-painting. New electric coppers were installed in the galley. New toasters were installed in the Enlisted and Staff Mess. A weather shelter was constructed over the new MQ-51 Reefer. Five additional drains were installed in the Galley and Spudlocker. Hot water lines were installed in the Staff and Officers Mess. New drains were installed under all steam lines. Electric Coppers were repaired and put into use in the Officers Mess. Two tents were put into use for proper storage of mess equipment and supplies.
- c. Technical training and on the job training were conducted for all mess personnel and properly recorded. The Messhall has been sprayed weekly for flies and roaches. Insecticide bombs have been ordered through supply so that the messhall can be sprayed daily for flies. The clubs were furnished night snacks during the month. Two much needed milk machines, in need of repair, were transferred to MAG-16. Necessary repairs were made and put into use. Two grills were also transferred, but it is doubtful they can be repaired. Additional sanitation lectures were conducted for all mess personnel by the MAG-16 medical section. The mess is still short of civilian personnel. The mess has also been unable to acquire the proper type of soap needed for the washing of dishes and silverware, pots and pans. The three steam lines are still out of order making it almost impossible to keep and serve hot food during the extended meal hour.

12. Base Services/Utilities

- a. During the month of September 1968 the Utility Section joined sixteen (16) personnel. There were three (3) Utility Section personnel rotated back to CONUS. One man returned from thirty (30) days leave. One (1) man returned from emergency leave. Four (4) Utility personnel went on thirty (30) days leave. There were no new cases of V. D. in the section. During the month of September, six (6) Utility personnel were granted out-of-country R&R. During the month of September, One (1) Lance Corporal was promoted to Corporal. One (1) Corporal was demoted to Lance Corporal and one (1) Lance Corporal demoted to Private First Class. One person was transferred to the Squadron Office. There were seven Utility personnel participating in the 10% Savings Program and 84% of the Section had U. S. Savings Bonds. On 30 September 1968 the Utilities Section had two Officers and ninety-three (93) Enlisted Personnel.
- b. <u>Water Point</u>. During the month of September the Water Point personnel processed a total of 3,958,000 gallons of potable water. Of this total 34,600 gallons were issued to other units outside of MAG-16. Well #2 is not in operations. To date there are two wells in operation. All equipment at the Water Point was exercised during the month.
- c. <u>Paint Shop</u>. During the month of September the Paint Shop personnel completed six (6) work orders, in addition many smaller jobs were completed. The work of the Paint Shop consists almost entirely of sign painting.
- d. Electric Shop. The Electric Shop completed seventy-six (76) work requests and trouble calls during the month of September. These consisted primarily of repairing shorts, rewiring hooches, installing switches and receptacles, repairing flourescent lighting, and restringing downed wires following the Typhoon.
- e. <u>Plumbing Shop</u>. The Plumbing Shop completed twenty-one (21) work orders during the month of September. These included installing hot water heaters in the Staff and Enlisted showers and adding to the existing shower facilities.
- f. Base Laundry. The Base Laundry processed 4,349 bundles of clothing for a total of 64,235 pounds. The individual bundle service remains available to all ranks.
- g. Refrigeration Shop. The refrigeration and Air Conditioner repair shop made twenty-nine (29) trouble calls during the month of September. The majority of these calls were to repair faulty Air Conditioners, but water coolers and refrigerators were also repaired.
- h. Carpenter Shop. During September fourty-one (41) work orders were completed by the Carpenter Shop. The majority of the work orders were embarcation boxes and crates. A small amount of minor construction was completed which included the tower at the Water Point. Numerous hooches were repaired, doors replaced or repaired, and other small jobs were also completed.

13. Heavy Equipment.

- a. Administration. During the month of September there were two (2) men rotated back to CONUS for Special Leave. One (1) man returned from Special Leave from Spain. There were two (2) men who returned from R&R. Four (4) men returned from TAD for details, one (1) man on guard, one (1) man on mess duty and there were three (3) men on Mobile Alert. There were no reported cases of V.D. nor were there any men placed in confinement. One (1) man was TAD to the USS Sanctuary for a period of five (5) days. One (1) generator was sent to 1st FSR for rebuild. Currently there is one (1) Officer and Twenty-two (22) Enlisted men assigned to our section.
- b. Maintenance. For the Month of September 1968, the maintenance section opened fourteen (14) work orders. Out of this number, twelve (12) were completed. We now have a total of eight (8) work orders open.
- c. Operations. The Operations Section completed 671 equipment requests. Of this total, the following breakdown is submitted:

AN HOA AIRFIELD COMMAND CHRONOLOGY FOR NONTH OF SEPTEMBER 1968

- 1. This report covers the period 1-30 September 1968. During this period the An Hoa Airfield Facilities, under the command of the Resident Officer-in-Charge supported all transient aircraft with crash, fire and rescue services, weather information, control tower facilities, air freight assistance and refueling services of aviation gas 115/145 and JP-4 fuel.
- 2. During the month of August the An Hoa Firebase was probed by enemy small arms fire and mortars four different times. Living areas and the a surrounding areas of the airfield were kept in good police daily by all hands and all equipment including generator was kept clean of dust and mud and preventive maintenance was performed weekly. The runway is patrolled daily to inspect for broken and torn places in the runwaymatting and to pick up metal pieces broken and laying on the runway. The runway matting is constantly being welded back together in order to maintain fixed wing capability.
- 3. High lights for specific days of the reporting period are as follows: On 1 Sep 68, received approximately 3 rounds of 82M. 2 Sep 68, uneventful. 3 Sep 68, fire behind messhall (type of fire; outside head building completely destroyed).
