Narrative Summary

1. This report covers the period 1-31 March 1969. During this period MABS-16 continued to support the facilities at Marble Mountain Air Facility and An Hoa Airfield.

Significant Events

- 1. Personnel. Three (3) Marine Officers, Eighty-two (82) Marine Enlisted, One Navy Officer and Three (3) Navy Enlisted were joined. One (1) Marine Officer, Seventy-one (71) Marine Enlisted, One (1) Navy Officer and Three (3) Navy Enlisted were dropped. There were the following promotions; Eighteen (18) to Sergeant, Four (4) to Corporal, Seven (7) to Lance Corporal and One (1) to Private First Class.
- 2. Administration. On 1 March Captain M. J. GILDEA relieved First Lieutenant G. P. TETU as Squadron Administrative Officer. On 10 March First Lieutenant R. L. DAVIS and First Lieutenant J. E. JOURNEY were appointed as Assistant Base Operations Officers. On 17 March Major J. "M" DAVIS was appointed as Base Operations Officer. On 10 March Captain W. L. TREECE was appointed to permanent Chief Warrant Officer 2. On 10 March Captain T. L. JONES was appointed a permanent First Lieutenant. On 28 March Captain T. C. BROCK was appointed a permanent First Lieutenant.
- 3. Awards. During the month of March 1969, there was One (1) Purple Heart and Thirty (30) Air Medals awarded to MABS-16 personnel.
- 4. Casualties. The following casualties were reported during the month of March 1969.
- CPL C. L. FROST 228 84 23/1345, USMC, WIA, 8 March 1969, An Hoa LCPL C. MELENDEZ 234 15 80/6372, USMC, WIA, MMAF, 20 March 1969 CPL R. M. FULGIUM 225 92 48/2841, USMC, 30 March 1969, An Hoa, Fractured Right Leg while passenger on mule that over turned.
- 5. <u>Civic Action</u>. The MAG-16 Med-Cap team went to the following places on a weekly basis: Hoa Long Dispensary and the Catholic Orphanage. A total of 2126 patients were rendered medical assistance and 83 villagers and orphans were rendered dental treatment. Five villagers were MEDEVACED to different civilian and military hospitals. To help ward off any saboteurs during MED-CAPS and to keep out trespassers, MAG-16 constructed a barb-wire and stake barrier around the village dispensary. With the new fence around the dispensary, it is easy for Civic Action personnel to provide adequate security during MEDCAPS. For this reason, Zulu Company no longer accompanies this command's MEDCAPS.

- 6. Ground Defense. Contact with the VC/NVA during the month of March 1969 was One (1) rocket/mortar attack on 6 March, One (1) mortar attack on 20 March, One (1) rocket attack 21 March and One (1) rocket attack on 27 March. All platoons continue to rebuild/refurbish existing bunkers with particular emphasis on relocation of the majority of the western perimeter bunkers. Approximately 800 meters of new tactical wire was laid on the western and southwestern perimeter.
- a. Morale/Welfare. Since the February "Shooting Match" was so well received and participated in by the troops, it has been decided to hold all future FAM Fire details in the manner of a shooting match. Winners of future matches will receive awards as incentive from the company recreation committee funds. A volley ball tournament will be held (intramural) within the company starting in April. Procurement of bunks, mattresses and matress covers during the month has contributed greatly to the overall welfare and morale of the troops. In general, troop morale has appeared to stabalize at a high level.
- b. <u>Intelligence/Counter Intelligence</u>. The MAG-16 Intelligence Officer has been contacted to give a weekly intelligence briefing.
 - c. Logistics. Concertina wire was delivered early this month.
- d. Supply. Received materials and began to rebuild the Zulu Company shower.
- e: Communication/Electronics. To ensure effective communications under all conditions and to provide for rapid response in the event of communications loss through enemy action or accidental damage, the following items of Comm equipment was requested.
 - (1) 5 SB-22 Switchboards (1 for Company CP, 1 each for the 4 platoon CP's).
 - (2) 35 EE-8 for the tower and bunker link-up around the MMAF perimeter.
 - (3) 5 25 pair terminal strips.
 - (4) 4 splicing kits.
 - (5) 3 reels of slash wire (a one and one half mile per reel).
 - (6) 3 Donut Reels Slash wire (a one and one half mile per reel).
 - (7) 5 backup operator packs for SB-22.

- 10. Base Operations. During the month of March 1969 the following events took place:
- a. On 7, 20, and 27 March the airfield came under mortar and rocket attacks. Negligible damage was done to the airstrip and parking aprons. No equipment nor buildings under the cognizance of Base Operations received any damage.
- b. Fifteen (15) new parking revetments with taxiways were completed on the west side of the field also a taxiway joining the apron to the runway.

- c. Work on the crosswind runway shoulders and taxiways have progressed steadily through the month of March.
- d. The antenna platform for the control tower has been completed. The radio room within Base Operations has been insulated and air conditioners installed in preparation for the radio equipment for the control tower.
- e. The GCA unit was flight checked and both FPN-36's and controllers were given an excellent rating.

- b. Lt BARE USN, METLO engineer for Fleet Weather Facility, Sangley Point calibrated the Ameroid Barometers at Marble Mountain Air Facility and An Hoa. Due to local conditions at An Hoa the Ameriod Barometer there has a constant correction of One (1) millibar.

11. Food Services


- a. There were approximately 241,800 meals fed at Marble Mountain Air Facility Messhalls, (which does not) include all normal meals and party rations. Bread and Cake Donuts were issued from the Red Beach Bakery. The Messhall, in addition, used 7,000 pounds of flour for preparation of breakfast pastries, cakes, french bread, etc. Fresh and Dry Stores were procured from NSA. Marble Mountain Messhall lost approximately 6,300 lbs. of meat during the month of March. This happened because the refer unit automatic defrost and freezing control went bad. Refer Mechanics from NSA China Beach were called in. Each time they came out they would start the unit to freezing. but when it started to automatically defrost, the unit would blow the hot air back into the freezer which would thaw out all the frozen meat inside. After the unit had been repaired and back in full operation, Corpsmen from Marble Mountain Dispensary were in to inspect all the meat that was in the refer at the time the unit went bad. Upon the Corpsmen's recommendation all of the meat and fish that had thawed out was disposed of. None of this meat which was inspected by the Corpsment was served in the Messhall before or after their inspection. There was a Corpsman present at the time the meat left the Messhall until it was disposed of.
- b. The drainage system for the Messhall has been completed. The front door in front of the Enlisted Mess has been relocated to help cut down on the fly problem. The back dock and scullery at both messes will be screened in as soon as utilities gets the necessary material to do the job. A three (3)

inch concrete dock is being layed in the Galley at the Enlisted Mess. A new back door for the Officer's Mess has been built and installed.

c. On the job training and Technical Training was conducted for all Mess personnel and properly recorded. The Messhall is being sprayed twice weekly for flies. The Mess System is hiring civilian personnel to replace Marine Messmen. An addition of thirty (30) civilian personnel were hired for the Messhall. There were no snacks furnished for the Enlisted personnel, clubs for the month of March. A Sewer System is needed in the back of the Enlisted Mess so the water will not flow onto the road. The water that is used to wash down the back dock of the Messhall has no place to flow but on the road in back of the Messhall. This has created an unsanitary condition, and an unfavorable odor. It also creates a breeding place for flies.

12. Base Services/Utilities

- a. <u>Water Point</u>. During the month of March the Water Point personnel distributed a total of 4,526,650 gallons of potable water. Of this 318,295 gallons were distributed to other units outside of MAG-16. To this date there are two (2) well pumps in operation.
- b. Paint Shop. During the month of March the paint shop completed seven (7) work orders. In addition to this many other smaller jobs were completed. The Paint Shop consists mainly of sign painting.
- c. Electric Shop. During the month of March the Electric Shop completed eighty-three (83) work orders. These included, but were not confined to, mostly rewiring howches, installing switches and receptacles and repairing and installing florescent lights, and wiring the M.T. "M" building. The Electric Shop took over from Heavy Equipment, all generators at MAG-16. The Electric Shop is also supplying two (2) generator men at An Hoa in support of the MAG-16 detachment there.
- d. Plumbing Shop. The plumbing shop completed four (4) work orders during the month of March. They repaired the New Expando Trailer, the drain line at the Officers Club, the hot water heaters at the Officers Club, hot water heaters at the BOQ, Staff and Enlisted showers, repaired the drain line at the E-5 Club, and the 5" drain line at the Enlisted showers.
- e. Refrigeration Shop. The refrigeration and air conditioner repair shop made 21 trouble calls during the month of March. The majority of these were faulty units, but water coolers and refrigeration units were also repaired. Weekly PM's were pulled on all units at the messhalls.
- f. Carpenter Shop. During the month of March the Carpenter Shop completed twenty (20) work orders. The majority of these were embarkation boxes and crates. A new addition to the Carpenter Shop is near completion. In addition hooches were constructed at Hill 55 for our MAG-16 detachment there. In addition many other smaller jobs were done. The Carpenter Shop is now in the process of tearing down the old Transit Facility in Danang and moving several hooches on base.



13. Heavy Equipment.

- a. Maintenance. For the month of March 1969, the Maintenance Section opened fourteen (14) work orders, out of this number eleven(11) were completed and five (5) were brought forward from January 1969 and seven (7) were brought forward from February 1969.

- 14. Ordnance. During the month of March 1969 the MABS-16 Ordnance Section issued a total of 10,173 White Phosphorus and High Explosive 2.75" rockets, 465,585 rounds of assorted small arms ammunition and 1,564 pounds of assorted smoke and chemical agents to the squadrons at MAG-16. Also 1,296 2.75" rockets and 80,000 rounds of assorted small arms ammunition was issued to An Hoa, and 1,108 2.75" rockets and 64,600 rounds of assorted small arms ammunition was issued to Hill 55.

a. As indicated on the Army Air Force Weekly Exchange Bulletin during the accounting period llFeb69-10Mar69 the MAG16 Exchange total volume of sales was third highest out of 8 outlets in the 1st Marine Air Wing. Two of the outlets are very large stores with direct access to Army-Air Force exchange warehouses.

An Hoa Airfield Command Chronology Month of March 1969

- 1. During the reporting period the An Hoa Airfield facilities, supported all transient aircraft with Crash, Fire and Rescue services, Weather information, communications from An Hoa to the Marine Aircraft Group 16 Command Post, refueling services of 115/145 Av Gas, and JP-4 type fuel and Air Traffic Control services provided by MATCU-67 Det "A".
- 2. During the reporting period the An Hoa Combat Base was under enemy attack using 82MM mortars, 60MM mortars, 120MM rockets RPG's and small arms fire fifteen times. One dud struck the runway approximately 500ft. from the approach end of 06, EOD was notified and the dud removed, one other dud struck the TAU 6X6 fire truck which was removed by EOD. One 122MM rocket struck the SW corner of the main parking apron causing a four foot crater which has been repaired by the Seabees. A 10X24 ft. standby bunker for the MAG-16 Med-Evac crew has been completed except for sandbagging.
- 3. A resume of each airfield activity as follows:
- a. Weather. The weather section consisting of three Marines made climatology observations on the hour each hour of the day when not under enemy fire. The weather section provided existing weather to the control tower, An Hoa DASC (until 7Mar69), Danang RAPCON, and MAG-16 weather office.
- b. Communications. The communications consisting of three Marines until 25Mar69 then reduced to two, provided communications between the An Hoa Combat Base and Marine Aircraft Group 16 Command Post utilizing a PRC-47 radio. Contact is made each hour to pass weather information and general message traffic.
- c. <u>Crash Crew</u>. Consisting of twelve men performed their function of providing crash, fire and rescue and structual fire protection for the airfield, parking area, TAFDS area, and the 5th Marine Regiment. The Crash Crew maintains three crews of three men each, a section leader and fire inspector. The night crew is on duty in a standby status.

The Crash Crew responded to the following:

Mar 3 - Responded to CH-46 with wounded and battle damage. No agent used. HMM-165 MODEX - 3 BUNO # 156433.

Responded to fire in Dump with 530/B tanker fire was not extinguished but contained.

- Mar 6 UH-IE declared emergency, no hydraulic pressure, all crews standing by.
 No agent used. VMO-2 MODEX 13 BUNO # 152420
- Mar 7 One crew responded to grounded Air Force C-130 that was hit by incoming mortar during enemy attack. Fire extinguished with 700 gal water, 30 gal foam, and two 30 lb. PKP bottles.

- Mar 9 One Crew responded to trash fire in 1/5 living area. Fire extinguished with 200 gal. of water.
- Mar 10 UH-34 declared emergency with control trouble, all crews standing by. No agent used.

The UH-34 hit a UH-1E while taxing, crash crew responded, no fire, minor damage to each aircraft. HMM-362 MODEX-10 BUNO 150573 VMO-2 MODEX-4 BUNO 153752

Two crews responded to hootch (5th Marines, S-5) that was hit by enemy mortars, fire was extinguished with 800 gal. of water.

- Mar 15 One drew responded to a fire outside the dump area. Fire extinguished with 200 gal. of water.
- Mar 19 One crew responded to grass fire, fire discovered to be outside the perimeter and could not be reached.
- Mar 22 Two crews responded to a fire at the dump. Each truck made two shuttles of water, but was unable to extinguish the fire. Fire was left to burn itself out after 1600 gal. of water was expelled in a futile attempt to extinguish it.
- Mar 24 One crew responded to shower heater fire at the mess hall. (1) 20 lb. PKP bottle and 5 gal. of water was expended.
- Mar 26 One crew responded to a tent fire in the 1st Engineers area, 30 gal. of water was used to extinguish the fire.

One crew standing by on a smouldering (live) 155 round at Alpha Battery, no agent used.

Mar 28 - Two crews responded to the Ammo dump, a round exploded while being removed by EOD. One (1) Marine Killed, three Marines wounded, 300 gal. of water was used to extinguish the fire.

d. TAFDS Section. Consisting of four men maintains the main TAFDS refueling pits 24 hours a day. Both JP-4 and 115/145 Av Gas are available. The refuelers and the defueler have been returned to the MAG-16 area. All aircraft are now being refueled at the main TAFDS area. The BAS unit has been secured due to shortage of personnel. MABS-16 Self Help Program

During the month of March 1969, the Self Help program completed 25 individual projects.

On 3 March, the new basketball court concrete forms were installed in the Special Service area. More grading of the newly sited athletic field was completed to the extent that two thirds of the field has now received some treatment in regards to fill and grading.

A parking lot was constructed for the new Exchange building from salvaged steel matting. There is now enough parking for ten vehicles.

The old crash crew site located between the runway and the helicopter parking apron south of the tower was cleared and the usuable building and materiels salvaged. This project was completed on 7 March.

Two reclaimed SEA huts were moved to the HML-167 squadron area on 8 March to expand the facilities of their Ready Room and their Administration Department. The huts required moderate rehabilitation but were definitely worth recovery.

On 10 March, a request was received to aid the ROKMC on the west side of MMAF. Their new operations area was in need of grading and hard surfacing. A plastic membrane was spread in the area and steel matting was interlocked on top. This provided a most satisfactory interim fix. This project was completed on the evening of 11 March.

A new front gate was constructed on 12 March which consisted of removing the bunker on the north side of the gate, enlarging and repainting the gate house, installing new and larger STOP signs and painting a white line to indicate the positions for vehicular stoppage.

On 13 March, it became apparent that the position of the Motor Transport work and storage sheds on the west side of the field were too close to the newly constructed taxiway in that area. Five buildings, an enormous amount of motor transport repair equipment and one command bunker had to be moved further west into the motor transport area. This was accomplished on 19 March.

On 20 March, an additional Expando trailer became available and was installed in the officer living area to house additional Lieutenant Colonels.

On 21 March, the rehabilitation of the sheds and buildings in the heavy equipment area was begun. This will allow the personnel to be shifted closer to their work and thus allow more readiness to emergency situations by having the operators sleeping in that position.

On 24 March, the Self Help program moved to the HML-167 enlisted living area to improve the serious erosion in that area that has occurred. A drainage ditch was constructed and the immediate living area was reinforced by the

On 26 March, a steel matting runway was completed in the HRMS-16 Avionics area that would allow for the movement of avionic equipment vans to the proper storage area behind the Avionics area proper. Exterior lights were also installed in the HRMS-16 Materiel open-air storage area.

An 8 man bunker was constructed for the use of the occupants of the Expando trailers on 27 March.

implanting of 55 gallon drums to form a solid wall.

On 28 March, MAG-16 requested and received permission to move 10 SEA huts from the abondoned III MAF Transient Facility at DANANG Air Base to MMAF. The remainder of the month was spent preparing these buildings for the move, plus recovering all salvagable material and lumber. The huts were moved each evening after 2000 to preclude traffic tie-up on the main arterial road from Danang to Marble Mountain.
