PART TWO

Narrative Summary

1. This report covers the period 1-31 October 1969. During this period MABS-16 continued to support the facilities at Marble Mountain Air Facility, An Hoa Air Field, 12 Baldy, and Hill 55.

Significant Events

- 1. Personnel. Two (2) Marine Officers, Forty-one (41) Marine Enlisted were joined. Three (3) Marine Officers and Twenty-three (23) Marine Enlisted were dropped. There were the following promotions; Six (6) to Lance Corporal.
- 2. Administration. On 10 October 1969 Lieutenant Colonel John W. COFFMAN relieved Lieutenant Colonel Joseph R. DONALDSON as Commanding Officer.
- 3. Awards. During the month of October 1969, there were two (2) Navy Achievement Medals, three (3) Single Mission Air Medals and twenty (20) Air Medals awarded to MABS-16 personnel.
- 4. <u>Casualties</u>. The following casualties were reported during the month of October 1969.

5. Civic Action

- a. At the present time MAG-16 is not providing any MEDCAPS; however, when MCB #4 departs for CONUS, we will assume their Civic Action area of responsibility. The Civic Action Section has been providing MCB #4 with transportation and security during their MEDCAPS to the hamlets of Binh Ky and Da Me#2.
- b. A total of twenty (20) General WALT Scholarships were presented to the students of Hoa Long Village. One hundred reams of writing tablets were delivered to the various schools in the DaNang area.
- c. A pig farm has been established in the hamlet of Da Me #2. 5th Comm Bn is providing the feed and instructions to the villagers on the proper breeding and raising methods and procedures. Twenty (20) bags of cement were donated to the Buddhist Monks on Marble Mountain to assist in the repairs of some of their war-damaged temples and shrines. A marked improvement was viewed of the reconstruction projects and it is gratifying to see the people utilizing the donated material. MAG-16 Utilities Section assisted the Civic Action Office by constructing two shower stalls in Binh Ky Hamlet. The CAP unit assigned in that area will be using these showers in hopes that through example the village children will pick up some sanitary habits. In conjunction with RD personnel in

Binh Ky, the Civic Action Team of MAG-16 is attempting to repair the school facilities so that school can be reopened. We are performing this task on strictly a scrounging basis and so far have collected enough lumber to build desks for the school. Utilizing two pumps from Utilities and TABDS, we were able to pump a total of 840,000 gallons of water out of thirty homes in Nui Kim Son. The primary school in Nui Kim Son had a clean-up day of the village and this was conducted by the principal and his students. The Civic Action Team provided the necessary rakes, sandbags, and transportation to haul the trash away. We are attempting to start a DaNang tour; however, it has not been very successful due to the lack of transportation.

- d. Binh Ky We have encountered some personality conflicts with the hamlet chief, who is cooperative only when he benefits personally. RD suspects him of being a VC; however, has no proof. We commenced working with the RD personnel rather than with the chief and noticed a marked improvement in our rapport with the people. A gunner's mate from Mobile Construction Battalion #4 was killed in an ambush in Binh Ky.
- e. Nui Kim Son A 15 pound, (command type) block of C-4 was discovered under the porch of a house where the Civic Action personnel usually congregate with the villagers. A sweep was conducted by members of the CAP Team, National Police and 3rd Amtracks on 23 Oct 1969. Twelve VC were netted and turned over to the National Police.
- 6. Ground Defense. Contact with the VC/NVA during the month of October was one (1) mortar attack on 21 October 1969.
- 7. Supply/Materiel. The following occurred in the Materiel Section during the month of October 1969.
 - a. Provided the Mess Hall with (30) dz Knives, Forks, and Spoons.
 - b. Issued Utilities Section one (1) Refrigerator MQ-51E.
- c. Issued Base Ops Section (30) Cots, Mess Kits, Poles Folding Insect Bar, Matress Pneumatic and Insect Bars Nylon Netting, Required for LZ Baldy.

Navy Side

- a. Surveyed 1 Cone Marker, Runway, 1 Forklift ART-30.
- b. Dropped 1 Truck Refueler, from Squadron accounts.
- c. Issued Crash Crew Section 2 General Purpose Tents.
- d. Received 10 pairs of Firemans Boots for the Crash Crew Section.
- e. Received 700 sheets of $\frac{1}{2}$ inch Plywood, 700 sheets of $\frac{1}{4}$ inch Plywood, 400 sheets of $\frac{3}{4}$ inch Plywood.

- b. Wing came out with a new UP&TT and all Sections are revising their UCM's to comply with change.
- c. Assisted TAFDS, Chaplin, Civil Affairs, Ordnance, Food Services, Zulu Co, and Base Ops in revising their UCM's.
 - d. In the process of a reconcilation of MEDS cards with the revised UCM's.

- b. Issued (62) Weapons and recovered (71) Weapons.
- c. Reconciled IMR cards with subsidiary cards.

Billeting

- a. Approximately (20) Officer's checked in and accommadations were made by procurement of required racks and mattresses, all S.E.A. huts were brought up to a (5) man manning level.
- b. Issued a memorandum to all Squadrons requesting a monthly report of Billeting Assignments. This is to be utilized with assignments held by this office.

Weather

- a. During the month of October 1969, the Weather Section continued to support all Marine Aircraft Group 16 Operations in the Marble Mountain and An Hoa areas.
- b. The METLO and NAESU engineer from Sangley Point, R.P. visited the Weather Section to repair the AN/UXH-2B Facsimile Recorder. Operation successful.
- c. The 15'x50' cement pad to support the incoming weather vans from MAG-39 was completed.
- d. The Meteorological requirements for support of operations at LZ Baldy were formulated. Anticipate observational program commencing about 1 Dec 1969.
- e. Morning weather briefs for the Group Commanding Officer commenced during the month.
- f. Rainfall for the month of October broke the previous record of 33.51" set in October of 1968. Total rainfall for October 1969 was 36.60". The normal average is 22.41"

11. Food Service

- a. There were approximately 214,790 meals fed at the Marble Mountain Air Facility Messhall during the month of October 1969, which includes all normal meals and party rations. Bread and donuts for the month of October were issued from the Red Beach Bakery. The messhall is required to pick up the donuts three (3) times weekly and bread each day. Marble Mountain Messhall used approximately 3,700 pounds of flour for the preparation of breakfast pastries and pies. Fresh and dry stores were procured from NSA.
- b. Seven (7) gas ranges have been installed in the Enlisted Mess Galley and are now in the process of being connected to the gas tank. A concrete deck for the G.I. House at the officer's mess has been completed. The flower garden on the south side of the Messhall has been moved to make way for extension of the Staff & Sergeant's messes. New doors for the front of the Enlisted Mess have been put in.
- c. On the job training and technical training was conducted for all mess personnel and properly recorded. Night snacks were furnished for all Enlisted Mess. The Enlisted and Officer's mess are both badly in need of roof repairs. The roof on the storeroom needs repair, dry stores get wet during the rainy season.

12. Base Services/Utilities

- a. Water Point. During the month of October 1969, the Utilities Water Point distributed a total of 3,639,900 gallons of potable water. Of this a total of 68,550 gallons were distributed to other units outside of MAG-16.
- b. Paint Shop. During the month of October 1969, the Utilities Paint Shop completed a total of 31 work orders. Signs were painted for H&MS Armory, MATCU 68, Enlisted Mens Club and the Chaplain.
- c. Electric Shop. During the month of October 1969, the Utilities Electric Shop completed a total of 75 work orders. Secondary lines were connected at Comm. Center and Motor Transport. Poles and the interior wiring was completed for Zulu 3 Command Bunker, downed lines at Sick Bay were rewired. Lines to the ME-10 located at Comm. Center and the compressors at Dental were ran. Minor electrical repairs were made throughout the living area. The Utilities Section, Electric Shop also has a man at An Hoa as a generator operator to supply emergency power for the flight line and a man is also supplied for off duty hours to answer any electrical problems that arise. The Electric Shop completed the above with a total of twelve men.
- d. Plumbing Shop. During the month of October 1969, the Utilities Plumbing Shop completed a total of 23 work orders. The Plumbing Shop completed the drain system for the 600 block EM showers. Many smaller jobs were also completed, such as repairs to the enlisted showers, repairing leaks and unstopping drains at the mess halls.

- e. Refrigeration Shop. During the month of October 1969, the Refgrigeration Shop completed a total of 31 work orders. Most of these were repairs on the air conditioners in the officer living area. Water coolers and refrigerators were also repaired. Many units were sent to China Beach Refrigeration Shop for repairs.
- f. <u>Carpenter Shop</u>. During the month of October 1969 the Utilities Carpenter Shop completed a total of 78 work orders. The MAG-16 CO's office, and the MABS-16 CO's trailer were redecorated. Embarkation boxes were built for H&MS 16, VMO-2, MATCU 68, Motor Transport and HML-167. Ten doors were installed at the E Club, windows were cut in the S/NCO Mess, small shed for compressors at Dental was built, picture frames were built for HMH 463. A bridge was constructed at the Enlisted Mens Club, construction of a mailbox and a hot locker for VMO-2, 20 fire barrel covers for Crash Crew and a bin for 3 M Maintenance were also completed. Numerous small jobs were completed in the MAG-16 area. A total of 125 sheets of plywood and 70 pieces of tin were issued for self help projects. The Carpenter Shop completed the above with a total of twelve men.
- g. Base Laundry. During the month of October 1969 the Base Laundry processed a total of 2938 bundles of clothing. An additional 3,400 pounds of organizational gear was also processed for a total of 47,700 pounds of clothing processed. The individual bundle service remains open to all ranks.

13. Heavy Equipment.

- a. <u>Maintenance</u>. For the month of October 1969, the Maintenance Section opened ten (10) work orders. Out of this number six (6) were completed and four (4) remain open. There are five (5) work orders still open from the month of September 1969.

- 14. Ordnance. AN HOA AIRFIELD COMMAND CHRONOLOGY FOR THE MONTH OF OCTOBER 1969

- 1. During the month of October 1969, the MAG-16 Detachment supported all transient aircraft with Crash Fire and Rescue services, Weather, Refueling, Ordnance, and Air Traffic Control services.
- 2. During the month of October, An Hoa Combat Base received no hostile fire or significant ground attacks.
- 3. The An Hoa area received approximately twenty-five inches of rain during the period 1-10 October. These heavy rains inundated the normal supply routes necessitating aerial resupply. One hundred-ten flights of fixed wing resupply (C-123/C-130) type of aircraft handled between 10 and 24 October 1969. Compliments U.S.A.F.
- 4. A brief description of activities follows:
- a. Weather. The Weather Section provided Meteorlogical services to the 5th Marine Regiment, Air Traffic Control Tower, and Marble Mountain Air Facility.
- b. <u>Communications</u>. The Communications Section continued to function as radio link between MAG-16 Detachment at An Hoa and its parent organization Marine Air Group 16. Communications Traffic consisted of weather information and general administration messages.
- c. <u>Crash Crew</u>. The Crash Crew Section continued to provide Crash, Fire and Rescue Services to the An Hoa Combat Base. The men responded to the below standby's and incidents.
- 90ct69 Crash Crew responded to a CH-46 that shut down on the R/W. The aircraft had battle damage, and was towed to the arming area by Crash Crew.
- 130ct69 Tower called a standby on a UH-lE landing R/W 6 with a fire warning light indication. All Crews responded.
- 140ct69 Crash Crew responded to a call that a vehicle was on fire behind the mess hall, it was a false alarm.
- 170ct69 Hot Spot responded to a KC-130, with a blown tire, Aircraft shutdown on R/W. Aircraft also had damage to both engines and right side of aircraft. Aircraft was towed to the arming area by Crash Crew.
- 23°ct69 Tower called a standby on a °-1 bird dog they thought had crashed off the end of the R/W.24. L/Cpl JOURDAN and crew in M116Al responded. The aircraft had crashed, there was no fire and both pilots were all right.
- 26° ct69 Crash ^Crew responded to a fire behind the base power plant. A latrine was on fire, 130 lb PKP bottle and 100 gallons of water were used to extinguish the fire.
