PART TWO - Narrative Summary

1 February 1968 (U) At approximately 0100 hours Danang Airbase received incoming 122mm rockets. MWSG-17 Fire Department and EOD responded to numerous calls.

2 February 1968 (U) At approximately 0310 Danang Airbase again received incoming 122mm rockets. MWSG-17 Fire Department and EOD assisted in de-arming and fire-fighting of burning aircraft. The fire department has been recommended for an award for their action.

3 February 1968 (U) MWSG-17 EOD supplied two men to assist in a search of the indigenous area that fronts MAG-11 billeting area. No arms or ammo was found.

11 February 1968 (U) 2255 hours MWSG-17 EOD dispatched two men to MAG-16 where 8 VC packs had been found containing live VC grenades and 1500 rounds of assorted ammo.

24 February 1968 (U) At approximately 2305 Danang Airbase received 10 rounds of 122mm rockets South of the field. MWSG-17 assisted in sweeping the runways and taxi-ways.

29 February 1968 (U) After completing a technical evaluation of the MK-24 Flare MWSG-17 EOD issued recommendations which drastically cut the number of dud flares dropped.

Help is still being given to those who are homeless.
