## CONFIDENTIAL

1. During the month of February, this unit continued to provide support for the 1stMAW as well as organic support of MWSC-17.

a. (C) The Motor Transport Section operated the assigned prime movers a total of 47,397 miles. A total of 4,030 tons of general cargo was transported during the month. There was a total of 178 taxi runs carrying 522 passengers for a total of 1,652 miles.

b. (U) There was one reportable motor vehicle accident during the reporting period with one personal injury.

c. (C) The Engineering Equipment Section continued to provide maximum support within its capability. Electric power use was furnished to the Air Terminal area, VMGR-152 area and the TAFDS site. The generators now assigned operated 1,484 hours and the Heavy Equipment assigned operated 1,499 hours.

d. (C) During the month of February, 4th Echelon received 437 components for repair. 381 were repaired and 56 were beyond economical repair. At the end of the month there were 127 open work orders. 90% are awaiting parts, 1% are awaiting parts, 3% are in progress of repair and 4% are awaiting inspection.

e. (C) The TAFDS Section at Tanang Marine Air Freight terminal issued 1,066,119 gallons of JP-4. No AV/GAS was issued.

f. (C) The Squadron was in a C-2 status on personnel during the reporting period. During the month of February, 13 personnel joined the Squadron, 14 were dropped from the Squadron, 2 went on special leave and 15 went on EFR.

## 2. Training

a. There was a total of 437 man hours of GMS training conducted during the reporting period.

a. There were 5 promotions during the reporting period.
