NARRATIVE SUMMARY

It should be noted that during the period covered by this report, this unit has had four different Officers in Charge. Their dates of command are as follows: 1 - 16 January 1973, WO-1 J. O. ORTIZ; 17 January - 17 April 1973, 1stLt S. S. SMITH; 18 April - 4 May 1973, CWO-4 W. J. CIPPERLY; 5 May - 30 June 1973, WO-1 L. G. JORDAN.

During the past six months, this unit has accomplished its mission by performing such maintenance as cognizant with an equipment repair unit. This maintenance shall be annotated in the following paragraphs.

Maintenance was performed on nine M-21 Arresting Gear absorber assemblies. This maintenance entailed unpacking, disassembly, inspection, correction of discrepancies, testing (only hydraulic tests were performed on absorbers), repainting and repacking of each absorber. The serial numbers of the absorbers on which the aforementioned maintenance was performed are as follows: 112, 113, 114, 120, 162, 170, 190, 272 and 273 respectively. Of the nine previously listed absorbers, eight are currently held by this sub unit in storage and in an "RFI" status. Absorber, serial number 273, has been sent to Nam Phong, Thailand.

Maintenance was performed on twelve M-21 Arresting Gear retrieve engines (in most instances the retrieve engines were in a storage status and in this unit's custody). All of the

engines were unpacked, disassembled, inspected, repaired when necessary, a functional test performed and each engine was cleaned and repacked. The painting and remarking of the retrieve engines was performed by corrosion control. The serial numbers of the engines on which the aforementioned maintenance was performed are as follows: 102, 112, 113, 115, 117, 158, 160, 168, 170, 175, 190 and 192. All previously listed engines are presently held by this sub unit in storage and in an "RFI" status with the exception of the following: Retrieve engine, serial number 112. This particular engine was found to be in need of many parts. It was completely rebuilt and upon completion, a functional test was performed. While undergoing this test, the engine became inoperative due to a thrown rod which was caused by a frozen piston. This engine has been shipped to MCAS Iwakuni, Japan (4th echelon); Retrieve engine, serial number 168, was received from N. A. B. Naha in a down status. It was repaired (replaced governor - P/N 5129811) and is currently in use on the runway at Naha; Retrieve engine, serial number 160, was shipped to Nam Phong; Retrieve engine, serial number 201, was received from Nam Phong in a down status and we are awaiting documentation on this engine. Requesting permission to survey this engine is being considered.

A total of thirty-three service changes were incorporated (all work in regards to the incorporation of service changes has ceased as of March 1973. The service changes held by this sub unit cannot be incorporated on components in storage, CE1-3 Catapult service changes). The service changes that have been incorporated are as follows: Service change #57 has been installed on launch dolly, serial number 011; Service change #57 on launch dolly, serial number 012; Service changes #24 and #33 on M-21 Arresting Gear absorber, serial number 112; Service changes #23, #34 and #35 on M-21 Arresting Gear absorber, serial number 114; CE1-3 Catapult 7405 received service changes #25, #40, #63, #65, #84, #112, #124, #132 (Rev. A), #142, #152, #168, #179, #197 and #209; *Catapult 7406 received service changes #38, #63, #70, #124, #142, #168, #188 and #209; Catapult 7407 received service change #25; Catapult 7408 received service changes #78, #119 and #152.

Three C-19 reel carriers have been repaired, repainted and placed in a storage status. Sixteen M-21 Arresting Gear tapes have been wrapped and stored. The following packages were repainted: eight M-9 packages; three M-13 packages; twenty-three M-24 packages. Thirty pallets of AM-2 matting were banded. An inventory of Airfields 7405, *7406, 7407 and 7408 was conducted. Airfields 7403 and 7404 (PACASS) were inventoried and cannibalization commenced (authorization for cannibalization

contained in Admin 1st MAW msg 260407Z Apr 73)

NARRATIVE SUMMARY

During the month of January, the Airfield Crew banded twenty-two pallets of matting, built sheave packages, packaged sheaves and assisted in moving packages to storage.

The Airfield Crew completed painting eight (8) M-9 boxes, three (3) M-13 boxes and twenty-three M-24 boxes. In addition, the Airfield Crew charged the batteries on the air compressor, rebuilt the front doors of the shop and sanded down one of the trucks [6X6 Ser. No. 390522]. The Airfield Crew also participated in the unloading of 701 pallets of matting received from Thailand.

The Maintenance Crew completed maintenance on absorbers 272 and 273. Absorbers were then tested in conjunction with testing of absorber 120 and were subsequently packed.
