NARRATIVE SUMMARY

1. General (U) Marine Air Control Group Eighteen continued to operate air control/anti-aircraft warfare and air support facilities for the First Marine Aircraft Wing.
2. Personnel (C) MACS-4 joined sufficient personnel to offset normal rotation losses and remain in a C-1 category. MASS-2, MASS-3 and the 1st and 2nd LAAM Bns are in a C-2 status; while R&RS-18 is placed in category C-4.
3. Administration (U) Routine administration progressed throughout the month of November.
4. Morale/Welfare (U) Liberty remained secured in Danang and Hoa Phut Village, outside Danang Air Base, throughout the month of November. The beach facilities in the Danang and Chu Lai areas remained open to all hands, and provided the majority of recreation for personnel. In addition, R&R flights were conducted to the following locations during the month:

7. Air Operations (C) During the month of November MASS-2 provided air support control for the Dong Ha and Phu Bai areas while MASS-3 provided air support control for the Chu Lai and Danang areas. 8. Training (U)

a. Troop Indoctrination lectures for newly joined personnel and fire-arms lectures were conducted.

b. General Military Subjects training was conducted by units of this command.

c. Technical training, on the squadron level, took the form of technical instruction and on-the-job training.

9. NBC Defense (U) No significant events occurred during the month of November.

10. Communications/Electronics (U) The communications section of all squadrons of this command, during the month of November, provided the communications to support the air control system for the First Marine Aircraft Wing operations in RVN.

CONFIDENTIAL11. Logistics (U)A. Military Construction

(1) A nominal amount of new military construction was accepted for use by MACG-18 units during the month.

(2) Under the Self-Help program, 8 items were submitted to First Marine Aircraft Wing, for units of this command,

(3) A total of 28 Minor New Construction projects were submitted to 1st MAF to be considered for inclusion in the Wing Minor New Construction Priority listing for 3rd Quarter FY68.

B. Motor Transport

(1) MACG-18 provided transport support for III MAF convoys (Rough Riders) for a total mileage of 8033 and transported 292 S/T of cargo. The cargo/mileage of MACG-18 vehicles was 5034 S/T and a total driven mileage of 99, 515.

(2) H&HS-18 has received some section "M" equipment during the month. The total motor transport assets of H&HS-18 at this time are 4 2½ ton cargo trucks, 1 2½ ton water truck, 3 1½ ton water trailers and 5 cere-lists.

C. Engineer

(1) MACG-18 is taking full advantage of the FMFPac generator rebuild program.

(2) The generator assets of H&HS-18 at this time are 2 PU-587's 2 PU-239's and 1 PU-565.

(3) The Group is in the process of transferring some generator maintenance personnel to enhance the generator repair capability of the Group.

D. Supply and Fiscal.

(1) Documents have been submitted for shortages of T/E equipment. Plans have been drawn for warehousing in hopes that occupation will be in the near future. The supply section is at 50% of manning level in personnel assigned.

(2) Allocation of funds were granted to H&HS-18 for initial outfitting of all equipment. Budget requirements for FY68/69 O&MN=11, O&MG=11 and AIK (Assistance in Kind) were submitted to comptroller 1st MAF.
