PART IINARRATIVE SUMMARY

(U) From 1 January 1975 through 30 June 1975, MAG-36 flew a total of 16,217 hours. Units of the Group were assigned 775 frags, in support of Okinawa based units.

(U) During the entire reporting period, MAG-36 maintained a composite afloat, under the operational control of the 3rd Marine Amphibious Force. HMM-164 maintained the composite squadron until 7 January, when HMM-462 was tasked to assume this duty in support of Operation Eagle Pull.

(U) MAG-36 units supported BLTEX 2-75 during January and February, and commenced detailed planning for MAFLEX 1-75 to be held in the Philippines. The MAFLEX was cancelled in its late planning stage due to operational commitments.

(C) In April, MAG-36 was tasked to provide support for the evacuation of Phenom Penh (Operation Eagle Pull) and the evacuation of South Vietnam (Operation Frequent Wind). As MAG-36 units deployed, it became necessary to establish a Provisional Marine Aircraft Group to exercise control of aviation assets under the newly created 9th Marine Amphibious Brigade. Col F. G. MCLENON, CO MAG-36, assumed duty as CO PROV MAG-39, and assembled a skeleton staff aboard the USS Blue Ridge. On 12 April, Operation Eagle Pull was executed, and on 29 April, Operation Frequent Wind. With the end of these contingencies the PROV MAG was dissolved, and MAG-36 units began to reform at MCAS(H) Futenma.

The end of the reporting period saw all of MAG-36 units at MCAS(H) Futenma, with the exception of HMM-462, which continued to fill the mission of the composite squadron.

## PART II

NARRATIVE SUMMARY

1. On 19 April 1975, the Intelligence Officer and the Assistant Intelligence Officer were transferred on Temporary Additional Duty Orders to PROVMAg-39. The PROVMAg was located aboard the USS Blueridge positioned in the South China Sea. After crossdecking to the Blueridge on 20 April 1975 the Intelligence Officer joined the PROVMAg Staff as the S-2. MSGT FETTERHOFF was assigned as the Intelligence Chief. The PROVMAg S-2 functioned as an integral part of the 9th MAB G-2, and participated in the evacuation of Saigon. Temporary additional duty for the S-2 Officer and Chief was terminated on 17 May 1975 upon return to MCAS(H) Futema.

2. Weekly liaison visits with III MAF G-2 were conducted throughout the period. Two TAD trips were conducted to G-2 1st MAF for the purpose of attending Intelligence Symposiums, during Feb and June 1975.

3. The Group S-2 conducted training for newly arrived O2 personnel to indoctrinate them as to the procedures for intelligence collection, security of classified material, and lock security.

4. The Group S-2 section was busy in the area of personnel security clearances, access, and investigations with the following statistics noted:

## NARRATIVE SUMMARY

(C) Support in the form of liaison and planning was given to MAG 36 units designated to participate in MAFLEX 1-75. This operation was cancelled in its planning stage due to operational commitments.

(C) Operations Eagle Pull and Frequent Wind were executed during this period. Planning and support for these contingency operations required the formation of a PROVMAF. PROVMAF 39, commanded by Col F. G. McLenon, participated in both of these operations and submitted Command Chronologies under separate cover.

(U) During this reporting period MAG 36 Training inducted 439 Marines into Training & Orientation School. 535 Marines qualified with the service rifle, and 430 with the pistol. Training sent 30 men to NCO School, 566 to Defensive Drivers School, 53 to JEST School, and 70 to Water Survival Qualification.

### NARRATIVE SUMMARY

1. The MAG-36 Human Affairs Branch, established in August 1971, has continued to progress and provide the following services or functions: Leadership/Human Relations Training, Congressional inquiry and Welrep correspondence, Career Planning, Education, Welcome Aboard, Cultural Lectures, Programs, and Tours, R & R Quota Dessimation, Outstanding Company Grade Officer Selections. Screening, Technical Information Screening for News Release, Drug and Alcohol Abuse Control, Postal Services.
2. Leadership/Human Relations Training. Attendance has fallen well below an adequate level during the first four months of this period training a total of only 274 Marines a 9.5% of the average command strength. Greater emphasis on training during May showed a definite increase with 223 Marines having received training; June however, showed a slowdown with only 128 Marines having received training. Due to these past

statistics and the burdens placed on squadrons to train their personnel, an overhaul of the program was implemented, activated, and incorporated into the T/O school program. It is anticipated that this will yield between 195 to 260 Marines trained each month. In order to meet current requirements approximately 8.3% of the Command or 240 Marines must attend training each month. Emphasis is being placed on training incoming personnel.

#### Additional Leadership/Human Relations Activities

a. Welcome Aboard Lectures. This program is managed by the Human Affairs Branch. The presentation is directed toward helping incoming Marines understand drug and alcohol problems, Japanese laws and jurisdiction, Human Affairs Activities, moral guidance availability and local recreation activities. Weekly lectures have had 946 Marines in attendance.

b. Cultural Lectures. These are conducted weekly with attendance reaching 839. These lectures are considered exceptionally successful. Attendees are interested and enthusiastically motivated. A large amount of material is presented and a high retention of knowledge has been noted. This is a very positive portion of the Human Relations Program covering customs, courtesies, short language phrases, ideas basic to local culture & Religion, history and geography.

c. Cultural Tours. These are set up in conjunction with cultural lectures and are considered the practical application phase of this program. Attendees use both military and local buses, they have the opportunity and progressive atmosphere to utilize short phases to local natives. Many "do's" and "don't's" are explained enroute in addition to kindling individual interest in numerous outside cultural activities. Many of the customs are explained as encountered along with ideas of the native culture. 31 tours have been conducted with 535 Marines participating.

d. Cultural Exchange Program. This is a new program on a trial basis having been initiated in May of this year. To date, 5 meetings have been held involving 15 Marines and 15 students from the University of the Ryukyus at Shuri. All of the University students are English minors which has definite advantages in aiding the progression of the program. Marines attending experience a educational relationship that normally would not be encountered elsewhere.

3. R & R Flights. Have been conducted regularly to Taiwan and to Korea with special flights frequently to Hong Kong. A definite preference among Marines to chose Korea as an R & R site exists in addition to numerous inquires as to possible R & R flights to the Philipines. Liaison with Camp Butler Special Services indicate no change is anticipated in the current program.

#### 4. Service Review Committee.

a. Numerous negative reports have been submitted, of the positive reports, far to many items have had little or no substantiation. ~~Improvements~~ have been initiated with emphases on submitting reports that are useful.

b. Of the numerous complaints or recommendations that have been received only the following remain without favorable solution thus far:

Base & interbase transportation

Permission to have soft drinks inside of theater

5. Career Planning. During this period 40 out of 90 first termers eligible reenlisted for a reenlistment rate of 44.4%. Careerist reenlistments were 29 out of 31 for a 93.5% reenlistment rate. The cumulative reenlistment percentage is 57%.

6. Education.

a. The Education program is consolidated effort with MCAS(H) Futenma. The Education Officer works from MAG-36, while the Education NCO is from MCAS(H) Futenma. The officer fulfills the roll of "camp representative" within the Butler Education System.

b. The summary goal of the MAG-36 Education Program has become High School level work leading to a diploma.

c. Non-high graduates were up from 647 to 686 new enrollments in prep courses is 128. In addition to 75 completions. College enrollement has dwindled to 36.

d. Groundwork was initiated and completed for the Prep/Float Program aboard MCAS. The lone obstacle preventing implementation is classroom availability. Efforts are continuing, but to date have been unsuccessful.

7. Drug and Alcohol Abuse.

a. The primary efforts of the MAG-36 Counseling Center staff during the period 1 Jan 75 - 30 Jun 75 centered around education. The overseas Drug Orientation Lecture was presented to 932 Marines. The Counseling Center staff presented additional drug and alcohol lectures to 476 Marines.

b. 48 Marines participated in local counseling at the MAG-36 Counseling Center for drug or alcohol abuse. 4 Marines were medivaced to Alcohol Rehabilitation Centers in the United States and 3 were medivaced to Naval Drug Rehabilitation Centers.

c. 2,904 Marines underwent random urinalysis testing and 25 returned confirmed lab positive for .86% positive rate. 21 drugs identified were opiates, 3 were barbiturates, and lamphetamine. One honorable discharge was awarded as a result of urinalysis testing.

d. Dr R. RESEN of the University of Maryland observed MAG-36 counseling efforts over a 5 week period offering guidance to the Counseling Center Staff.

e. A primary hindrance to MAG-36 counseling efforts was the lack of trained counselors. During this reporting period, only one formal school (at the University of Oklahoma) was available. Camp Kuawae was utilized for a 1 week orientation course.
