3. Summary of Significant Events

a. Personnel. (u) Four Naval Aviators, one Naval Flight Officer and one Aviation Ground Officer completed their overseas tours. One Naval Aviator was transferred to Marine Aircraft Group 16. Three Naval Aviators, two Aviation Ground Officers, and one Naval Flight Surgeon were received from the August draft. One Aviation Ground Officer was received from Marine Air Base Squadron 11. Enlisted strength remained almost the same after the large loss of personnel in July.

b. Awards. (u) Master Sergeant Raymond W. SMITH and Gunnery Sergeant Charles W. BERRYMAN were awarded the Vietnamese Gallantry Cross with the Bronze Star for skillful and resourceful performance in support of Operation Colorado.

c. Air Operations. (s) Total flight hours and sorties were 825.8 and 676; combat hours and sorties were 817.5 and 669. Damage assessment for the month included 216 structures destroyed, 5 boats destroyed, 242 VC confirmed killed, and possibly 301 more VC killed. The VC killed by air figures are easily the highest figure attained by this unit in either of its two combat tours in the Republic of Vietnam.

d. Command Relationship/Command and Control. (u) On 8 August, Major Larry R. VAN DEUSEN assumed command of this organization from Lieutenant Colonel Dean C. MACHO. Major VAN DEUSEN had formerly been the Executive Officer of Marine Fighter/Attack Squadron-314; LtCol. MACHO has his next duty assignment with the Third Marine Aircraft Wing.

e. Training. (u) Nine aircrew members completed the Jungle Environment and Survival Training Course. One Naval Aviator completed the Fifth Air Force Sea Survival Course. One officer and one enlisted man completed the Corrosion Control Course at Tachikawa Air Base. One officer completed the Embarkation School at Camp Hansen, Okinawa.

## 3. Summary of Significant Events

a. Personnel. (u) One Naval Aviator, two Naval Flight Officers, and one aviation ground officer were rotated upon completion of their overseas tours. One Naval Aviator and three Naval Flight Officers were received from various duty stations in the United States. One aviation ground officer was received from Headquarters and Maintenance Squadron Eleven. One staff sergeant was commissioned as a temporary Second Lieutenant. Enlisted strength shows a slight increase as compared to the previous month.

b. Awards. (u) Seventy-two Air Medals were awarded to flight crew members. Recommendation for fifty-eight Air Medals were made to higher authority.

c. Air Operations. (s) VMFA 115 recorded in September 841.2 hours and 673 sorties. Combat hours and sorties were 824.2 and 660. Missions included TPQ, Tally Ho, cover, direct air support, helo escort, close air support, ground defense alert scramble, Red Blazer, tactical air controller (airborne), Fire Cracker, ferry, and test. Damage assessment included 165 structures destroyed, 29 VC killed, 7 boats destroyed, and one POL dump destroyed.

d. Training. (u) Five aircrew members completed the Jungle Environment and Survival Training Course. Two Naval Flight Officers completed the Fifth Air Force Sea Survival Course. One ground officer completed the Corrosion Control Course at Tachikawa Air Base. One officer and four enlisted personnel completed the Wing Special Ordnance Loading Course.
