




b. Awards. (U) Twenty-two Air Medals were awarded to flight crew members. Recommendations for sixty Air Medals were forwarded to higher authority. The Vietnamese Cross of Gallantry with Silver Star was awarded to one flight crew member. One Meritorious Mast was awarded.

c. Air Operations. (C) During the reporting period VMFA-115 reported 609.4 flight hours and 518 sorties. The squadron flew 607.4 combat flight hours and 515 sorties. Missions include Close Air Support, Direct Air Support, Tally Ho, Helicopter Escort, Landing Zone Preparation, Red Blazer, and TPQ. Damage assessment included 248 structures destroyed and 9 damaged, 18 road cuts, 7 automatic weapon positions destroyed and 2 damaged, 19 secondary explosions, 15 secondary fires, 505 meters of trench line destroyed, 18 foxholes destroyed, 1 bridge destroyed, and 1 radio transmitter site destroyed.

One Bronze Star was awarded. 19 Distinguished Flying Crosses were recommended to higher authority, but were returned for further processing.

c. Air Operations. (C) During the reporting period VMFA-115 recorded 668.4 flight hours and 564 sorties. The squadron flew 661.1 combat flight hours and 557 combat sorties. Missions included Close Air Support, Direct Air Support, Tally Ho, Helicopter Escort, Landing Zone Preparation, Red Blazer, and TPQ. 



b. Awards. (U) 78 Recommendations for Air Medals were forwarded to higher authority. Three Meritorious Mast were awarded.

c. Air Operations. (C) During the reporting period VMFA-115 recorded 750.4 flight hours and 639 sorties. The squadron flew 721.3 combat flight hours and 611 combat sorties. Missions included Close Air Support, Direct Air Support, Tally Ho, Helicopter Escort, Landing Zone Preparations, Red Blazers, and TPQs. Damage assessment included 28 KBA confirmed and 38 KBA probable, 77 bunkers destroyed and 7 damaged, 141 structures destroyed and 35 damaged, 49 road cuts, 5 bridges destroyed and 1 damaged, 300 meters of road destroyed, 130 meters of trench line destroyed, 4 automatic weapons positions destroyed and 6 gun positions destroyed, 18 secondary fires and 8 secondary explosions. VMFA-115 flew combat missions in support of operations Kingfisher, Benton, Cumberland, Cochise, Beacon Guide, Beacon Torch, Ardmore, Freemont, Dragon Head, and Stockton.

During the reporting period the squadron dropped 1249.43 tons of ordnance. Ordnance expended included 1816 MK81, 2466 MK82, 276 MK117, 28 MK83, 458 MK77 fire bombs, 1121 2.75 rockets, 118 Zuni, and 5586 rounds of 20MM.

PART TWO: NARRATIVE SUMMARY

During the reporting period VMFA-115 recorded 682.4 flight hours and 575 sorties. The squadron flew 666.5 combat flight hours and 561 combat sorties. Missions included Close Air Support, Direct Air Support, Tally Ho, Steel Tiger, Helicopter Escort, Landing Zone Preparation, Red Blazers, and TPQ's. Bomb

damage assessment included 37 KBA confirmed and 103 KBA probable, 43 bunkers destroyed and 8 damaged, 342 structures destroyed and 104 damaged, 570 meters of trench line destroyed, 20 road cuts, 300 meters of road destroyed, 5 bridges destroyed, 9 secondary explosions and 14 secondary fires, 2 mortar positions destroyed, 6 rocket positions destroyed, 2 artillery positions destroyed, and 4 automatic weapon positions destroyed. VMFA-115 flew combat missions in support of operations Kingfisher, Neutralize, Freemont, Fortress Sentry, Shelbyville, Wheeler, Ballistic Charge, Dragon Fire, Swift, and Cumberland.

During the reporting period the squadron dropped 1024.7 tons of ordnance. Ordnance expended included 386 MK-77 Fire Bombs, 1651 MK-81, 2233 MK-82, 599 MK-117, 20 MK-83, 28 CBU-24, and 1562 Zuni.

During the reporting period two aircraft were lost at sea, one as a result of enemy ground fire and the other as a result of aircraft malfunction. Three aircraft received extensive battle damage.

PART THREE: SIGNIFICANT EVENTS

1. Awards. Recommendations for nineteen Distinguished Flying Crosses, ninety-three Air Medals, one Bronze Star, one Navy Achievement Medal, and seven Navy Commendation Medals were forwarded to higher authority. Aircrew members received eighty-seven Air Medals.
2. Casualties. Two aircrew members received major injuries during ejection.
3. Personnel. Five Naval Aviators, four Naval Flight Officers and one Aviation Ground Officer were joined. Three Naval Aviators, two Naval Flight Officers and one Aviation Ground Officer were transferred. Nine enlisted men were promoted to Sergeant, forty-nine to Corporal, ten to Lance Corporal and one to Private First Class.
4. Training. Aircrew training was conducted throughout the reporting period, with particular emphasis on instrument flying in preparation for the coming monsoon season.





During the reporting period VMFA-115 was active in supporting operations throughout the I Corps area, within the DMZ, and in the southern panhandle of North Vietnam. Operations supported included Kingfisher, Freemont, Wheeler, Dragon Fire, Formation Leader, Ardmore, Osceola, Wallowa, Neutralize, and the A Shau Valley winter campaign. Missions flown included Close Air Support, Direct Air Support, Tally Ho, Steel Tiger, Helicopter Escort, Landing Zone Preparation, Red Blazer, Visual Reconnaissance, and TPQ.

Bomb damage assessment included 11 KBA confirmed, 10 KBA probable, 27 bunkers destroyed, 7 sampans destroyed and 8 damaged, 3 pack animals killed, 285 meters of trench line destroyed, 139 structures destroyed and 42 damaged, 1 secondary explosion and 1 secondary fire, 1 automatic weapons position, 2 artillery positions, and 2 anti-aircraft positions destroyed, 1 road cut, and 130 meters of road destroyed. An increase in TPQ'S and Tally Ho's was a significant factor in the reduction of bomb damage assessment for this month.

During the reporting period the squadron dropped 989.78 tons of ordnance. Ordnance expended included 290 MK77 Fire Bombs, 1293 MK81, 2258 MK82, 12 MK83, 160 MK117, 6 CBU-24/B, 14,375 20MM, 49 Zuni Rockets, and 19 2.75 Rocket Pods.

PART THREE: SIGNIFICANT EVENTS

1. Personnel. Six Naval Aviators and three Naval Flight Officers were joined. Six Naval Aviators and six Naval Flight Officers were transferred. 47 enlisted were joined and 33 transferred. 2ndLt KENNETH G. DURHAM was promoted to 1stLt. 41 enlisted men were promoted to corporal and 2 to lance corporal. There were no reenlistments or extensions during the month.
2. Awards. Recommendations for four Distinguished Flying Crosses, two Purple Hearts, fifty-eight Air Medals, and one Navy Commendation Medal were forwarded to higher authority. Aircrew members received fifty-eight Air Medals.



During the reporting period VMFA-115 was active in supporting operations throughout the I Corps Area, within the DMZ, and in the southern panhandle

of North Vietnam. Operations supported included Kingfisher, Neutralize, Wallowa, Kentucky, Lancaster, Wheeler, Essex, Foster, Knox, and Granite. Missions flown included Close Air Support, Direct Air Support, Tally Ho, Steel Tiger, Helicopter Escort, Landing Zone Preparation, Visual Reconnaissance, Air to Air Intercept Practice Scrambles, and TPQ.

Bomb damage assessment included 10 KBA confirmed, 28 KBA probable, 62 bunkers destroyed and 20 damaged, 51 structures destroyed and 61 damaged, 14 secondary fires, 10 secondary explosions, 130 meters of trench line destroyed, 29 fighting holes destroyed and uncovered, 2 rice crops destroyed, 1 anti-aircraft site destroyed and 1 damaged, 1 artillery position destroyed, 14 sampans destroyed and 4 damaged, 4 bridges destroyed, 7 road cuts, and 4 partial road cuts. The onset of the monsoon season was a significant factor in the reduction of bomb damage assessment for the month.

During the reporting period the squadron dropped 1,408.119 tons of ordnance. Ordnance expended included 150 MK 77 fire bombs, 985 MK 81, 3778 MK 82, 5 MK 83, 779 MK 117, 71 Zuni, 19 2.75 rocket pods, and 11,338 20 MM.

Significant Sorties Flown During the Month

On 18 November COL E. N. LEFAIVRE, 1/LT R. P. ROBSON, CAPT D. R. GRIFFING, and CAPT R. E. HENRICKSEN flew a Close Air Support mission in support of Operation Foster South of Danang. Using napalm and a gun pod the flight destroyed 26 military structures, damaged 4 military structures, and destroyed 2 rice crops.

CAPT H. F. PYLE, 1/LT R. T. COX, CAPT N. G. G. KERR, and 1/LT M. J. SHARBAUGH were diverted to an emergency Close Air Support mission in the DMZ on 18 November. Dropping MK 82 snakeye bombs the flight destroyed 20 bunkers and had 5 KBA probable.

Recent Information Received on Previous Sorties

On 10 September CAPT F. S. TENER, CAPT N. G. G. KERR, CAPT C. S. CAHASKIE, and CAPT T. W. HOWARD were also called on to conduct a Close Air Support mission in the Dong Ha area. Dropping MK 81 snakeye bombs and napalm in marginal weather conditions the flight was credited with 65 KBA confirmed and 120 KBA probable. While making runs, both aircraft were hit by ground fire and sustained serious damage.

On 20 October LTCOL R. E. CAREY, MAJ R. A. GURLEY, CAPT D. L. SHORTAL, and CAPT B. B. RODGERS flew an emergency Close Air Support mission in the Dong Ha area. The flight dropped MK 82 snakeye bombs and fired a gun pod in

close proximity to friendly troops in marginal weather. The flight received credit for a substantial amount of the 195 KBA confirmed that were counted after the engagement.

PART THREE: SIGNIFICANT EVENTS

There was one reenlistment and no extensions during the month. 95.4 per cent of the squadron was enrolled in the Savings Bond Program.

2. Awards. Recommendations for sixty-four Air Medals, two Single Mission Air Medals and five Vietnamese Crosses of Gallantry were forwarded to higher authority. Fifty-six Air Medals, four Single Mission Air Medals, and one Navy Achievement Medal were received.



During the reporting period VMFA-115 was active in supporting operations throughout the I Corps Area, within the DMZ, in the Southern Panhandle of North Vietnam, and Laos. Operations supported included Kentucky, Fortress Ridge, Citrus, Kent, Headshed, Lancaster, Lamson, and Shock Four. Missions flown included Close Air Support, Direct Air Support, Tally Ho, Strike, etc.

Helicopter Escort, Landing Zone Preparation, Visual Reconnaissance, Armed Reconnaissance, Air-to-Air Intercept Practice Scrambles, BARCAP, and TPQ.

Bomb damage assessment included 13 KBA confirmed, 50 KBA probable, 66 structures destroyed and 25 damaged, 32 bunkers destroyed and 15 damaged, 680 meters of trench line destroyed, 6 secondary fires and 2 secondary explosions, 2 automatic weapons positions destroyed, 46 road cuts, 2 road slides, 3 bridges destroyed, and 4 ford cuts.

During the reporting period the squadron dropped 1137.84 tons of ordnance and averaged 36.70 tons of ordnance expended per day. Ordnance expended included 222 MK 77 fire bombs, 1,462 MK 81, 2,788 MK 82, 4 MK 83, 195 MK 117, 12 CBU-24B, and 1,767 rounds of 20 MM.

Significant Sorties Flown During the Month

On the night of 25 December Capt H. F. PYLE, Capt L. R. CUSHMAN, 1stLt J. W. PROCTOR and 1stLt R. P. ROBSON were scrambled off the Air-to-Ground Hot Pad on a priority Close Air Support Mission northwest of Dong Ha. The flight dropped snakeye bombs and napalm within 50 meters of friendlies during marginal weather without the aid of flares. As result of the flights accurate ordnance delivery the Recon Team supported was successfully extracted.

On 29 December LtCol C. L. BATTISTONE, 1stLt R. P. ROBSON, Capt J. C. HURST and 1stLt A. L. SHERWIN were scrambled off the Air-to-Ground Hot Pad on an emergency Close Air Support Mission south of Chu Lai to support a med evac and attack a fortified VC village. As a result of the flights accurate delivery of their snakeye bombs and napalm the med evac was successfully completed and the fortified village neutralized.

1. Personnel. One Naval Aviator and one Naval Flight Officer were joined. Two Naval Aviators and one Naval Flight Officer were transferred. 41 Enlisted were joined and 33 transferred. One SSGT was promoted to GYSGT and 11 CPL to SGT. There was one reenlistment and no extensions. 99 per cent of the squadron was enrolled in the Savings Bond Program.
