PART II

NARRATIVE SUMMARY

During this period, VMGR-152 flew a total of 1132 sorties, carrying 4080 short tons of cargo, baggage and mail, and 26,417 passengers.

The squadron continued to maintain a detachment of aircraft at Danang AFB, Republic of Viet Nam, under the operational control of the CG, 1stMAW. This detachment provided the necessary aerial refueling, flare drop, logistical resupply, and medical evacuation support for operations throughout the III MAF. VMGR-152 maintains Sub Unit 1 at Danang AFB to support the detachment aircraft. The squadron normally maintains four aircraft with the Sub Unit 1 detachment. The detachment is augmented with additional aircraft, as required, for special operations.

Periodically the squadron detachment at Danang is called upon to perform night flare drop missions in support of local ground action. During January four flare drop missions were flown with 21 flares dropped. The relatively small number of flares expended was due to adverse weather conditions.

January operations consisted primarily of routine passenger and cargo flights. During the latter part of January the weather in Viet Nam improved to allow VFR operations in most areas. This greatly increased the number of daily sorties in-country.
