NARRATIVE SUMMARY

During the month of May 1970, HMM-161 continued to fly combat missions in support of the 1st Marine Division, ROKMC and the ARVN units located in the DaNang area. Squadron aircraft and crews accumulated a total of 1122.8 flight hours while primarily being involved in such tasks as Med-Evac, resupply, troop lifts and strikes, administrative lifts and numerous recon inserts and extracts. In accomplishing these assigned missions, the Squadron flew 3,651 sorties, completing 2,054 tasks, transported a total of 8,899 passengers and delivered 181.8 tons of resupply cargo. The Squadron evacuated 114 emergency, 115 priority, and 157 routine Med-Evacs from field units to medical units in the DaNang complex.

During the month there were two (2) meritorious/combat and three (3) meritorious promotions for enlisted personnel.

During the month there were seven (7) Air Medals, one (1) Purple Heart and fifteen (15) Combat Air Crew Wings awarded to enlisted personnel.

During the month, the Squadron had one (1) Aircraft Accident ("Charlie" damage), ten (10) Aircraft Incidents and one (1) Aircraft Ground Accident. Injuries sustained by individuals in the Aircraft Incidents, were one (1) Major and one (1) Minor and were due to Enemy Fire.
