- B. PART TWO NARRATIVE SUMMARY

l March 1967 - Normal operations conducted in the Phu Bai/Dong Ha areas. Nine (9) medevac missions were flown in the Dong Ha area and one (1) in the Phu Bai area for a total of ten (10). On two (2) of the medevac missions in the Dong Ha areas Lt. HUGHES, the flight leader, received amall arms fire. No hits were recorded to the aircraft. On an admin flight in Dong Ha area Major CARROLL executed an autorotation to a rice paddy due to rough running engine and subsequent loss of power. No injuries to either crew or passengers were recorded.

2 March 1967 - Normal operations conducted in the Phu Bai/Dong Ha areas today. A total of twenty-three (23) medevac missions were completed today. Eight (8) of these missions were flown as night medevacs. Captain THIEN, while on one medevac in the Dong Ha area, received small arms fire (sniper) while in the zone. No hits were recorded. Major BENO, while on a medevac mission in the Phu Bai area at night received mortar and small arms fire while in the zone. One (1) hit was recorded but no injuries received.

3 March 1967 - Normal operations in the Phu Bai/Dong Ha areas today. A total of fourteen (14) medevac missions were flown by the squadron today. Three (3) of the medevac missions were night medevacs. Captain BARNETT flew SAR for downed UH-34D attached to HMM-361 in the Phu Bai area (Pilots were recovered). Lt. BRICKELL, while on medevac mission in the Dong Ha area, received mortar fire while in the landing zone. No hits or injuries were recorded. Lt. KAWALEK, acting as chase on a medevac in the Dong Ha area was climbing out of the zone when he experienced rapid rise in oil temperature and a engine chip detector light. An autorotation was executed to a field below them with no injuries resulting. The aircraft was later retrieved from the field.

4 March 1967 - Normal operations conducted in the Phu Bai/Dong Ha areas. A total of sixteen (16) medevac missions were flown in both areas today.

5 March 1967 - Weather limited flying in both areas today. A total of six (6) medevac missions were flown by the squadron. All in the Dong Ha area. On one (1) medevac mission Lt. HUGHES, flight leader, received fire while in final approach to the zone at about 200 feet. The aircraft received numerous hits to both rotor blades and fuselage. No injuries were reported. On two subsequent medevac missions Lt. O'CONNELL, acting as chase for Lt. HUGHES, received fire and numerous hits to his aircraft. On both occassions the Pilot and Co-pilot received minor shrapnel wounds from flying glass and metal in the cookpit. No other crew members recieved injuries. On a forth medevac mission, Captain HURLBUT, acting as Lt. HUGHES's chase, received small arms fire while coming out of the landing zone. He received small arms hit to his aircraft and the corpsman received gunshot wounds to his lower abdomen.

6 March 1967 - Weather limited flying in both areas today. Three (3) medevac missions were flown by the squadron today. Major McDONALD led a flight of three aircraft on an emergency retraction of three (3) recon teams today. Muster I, Nettlerash II and Muster II were the teams involved. Sniper fire was recieved while extracting Nettlerash II, however, no hits were taken by the aircraft.

7 March 1967 - Bad weather limited flying today to two (2) medevac missions.





8 March 1967 - Bad weather limited flying today to three (3) medevac missions. On one (1) night medevac mission today, led by Captain THIEN, an enemy grenade was thrown at the aircraft while in the landing zone. The aircraft took hits from shrapnel, however, no injuries were recieved.

9 March 1967 - Bad weather limited flying in both areas today. Five (5) medevac missions were flown by the squadron today. Major McDONALD led a flight of three aircraft on emergency retraction of one recon team, "Nettlerash I", with no fire being taken by the flight. Major BENO led a flight on an night emergency retraction of a recon team. Major BENO was orbiting the zone after picking up his half of the recon team when he experienced an engine chip detector light. An autorotation was made immediately and the engine quit on touch down. There were no injuries reported and the aircraft was later externaled back to Phu Bai.

10 March 1967 - Normal operations conducted in the Phu Bai/Dong Ha areas today. Three (3) medevac missions were flown by the squadron today.

11 March 1967 - Normal operations conducted in the Phu Bai/Dong Ha areas today. Twelve (12) medevac missions were flown by the squadron today, two (2) being night medevacs.

12 March 1967 - Normal operations conducted in the Phu Bai/Dong Ha areas today. The squadron completed thirteen (13) medevac missions today, three (3) being night medevacs.

Seventeen (17) medevac missions were flown today, one (1) being a night medevac. Major SAMARAS, while leading on two (2) medevac missions in the Dong Ha area, received small arms fire from area around the LZ. No hits were taken. Lt. HENDERSON, while leading a flight on a medevac mission in the Phu Bai area, received fire about 1000 meters from the LZ. No hits were taken. Captain KESTLER, while leading a flight on a medevac mission in the Dong Ha area, received mortar rounds to the landing zone as the aircraft was lifting out. No hits were recorded. Major SAMARAS, while on an emergency recon team retraction, received fire as he was touching down in the zone. The aircraft received several hits and the pilot immediately lifted off. He continued to receive fire and the aircraft subsequently lost power and crashed into the trees. The aircraft exploded before the other two crewmembers could be freed. The pilots were retrieved from the area the following day and were taken to the USS REPOSE.

14 March 1967 - Normal operations conducted in the Phu Bai/Dong Ha areas today. Thirteen (13) medevac missions, three (3) of them being night were completed. Major RUECKEL, while on an recon overflight received fire on three (3) occasions. No hits were taken. Captain HEIN, experienced a generator failure while on a night medevac today. Aircraft flown back to Phu Bai with no damage or injuries.

15 March 1967 - Normal operations conducted in the Phu Bai/Dong Ha areas today. The squadron flew a total of ten (10) medevac missions today, one (1)being a night medevac.

16 March 1967 - Normal operations conducted in the Phu Bai/Dong Ha areas today. The squadron flew a total of seventeen (17) medevac missions today, five (5) of them being night medevacs. Major RUECKEL led a flight of three aircraft on an emergency retraction of recon team "Nettlerash II". The aircraft took fire during the pickup, but no hits were taken to the aircraft.

17 March 1967 - Normal operations conducted in the Phu Bai/Dong Ha areas today. The squadron flew a total of twenty-one (21) medevac missions, six (6) of them being night medevacs. Lt. HUGHES while on a day medevac mission received small arms fire from area around the landing zone. No hits were taken. Lt. HUGHES, on a night medevac and emergency resupply of ammo, received fire while in the landing zone. One (1) hit was taken to the aircraft but no injuries occurred. The mission was completed.

18 March 1967 - Normal operations conducted in the Phu Bai/Dong Ha areas today. The squadron flew a total of fifteen (15) medevac missions, two (2) of them being night medevacs. Lt. HUGHES was leading a section of two (2) aircraft from Dong Ha to Phu Bai on an emergency evacuation of Dong Ha, when his section took heavy fire. The aircraft were forced to fly low due to bad weather. The second plane, piloted by Lt. SNIDER, received a hit to his aircraft and the fuel quantity guage fell to zero. He made a precautionary landing to a rice paddy by Highway # 1. No injuries occurred. Captain BOWMAN also received fire today while on a night flight returning to Phu Bai south along Highway # 1. One (1) round hit the spar of his rotor blade. No injuries occurred.

19 March 1967 - Normal operations conducted in the Phu Bai/Dong Ha areas today. The squadron flew a total of ten (10) medevac missions today, one (1) being a night medevac. Lt. HEIN received small arms fire today while on a medevac mission. He had just lifted from the landing zone when he received sniper fire. He took one (1) round through the spar of the main rotor blade. No injuries occurred. DECLASSIFIED

- 20 March 1967 Poor weather hampered flying in both areas today. The squadron flew a total of nine (9) medevac missions today, three (3) of them being night medevacs. Lt. HEIN, while flying a medevac mission during the day, damaged his aircraft by flying into a tree. He was forced to low altitude by the weather, and while following a river for navigational purposes he inadvertently struck a tree causing considerable damage to the aircraft. No injuries reported. Lt. HEIN, while flying on a night medevac mission, received what appeared to be fire from an anti-aircraft weapon. He noticed five (5) airbursts close to the aircraft, however, no hits were taken. Major McDONALD, while on an emergency medevac at night, had an enemy grenade thrown at his aircraft. He was just setting down in the zone when the grenade exploded inflicting shrapnel damage to the aircraft. No injuries were recorded.
- 21 March 1967 Normal operations conducted in the Phu Bai/Dong Ha areas today. The squadron flew a total of nine (9) medevac missions today.
- 22 March 1967 Normal operations conducted in the Phu Bai/Dong Ha areas today. The squadron flew a total of seven (7) medevac missions, three (3) of them being night medevacs.
- 23 March 1967 Normal operations conducted in the Phu Bai/Dong Ha areas today. A total of ten (10) medevac missions were flown today, seven (7) of them being night medevacs. On one (1) night medevac mission Lt. BANCELLS, the flight leader, took automatic weapons fire from the area around the landing zone. No hits were taken to the aircraft.
- 24 March 1967 Normal operations conducted in the Phu Bai/Dong Ha areas today. Fourteen (14) medevac missions were flown by the squadron today, seven (7) being night medevacs. Major STEPHENS led a flight of three (3) aircraft on an emergency extract of two recon teams. The flight took fire on both missions however no hits were taken. Major STEPHENS and flight also received fire while on a recon overflight in the Phu Bai area. No hits were taken to the aircraft. Captain THIEN, while on an emergency resupply in the Dong Ha area received fire. No hits were taken.
- 25 March 1967 Normal operations conducted in the Phu Bai/Dong Ha areas today. The squadron completed sixteen (16) medevac missions today, two (2) being night medevacs. On one (1) medevac missions in the Dong Ha area Captain HALL took small arms fire from area near the landing zone. No hits taken by the aircraft.

26 March 1967 - Normal operations conducted in the Phu Bai/Dong Ha areas today. A total of eleven (11) medevacs were flown in both areas, eight (8) were emergency and three (3) were priority. Four (4) were flown at night. Captain HEIN was flying the night medevac at Dong Ha and received fire, but no hit were taken in the aircraft.

27 March 1967 - Normal operations conducted in the Phu Bai and Dong Ha area today. A total of twenty-six (26) medevacs were flown in both areas today. There were twelve (12) night medevacs flown. Lt. HUGHIS received fire on one of the night medevac missions. No hits were recorded.

28 March 1967 - Normal operations in Phu Bai and Dong Ha area today. A total of fifteen (15) medevac missions were flown. Four (4) of the medevac missions were flown at night. Captain ZOLLER received fire on one of the night missions. No hits were taken in the aircraft. Captain HURLBUT made an emergency landing with engine trouble. The aircraft was repaired and flown back to Phu Bai. Several VIP hops were flown, VIP were code 2 and 3.

29 March 1967 - Normal operations conducted in the Phu Bai/Dong Ha areas. The total number of medevac missions flown was ten (10). Lt. (CONNELL flew the only night medevac mission but was unable to complete it when he made a hard landing after going IFR due to dust in the landing zone. Several VIP hops were flown carrying the Congressional party.

30 March 1967 - Normal operations conducted in the Phu Bai/Dong Ha area. A total of fifteen (15) medevac missions were flown. Two (2) of the medevacs were flown at night. Major McDONALD made a full autorotation due to engine trouble. None of the crew were injured.

31 March 1967 - Normal operations conducted in the Phu Bai and Dong Ha area. A total of six (6) medevac missions were flown.
