

### NARRATIVE SUMMARY

- 1. Major J. J. MCCAFFREY relieved Major J. A. JENNINGS as Executive Officer. Major JENNINGS relieved Major C. L. PHILLIPS as Operations Officer and Major PHILLIPS became the Maintenance Officer.
- 2. Average aircraft availability was 64% for October.
- 3. The squadron flew 695.5 hours with an average on board count of 17 air-craft and 21 pilots.

#### SIGNIFICANT EVENTS

### 1. Personnel:

- a. Four (4) officers and seventeen (17) enlisted personnel were promoted
- b. Three (3) enlisted personnel received meritorious masts.
- 2. Public Information: The TIO officer processed twenty-six (26) Fleet Hometown News Releases.
- 3. Morale and Welfare Program: Fourteen (14) personnel were sent on R & R.

# 4. Air Operations:

a. During October the squadron flew 556 sorties for 695.5 hours, the following is a breakdown of the type of sorties flown:

- b. Twenty Two (22) non-squadron pilots flew 71 sorties amounting to 96.9 hours which represented 12.7% of total sorties flown.
- c. The squadron expended the following amounts of ordnance by type in October: 2016 Rds of 20MM, 193 MK 77, 18 LAU 3, 788 MK 81, 81 MK 82, 4 MK 84, 52 ANM 64, 100 ANM 65, and 1 ANM 66.
  - d. Six (6) pilots were transferred and Eight (8) pilots joined in October.
- 5. Ground Defense: One actual alert was held in October and the reaction time was somewhat hindered due to the absence of sounding the siren identifying the type of alert.

## 6. Training:

- a., Two pilots were sent to Low Pressure Chamber/Ejection Seat refresher in Okinawa.
- b. Numerous pilot training, NATOPS, and safety briefings were conducted through APM's and Flight Schedule notes. Particular emphasis was placed on complacency, foul weather operations, and ordnance patterns.

# 7. Logistics:

- a. Received OPTAR grant of 179,000.00
- b. Received authority to order certain project 51 items previously budgeted for.
  - c. Budget for next quarter submitted on project 10 and 51.
  - d. All custody cards, master and sub-custody re-signed.
  - e. Invoiced 2 hydraulic stands to MAG-11.
  - f. Received one new air compressor.
  - g. Safety shoes issued to flight line personnel.
- h. Pre-A&M inspection held by Group Supply, Navy Section received excellent rating, Marine Corps Section received outstanding, A&M inspection was post-poned until March 1967.
  - i. Received 2,000 sand-bags for renovation of squadron foxholes.
- j. Submitted following number of documents during the month of October, NORSG 98, NORSN 31, Pri 05 266, Pri 12 102, other Pri 02 136.

## 8. Maintenance:

- a. Average availability for the month was 64%.
- b. Average number of AOCP's was 17 per day. The most outstanding AOCP as of 31 October is dated 16 October. The AOCP rate decreased to 3.3 per day.
- c. BuNo 151059 shipped to repair and transferred. BuNo's 150035 and 149968 received from VMA 224. BuNo 151159 received from PAR and BuNo 152000 sent to PAR.
  - d. BuNo's 149976, 151199, 151190 are presently at PAR.
- e. APN/141 Radar Altimeter repair was hindered due to the bench tester being inoperative part of the month.
  - f. On Hand personnel increased to 150.
