#### SIGNIFICANT EVENTS

## 1. Personnel:

- a. Twenty Five (25) enlisted personnel and one (1) officer were promoted during the reporting period.
  - b. There were two (2) Meritorious Masts.
- c. Eight (8) officers and forty eight (48) enlisted were joined. Sixteen (16) officers and forty eight (48) enlisted were dropped during the reporting period.

## 2. Air Operations:

- a. During April the squadron flew 390 sorties for a total of 636.7 hours.
- b. Seven (7) non-squadron pilots flew 36 sorties amounting to 58.5 hours. This represents approximately 9% of the total hours flown.
- c. There were twelve (12) pilots transfered and seven (7) pilots were joined during the reporting period.

## 3. Training:

a. The following is a breakdown of personnel who attended schools during the month of April.

- b. On 30 April the squadron devloyed ten (10) aircraft, fifteen (15) officers and fifty nine (59) enlisted personnel to Naha Air Base, Okinawa for weapons training.
- c. On 22 April five (5) officers and twelve (12) enlisted deployed to NAS Cubi Pt. P. I. with four (4) A4's to participate in exercise Mud Puppy. The exercise was cancelled, however successful aerial refueling training was accomplished enroute to Cubi Pt.
- d. Pilot ground training included lectures on auxilliary equipment, bombing range procedures, and appropriate Safety/NATOPS briefings. Ordnance safety procedures were emphasized during briefings.
