## 3. Summary of Significant Events

a. Personnel

- (1) On 28 January this squadron made a scheduled exchange of personnel with VMFA-542.
- (2) One First Lieutenant promoted to Captain.
- (3) One Staff Sergeant promoted to Gunnery Sergeant.
- (4) Four Sergeants promoted to Staff Sergeant.
- (5) Five Corporals promoted to Sergeant.

b. Casualties

- (1) On 10 January, 1stLt George E. PERRY Jr. suffered a broken left leg and right ankle as a result of landing in a rocky area after ejecting from his aircraft. 1stLt Richard T. MORRISSEY, The Naval Flight Officer of that aircraft, received cuts and bruises on ejection but no major injuries.
- (2) On 25 January, 1stLt Dudley M. WEATHERS was wounded during a bombing mission. He received broken bones and tendons in his hand and pieces of plexiglas in his chest as a result of a round striking the front cockpit canopy and entering the rear cockpit.
- (3) All the above mentioned men have been awarded the Purple Heart Medal; Lieutenants PERRY and WEATHERS have been evacuated from Viet-Nam.

c. Intelligence

- (1) Updating of all situation maps was accomplished.
- (2) Access and clearances were processed for personnel joined from VMFA-542.
- (3) The following training lectures were given:
  - (a) General Intelligence (Laos)
  - (b) Jungle Survival
  - (c) E&E, North/South Viet-Nam & Laos
  - (d) Political Situation, North/South Viet-Nam (Past and Present)
  - (e) Local Customs Lecture

d. Maintenance

(1) The squadron received a new aircraft from the F-4B pool at NAS Cubi Point, P. I.

(2) One aircraft was delivered to the Progressive Aircraft Repair facility at NAS Atsugi, Japan.

(3) One aircraft was lost as the result of battle damage.

(4) Two aircraft received battle damage, one requiring replacement of both canopies, the other requiring extensive rudder and stabilator repairs.

(5) Four aircraft received minor battle damage from ground fire.

e. Air Operations. The squadron flew 622 sorties for 843 hours. Of these totals, 557 combat sorties accounted for 751 hours. The squadron continued to fly Interdiction/Blue Blazer and other classified missions as well as the Fire-cracker Combat Air Patrols in support of VMCIJ-1.

f. Ordnance. During the month of January, the squadron expended 2045 bombs and 124 napalm bombs for a total of 650 tons of bombs. 5331 2.75" rockets were also expended.
