PART II - Significant Highlights

A. On 7 July, the squadron completed its conventional ordnance training deployment at NAF Naha, Okinawa, and the detachment of 120 personnel plus six aircraft returned to Iwakuni. The deployment was highly successful in all respects with all crews requalifying in addition to the three pilots qualifying for the first time. Training was conducted in all types of ordnance, using all modes of delivery both day and night. The deployment substantially increased the squadron's operational readiness for its impending redeployment to Vietnam.

B. On 15 July, Lieutenant Colonel Edison W. MILLER relieved Lieutenant Colonel G. H. KELLER, Jr., as Commanding Officer in ceremonies at Iwakuni. Lieutenant Colonel MILLER was the former Executive Officer of VMFA-513. Lieutenant Colonel KELLER is to assume duties with the G-3 Section, 1st MAW, at Danang, RVN.

C. On 17-20 July, the squadron conducted a Sidewinder FIREX out of Iwakuni. A total of 14 out of 14 missiles were successfully fired. The purpose of this FIREX was to provide aircrews with operational experience in the area of air-to-air weapons.

B. Administration. During July, audits were conducted of Service Record Books and over 200 sets of orders were processed for the Naha Deployment and the advance party which left for RVN on July 29.

C. Flight Operations. Primary efforts in July after the return of the Naha deployment were directed toward air-to-air weapons and tactics training. In connection with this, a Sidewinder FIREX was conducted. All types of intercepts were run, both in GCI and non-GCI environment. In addition a number of aerial combat maneuvering missions were flown in connection with the above intercept missions to round out training for any type of mission which might be assigned the squadron during its third combat tour in Vietnam. The squadron also continued to direct and run ferry missions to and from Atsugi, Japan and Chu Lai, RVN in connection with the "Shoehorn" program. The following statistical summary is presented:

Total Sorties.....179

D. Training. For the first time since leaving Vietnam, the squadron found more than 90% of its members in one place (Iwakuni) at one time (7-31 July). Accordingly, intensive basic military training was carried out, including GMS Training, NBC Warfare, small arms requalification and fam firing (Including M-14 and M-16 rifle, .38 and .45 Pistol), the Physical Readiness Test, Swimming Qualification, and administration of the GMSF test. To meet these requirements, the squadron stood down from flight operations on a number of days.
