NARRATIVE SUMMARY

2 July: Capt. E. D. HAYMORE and his wingman, Capt. J. E. UNDERWOOD, received light sniper fire from BT 200552 while on a night TAOR mission.

Capt. G. W. CUNNINGHAM received moderate sniper fire from BT 076622 and BT 074650 while on a morning medevac mission.

3 July: Capt. M. V. GRIFFITH and his wingman, Maj. C. H. F. EGGER, received moderate sniper fire from AT 812384 while on an early morning medevac mission.

Capt. C. B. SALMON received intense automatic weapons fire from ZC 210485 while on an afternoon medevac mission.

Capt. J. P. BURGESS received light sniper fire from BT 178638 while on a late afternoon medevac mission.

4 July: Capt. B. A. GALLUP and his wingman, Maj. G. L. JOHNSON, received light sniper fire from AT 882497 while on a early morning medevac mission.

5 July: Lt. R. C. GOODWIN received light sniper fire from AT 990330 while on an afternoon medevac mission.

Capt. J. R. ELFINS, the wingman for Capt. N. E. JACOBSON, received light sniper fire from AT 798558 while on an afternoon resupply mission.

6 July: Capt. L. B. MCDONOUGH received intense automatic weapons fire from AT 953608 while on a night medevac mission. The aircraft received three hits, and the Corpsman, HM3 T. E. EAGLES, received light shrapnel wounds in the left forearm. After returning to base and securing another aircraft, Capt. MCDONOUGH returned and completed the mission.

Lt. D. J. KURY received light sniper fire from ZC 1065 while on a VIP chase mission.

7 July: Capt. M. V. GRIFFITH received intense sniper fire from BT 070605 and BT 065600 while on a morning medevac mission. Excellent cover fire was provided by Annunciate "D".

8 July: Lt. R. C. GOODWIN received intense automatic weapons fire from AT 958732 and AT 980535 while on a morning resupply mission, with the aircraft receiving three hits.

- 9 July: Lt. N. F. WHITBECK, JR. and his wingman, Capt. J. P. BURGESS, received light sniper fire from AT 8952 while on a morning resupply mission.
- 10 July: Capt. L. B. McDONOUGH received light sniper fire from AT 992583 while on an afternoon resupply mission.
- Capt. B. A. GALLUP received light sniper fire from AT 995644 while on an evening medevac mission.
- 12 July: Maj. C. H. F. EGGER received light sniper fire from BT 051639 while on an early morning medevac mission.
- 13 July: Capt. C. B. SALMON received light sniper fire from BT 085655 while on an afternoon medevac mission.
- 14 July: Capt. L. B. McDONOUGH and his wingman, Capt. J. P. RAY, received light sniper fire from BT 0534 while returning from a night medevac mission.
- 16 July: Maj. G. L. JOHNSON received light sniper fire from BT 154561 while on an afternoon medevac mission.
- Capt. M. L. MORRIS received moderate sniper fire from BT 136532, AT 965720, and BT 105500 while on three different early evening medevac missions.
- 17 July: Capt. J. F. LONGDIN received moderate automatic weapons fire from BT 007573 while on an afternoon medevac mission, with the aircraft receiving one hit. Capt. LONGDIN had been diverted from a VIP chase mission to the medevac mission.
- 19 July: Capt. E. J. COADY received light sniper fire from AT 943597 while on morning liaison mission, with the aircraft receiving one hit.
- Capt. M. V. GRIFFITH received intense automatic weapons fire from ZC 195645 while on an early evening medevac mission.
- 26 July: Capt. M. M. CALEF, II received intense automatic weapons fire from YD 165653 while on an afternoon medevac mission. Capt. CALEF received shrapnel wounds in the right hand and leg, and the aircraft received six hits. The wingman, Capt. L. B. McDONOUGH, completed the mission without taking fire.
