NARRATIVE SUMMARY

Marine Light Helicopter Squadron 367 continued throughout May to maintain its traditional high level of professionalism in the completion of its assigned missions. During May the squadron logged 470.8 flight hours, 412 sorties and 194 tasks. These figures reflect the low number of operational commitments assigned HML-367 due to the progressive stand down of the transport squadrons.

Throughout May HML-367 personnel have been detached from the squadron and sent to Okinawa and Hawaii awaiting official re-deployment of the squadron colors. On the 4th of May the AH-1J aircraft left HML-367 and the Republic of Vietnam for Okinawa to be attached to VMO-6. Other members of Scarface were transferred on the 16th, 18th and 26th of May. Despite the loss of numbers HML-367 remained 100% operational up through official stand down, 26 May 1971.

During May H.L-367 was able to log more training hops than anytime since being in Vietnam. The more experienced pilots passed on their knowledge and experience gained through months of combat flying and at the same time brushed up on their own proficiency. On the 13th of May Major General Alan J. ARMSTRONG inspected H.L-367. The squadron notes with pride that HML-367 was the only squadron in Marine Aircraft Group 16 designated as satisfactory/outstanding. During May there were 8 promotions for Scarface men, 7 of them meritorious. HML-367 also had 3 efficers awarded augmentation and sworn into the regular Marine Corps. Two of these augmentations were meritorious.

26 May was the end of an era, Scarface left the skies of Vietnam. The first Marine Cobra squadron folded its colors in preparation for re-deployment. HML-367 has made a name for itself, a name and reputation characterized by professionalism. The facts speak for themselves. There was a job to do and Scarface did it. The name and legacy of Scarface shall live on in the proud tradition of Marine Corps History.
