



PART II - NARRATIVE

(C) During the period covered by this report, 1 September - 30 September 1972, the 'Hawks' of the Marine All Weather Attack Squadron 533 continued to hunt at night. The squadron flew 86 sorties and 158.5 flight hours in Route Package One in North Vietnam. Planning is the final stages for further extension of the hunting grounds to include Route Packages Two and Three. We are continuing to prove the night and all weather delivery capabilities of the Gruman A6-A Intruder and are destroying numerous supplies and other military targets in the Route Package. In addition to these night missions there were also 110 day visual sorties flown in Military Region One, South Vietnam, in direct support of South Vietnam's military forces. The squadron flew a total of 240 sorties and 405.0 flight hours in the month of September. There were 903.5 tons of ordnance delivered during this period and the squadron delivered it's 10,000th bomb of this Thailand deployment, on 17 September. The squadron accounted for a significant amount of BDA for the month.

(C) The squadron had an 82.4 sortie completion rate despite an average NORS rate of 42 items per day. Airframe supply support has been a continuing problem at Nam Phong as evidenced by the increased average daily NORS over July and August. We have also had six aircraft with major fuel leaks requiring maintenance at the depot level. Unfortunately during the month there was also an attempted sabotage of the squadron aircraft which left six A6-A's down for 24 hours.

(C) The Commanding Officer and the Operations Officer made a liaison visit to VA 115 and VA 75 aboard the USS Midway and the USS Saratoga from 16 September to 19 September 1972. The purpose of the visit was to compare planning and operational techniques and to review combat tactics used at night in high threat areas. The squadron will reap the benefit of this trip in the coming months.


(C) The squadron began an expansion of their avionics complex which should add to the squadron's capability to maintain the complex attack and navigation systems which are imperative to the performance of the Intruder's mission. Combining all avionics shops (fire control, com/nav, and electrical) in one area will provide more efficient maintenance. Plans are also underway to provide more stable and reliable power sources to the avionics maintenance area.

(U) The squadron voting, re-enlistment, and Human Relations programs are proceeding full bore. The squadron voter registration is 90% as of the end of September and promises to rise very near 100% by the end of October. Re-enlistments were above the norm again this month with five of the enlisted men signing for another tour. This is a 71.4% re-enlistment/retention rate. Over 92% of 533 personnel have completed the Marine Corps Human Relations Training program at this time. Squadron personnel are making good use of squadron educational opportunities. Approximately 20% of the enlisted personnel are enrolled in USAFE college level work including 5 new participants in September. Nine men retook the area aptitude classification examination, however, the results are not available at this time.

(U) During September the squadron recognized several of the accomplishments of it's men. There were two meritorious masts held and one meritorious promotion to Lance Corporal. CWO 3 Demeracki was awarded the Navy/Marine Corps medal(see TAB D).

(U) The Marines of Marine All Weather Attack Squadron 533 are exhibiting a tremendous ability to perform our mission under the most austere circumstances. The motivation toward our goals and the attention to duty which allows us to accomplish our mission is truly a credit to this unit and to the U. S. Marine Corps. The conditions under which we are working are improving gradually, although they still remain, in the true tradition of the Corps, expeditionary.

*CITATION*

*"For heroism on 10 July 1972 while serving as Maintenance Control Officer of Marine All Weather Attack Squadron FIVE THIRTY-THREE. Chief Warrant Officer DOMERACKI was supervising the launch of a combat sortie. During the pre-start phase, an electrical power generating unit which was plugged into an ordnance-laden attack aircraft burst into flames. Seeing the fire, he immediately dispatched line personnel for fire fighting equipment. Then, despite the obvious personal hazards, he raced to the flaming power unit and, assisted by a fellow marine from another squadron, pushed it clear of all aircraft. The aircraft in the immediate vicinity were fully fueled and loaded with 500 pound bombs. Chief Warrant Officer DOMERACKI's quick thinking and unhesitating response with complete disregard for his personal safety averted what could have turned into a major disaster that would have resulted in the loss of numerous aircraft and injury to fellow marines. Chief Warrant Officer DOMERACKI's quick action and concern for the safety of others reflected great credit upon himself and were in keeping with the highest traditions of the United States Naval Service."*
