PART IINarrative Summary

1. 31 August 1973 found VMA(AW)-533 in the process of retrograding from RTAFB, Nam Phong, Thailand. The squadron had been deployed from its parent organization in Japan since 21 June 1972. The retrograde movement, transfer of the squadron from MAG 15 to MAG 12, and the adjustment from primitive base combat operations to the garrison environment has been accomplished not without problems.

2. The majority of these have been resolved. Some significant problem areas which remain are:

a. SACE Support - Poor pre-planning resulted in repeated movement and relocation of the transferred equipment. Although some SACE support was initiated 11 September 1973, complete organic support has not been achieved to date.

b. Supply Support-- The absence of a complete inventory of the A-6A peculiar parts transferred to MAG 12 from MAG 15 delayed utilization of these assets. The existing four to five hour delay in obtaining replacement parts continues to have a detrimental effect on aircraft maintenance.

c. Test Equipment - The A-6A test equipment previously sub-custodied from MAG 12 was not available from MAG 12 until early December 1973 because of inadequate record documentation.

d. Administrative and Maintenance-- These work areas were in universally poor condition upon initial acceptance. Station Public Works backlog of maintenance and a paucity of funds precluded any outside support. Limited self-help projects have been initiated utilizing squadron assets to provide reasonable working conditions.

e. Billeting Areas - Rehabilitation of the barracks has been to date a completely self-help project. Without considerable replastering, repainting, and refurbishing of fixtures, all beyond the squadron's capabilities, these living areas continue to be marginal for our enlisted personnel.

f. Office Equipment - Typewriters necessary for the accomplishment of a myriad of administrative tasks were not obtained until late December 1973, delaying the timely submission and updating of the files and administrative functions generally.

g. Ground Support Equipment - A general shortage and the unreliable condition of assigned GSE continue to plague both the maintenance and training efforts. Numerous sorties have been lost because of inoperable equipment. Additionally, the lack of operable S&TS loaders has hampered the squadron's Special Weapons Loading Training Program.

3. VMA(AW)-533 flew 300 sorties with 807.9 flight hours in the period 31 August - 31 December 1973. On 12 September 1973, the squadron flew its 10,000th accident free hour.

4. On 28 December 1973, the squadron deployed to NAS Cubi Pt, Philippines for a period of about six weeks. Eight aircraft and a complement of 24 officers and 146 enlisted men participated. The major objective of this deployment was to requalify all aircrew in advanced navigation and ordnance delivery.
