NARRATIVE SUMMARY

1. On 1 May 1966, VMFA-542 commenced the third month of its second combat tour in the Republic of South Vietnam. During the month, VMFA-542 flew combat missions in support of the following operations:

Operation GEORGIA
Operation MONTGOMERY
Operation OSAGE
Operation WAYNE

VMFA-542 had two (2) aircraft hit by ground fire during the month of May. Both of these aircraft are repairable at this command.

a. During a scramble in support of a Close Air Support Mission on 12 May 1966, First Lieutenant Thomas E. MULLINS 087869, pilot of WH-6, Bureau Number 151483, received a small arms round in the starboard side windscreen. The aircraft was recovered without further incident.

b. During a scramble in support of a Close Air Support Mission on 18 May 1966, First Lieutenant Charles L. BACON 087298, pilot of WH-9, Bureau Number 151417, received a small arms round in door # 29 left. The aircraft was recovered without further incident.

2. A recapitulation of sorties, hours and ordnance expended follows:



SIGNIFICANT EVENTS

1. CHANGE OF COMMAND

a. On 23 May 1966 Major Paul S. FRAPPOLIO assumed command of VMFA-542 relieving Lt. Col. Eddie E. PEARCY.

2. PERSONNEL


a. One Second Lieutenant, two Master Sergeants, one Sergeant, one Corporal, one Lance Corporal and one Private First Class were promoted to their present ranks during May.

3. AWARDS

a. 28 Air Medals were awarded to Officers of the squadron during May. There were four Meritorious Masts presented to squadron personnel.

4. POLITICAL SITUATION

a. Due to the political situation in South Vietnam and the danger of attack on the base at Da Nang nine (9) aircraft of VMFA-542 were evacuated to UBON AB on 21 May 1966. All aircraft were recovered three days later as the civil situation eased.
