

**AMERICAL DIVISION VETERANS ASSOCIATION (ADVA)
SCHOLARSHIP FUND OPERATING RULES**

PURPOSE

- A. The purpose of the Scholarship Fund is to provide college and vocational scholarships to the children and grandchildren, including those by adoption, of current and deceased ADVA members, provided the deceased member held good membership standing at the time of death, and to any child or adopted child of an Americal Division soldier who was killed or died while on active duty with the Division.
- B. ADVA membership shall be defined in the ADVA Constitution and By-Laws.

TRUSTEES

- A. The Scholarship Fund Committee will be comprised of six (6) Trustees. Trustee/Officers shall be: the ADVA National Commander, who will hold office Ex-Officio, the Fund Chairman, who will be appointed by the National Commander to serve an unlimited term unless replaced by a vote of the Trustees, the Fund Treasurer, who will be appointed by the National Commander to serve an unlimited term unless replaced by a vote of the Trustees, and four (4) other Trustees, who will be elected by the ADVA membership to serve a four (4) year term. A new Trustee will take office each year.
- B. Trustees shall not receive any stated compensation for their services.
- C. Nothing herein shall constitute members of the Trustees as partners for any purpose. No Trustee shall be held liable for the acts or failure to act on the part of any Trustee nor shall any Trustee be liable for his act or failure to act excepting only acts or omissions arising from willful misfeasance.
- D. Nothing herein shall constitute any liability for acts or omissions committed by anyone associated with the Scholarship Fund.
- E. The Scholarship Fund shall use its funds to accomplish the purpose of the fund as specified above.

GOVERNANCE

The Trustees shall direct and control the business management and affairs of the Scholarship Fund. They shall have the authority to approve or deny

any requests for scholarship awards and to recommend dispensing of funds.

SCHOLARSHIP FUNDS

The funds of the Scholarship Fund shall be obtained primarily from donations, grants, gifts, devises, or bequests. All funds received must be unconditional.

MEETINGS

The Trustees shall meet the first day of the Annual ADVA Reunion, or at a date designated by the Chairman, to select recipients for scholarship awards and conduct other Scholarship Fund business.

DUTIES OF TRUSTEES

- A. The Chairman shall preside over all meetings of the Trustees and:
 - 1. Be responsible for publication in the Americal Newsletter, in the October-November-December issue, an announcement of the Scholarship Fund program and information on how to apply.
 - 2. Be responsible for receiving completed applications, verifying the eligibility of each applicant, and arranging for an independent selection team to review all applications.
 - 3. Review selection team results with the other Trustees.
 - 4. Announce the successful applicant's names, scholarship values, and college or institution they will attend at the Annual ADVA Reunion and in the ADVA Newsletter.
- B. The Treasurer shall:
 - 1. Be responsible for the care, safekeeping and accounting of all funds and property of the Scholarship Fund which comes into his possession.
 - 2. Dispense funds as directed for authorized fund expenses. Scholarship awards are to be made payable to the college or institution that each award winner will attend.
 - 3. Issue the annual Scholarship Fund financial report.
- C. The elected Trustees shall:
 - 1. Participate in finalizing the scholarship awards.
 - 2. Oversee the overall operation of the Scholarship Fund.

FINANCIAL

- A. All funds received shall be promptly invested as deemed appropriate by the Trustees.

- B. Any real property received that is not necessary for the operation of the Scholarship Fund shall be converted to cash and handled in the same manner as above.
- C. Scholarship Fund funds shall be audited and reported annually in conjunction with the audit and reporting of rest of the ADVA funds.

AWARDS

- A. The total amount awarded annually for scholarships shall be limited to no more than one-half (1/2) of the yearly income until reaching a balance of \$100,000 in the Scholarship Fund. Thereafter, the total yearly income may be awarded.
- B. The Trustees will decide on the number and dollar amount of scholarships awarded annually. Awards will be merit-based and the complete application package of each qualified applicant will be considered in determining awards.

APPLICATIONS

- A. Completed application forms, together with all required enclosures, as specified on the application form, must be sent to the Fund Chairman at an address he designates and must be postmarked no later than 1 May of each year.
- B. All applications postmarked later than 1 May will be returned.
- C. Scholarships are awarded for one (1) year.
- D. Applicants must file a new application for each successive year.
- E. Scholarships are not awarded for graduate studies.
- F. All applications will be acknowledged.

DISSOLUTION

Should this Scholarship Fund cease to operate, for any reason whatsoever, all of the property of the Scholarship Fund shall be turned over to the ADVA Treasurer.
