

1. (C) SITUATION:

a. Enemy forces.

(1) Current INTSUMS.

(2) Annex A, Intelligence.

b. Friendly forces.

(1) Americal Division continues current operations.

(2) 7th Mar Regt continues current operations.

(3) 198th Inf Bde continues current operations.

(4) 5th ARVN Regt continues current operations.

c. Attachments and Detachments. Task Organization.

d. Assumptions.

(1) Intelligence sources will report locations of US Prisoners of War or suspected PW camps in 196th Bde TAOI.

(2) The enemy will not voluntarily release all Prisoners of War in his control.

2. (S) MISSION:

On order the 196th Bde conducts immediate recovery operations to exploit credible intelligence reports on the location of US Prisoners of War in the 196th Bde TAOI.

3. (S) EXECUTION:

a. Concept of Operation.

(1) Maneuver. Upon receipt of credible and timely intelligence information, giving the locations of US prisoners or PW camps, 196th Bde immediately commences recovery operations. Operations will be directed toward exploitation of the intelligence information with sufficient forces committed or prepared for commitment to insure location and extraction of prisoners. An air cavalry troop with aero rifle platoon will be dispatched immediately to the reported prisoner location to search and gain contact with enemy security units. The Inf Bn in whose TAOI the prisoners are reported will provide one infantry company as a standby reaction force. Reaction force will be prepared for immediate combat assault to assist air cavalry troop in recovery operations. Upon commitment of the reaction force, Bn will assume OPCON of air cavalry troop.

b. 4/31, 2/1, 1/46, 3/21 Inf Bns:

- (1) Continue current operations.
- (2) Provide one rifle company as standby reaction force.
- (3) On order reinforce reaction force with one infantry battalion (-).
- (4) Be prepared to assume command of recovery operations and to receive ORCON of one air cavalry troop.

c. A Co 26th Engr Bn:

- (1) Continue current operations.
- (2) Be prepared to provide an engineer A team for construction of LZ's in support of PW recovery operations.

d. 48th IPSD: Continue current operations.

e. Coordinating Instructions.

(1) This plan is effective for planning upon receipt and execution on order.

(2) This plan gives authority for the conduct of PW recovery operations throughout 196th Bde TAOI only.

(3) Intelligence information concerning location of US PW's will be transmitted to Bde by using FLASH precedence.



1. (C) SUMMARY OF ENEMY ACTIVITY

- a. Current 196th Bde INTSUMS.

c. MACV Specific Intelligence Collection Requirement (SICR), Subject: Prisoner of War Intelligence (U), dated 20 July 1970.

2. (C) ESSENTIAL ELEMENTS OF INFORMATION:

(1) Where are the enemy's Prisoner of War (PW) camps located in the Bde Tactical Area of Interest (TAOI)?

(2) How many prisoners are in the camps? What is their nationality?

(3) What is the NVA/VC policy or guidance on the capture or execution of US personnel?

(1) What security measures does the enemy use for PW camps?

(2) What is the physical plan of the enemy PW camps?

(3) How often are these camps moved? How far?

(4) How accessible are the PW camps to ground forces? Airmobile forces?

(5) What is the availability of landing zones (LZ) near the camps? How many helicopters will each LZ hold?

(6) What is the physical condition of PW's in the enemy camps?

3. (C) INTELLIGENCE ACQUISITION TASKS:

a. Orders to Subordinate and Attached Units. Report as obtained all EEI by the most expeditious means.

b. Request to Higher, Adjacent and Cooperating Units. Appropriate information as it becomes available.
