

PART II

During the month of December 1968, the 9th Engineer Battalion, LtCol D. U. DAVIDSON Commanding, continued as its primary mission the maintenance and upgrading of RVN Route #1 from Chu Lai (BT 520044) to the Song Cau Lau (BT 091554). The maintenance of road networks for the Americal Division, Supply Company (Rein) FLC, plus Engineer Support of Free World Forces in the Chu Lai TAOR continued to require a significant engineer effort.

Company "A" (-), located at Hill #10 (BT 199390), was in the process of maintaining and upgrading RVN Route #1 from (BT 259289) to Thang Binh (BT 175418), a distance of 10 miles. The 2nd Platoon, Company "A" was located on Hill #29. Between Bridge #35 (BT 259289) and Thang Binh (BT 175418), the "A" Company personnel expended 3,252 man hours and 979 equipment hours in hauling and placing 2,402 cubic yards of rock and spreading 29,000 gallons of pentaprime.

Company "B" was located at Chu Lai (BT 520044) and is engaged in vertical construction in that area. It also is paving RVN Route #1 from Chu Lai (BT 520044) to Tam Ky (BT 330209), the "B" Company personnel expended 5,442 man hours and 1,980 equipment hours in spreading 3601 tons of asphaltic concrete. Assisting in the paving operations of personnel from MCB-74. When complete QL-1 will have a 24 foot traveled way $2\frac{1}{2}$ " thick. At the end of this period a total of 4.4 miles conformed to the above standards.

Company "C" is currently upgrading RVN Route #1 from Ky Khoung to Bridge #35 (BT 259289), a distance of 14 miles. Between Chu Lai (BT 520044) and Bridge #35 (BT 259289), the Company "C" personnel expended 7,623 man hours and 1,090 equipment hours in hauling 17,403 cubic yards of rock and spreading 5,200 gallons of pentaprime.

Company "D" continued maintenance and upgrading of RVN Route #1 from Thang Binh (BT 175418) to the Song Cau Lau (BT 091554), a distance of 11.1 miles and engaged in construction in support of Free World Military Forces. Between Thang Binh (BT 175418) and the Song Cau Lau (BT 091554), the Company "D" personnel expended 2,523 man hours and 2,194 equipment hours in hauling 1,737 cubic yards of rock and spreading 11,000 gallons of pentaprime.

In addition to the major road and bridge work being done on RVN Route #1 the 9th Engineer Battalion was responsible for the repair and maintenance of other sections of road as shown below:

Company "B" maintains from BT 325180 to BT 330207 a distance of 2 miles for CAP Unit 1-1-2/1-1-3, also Route #22 West from BT 512053 to BT 493037 and Route #22 East from BT 538027 to BT 549049, a distance of 2.2 miles.

Company "C" continued the maintenance of 2.0 miles of roadway within the Supply Company (Rein) FLC-C (BT 532111) and the maintenance of 3.5 miles of roadway within the Supply Company (Rein) FLC ASP (BT 550044).

Headquarters Company Heavy Equipment Platoon retained the responsibility for the maintenance and repair of the Americal Perimeter Road (BT 521071)-(BT 519049) a distance of 8.5 miles. The Platoon is also responsible for upgrading 300 meters of road for MAG-13, and resurfacing roads in the MAG-12 area.

Since 1 December 1968, the 9th Engineer Battalion has provided the following additional Engineer Equipment Support for the U. S. Army, U. S. Navy, U. S. Marine Corps and the Korean Marine Corps units within its area of responsibility.

2 December 1968 "A" Company sweep team found a 10 lbs nitrostarch mine with a pressure type firing device. Disarmed mine and returned it to CP.

6 December 1968 "D" Company sweep team discovered two sand piles at BT 154447. These were 2' high by 2' wide the width of road. composed of scrap-metal also warning signs were found. Obstacle removed.

10 December 1968 "D" Company sweep team found dirt barricade 3' wide across road at BT 154557. Obstacle was removed.
"D" Company platoon working on Song Ba Ren bridge received 50 rounds small arms fire. Fire was returned with unknown results.

11 December 1968 "D" Company medevaced one VN female who swallowed rat poison at BT 103512.

14 December 1968 "A" Company sweep team found a 80 lbs nitrostarch mine. Mine blown in place.

15 December 1968 "A" Company sweep team found boobytrapped M-26 grenade at BT 177419. Grenade blown in place.
"D" Company sweep team was attacked by 1-155 round, 2-105 round command detonated. Negative casualties. Wires traced to a concealed position 250 meters from road.

16 December 1968 "C" Company sweep team received small arms fire from 873 RF Company security located at BT 259286. Sweep team leader disarmed RF No. "D" Company sweep team found bamboo barricade across road at BT 093544. Barricade removed.
"A" Company sweep team reported VC unsuccesful in attempt to blow bridge at BT 225347. Two PF's were wounded in the fire fight.
"A" Company sweep team called in dustoff for two wounded ARVN's at BT 205376.

17 December 1968 "D" Company platoon working on Song Ba Ren received 30 rounds small arms fire. Returned fire. Negative casualties.
"D" Company sweep team found Vietnamese sign on pole in center of road. Removed sign with grappling hook.

18 December 1968 "A" Company sweep team discovered bridge located at BT 219359 15% destroyed. 9th Engineer Bn tractor and trailer hit mine at BT 275265. Negative casualties both vehicles damaged.

"A" Company vehicle assisting in the above incident hit mine 10 meters from the first one. One USA, one USMC minor wounds. Sweep team discovered another mine at the same location. Mine blown in place. Units adjacent to 9th Engineer CP received rocket rounds. They called in illumination, several illumination canisters landed in 9th Engineer CP causing minor damage to one Sea Hut and one 2½ ton trailer.

19 December 1968 "D" Company sweep team called in medevac for 7 VN personnel with shrapnel wounds at BT 102515.

873 RF Company refused to provide proper flank security for "C" Company sweep team at BT 279255.

21 December 1968 "A" Company sweep team received 1 round of sniper fire at BT 248308. Negative casualties. "A" Company called in medevac for 3 PF wounded with shrapnel at BT 198389.

873 RF Company refused to provide proper security for "C" Company sweep team at BT 282251.

22 December 1968 "A" Company sweep team found culvert blown at BT 181411. Requires 5 loads of fill to repair.

25 December 1968 873 RF Company failed to provide proper flank and point security for "C" Company minesweep. Pentaprime on Hill #29 caught fire 70 barrels burned. Fire caused by pop flare landing among the barrels.

26 December 1968 VN Civilian dropped M-79 round that he was turning in to "A" Company sweep team at BT 220358. Round detonated causing 1 VN KIA, 2 VN WIA's, and 2 USMC WIA. Medevac called in.

28 December 1968 "D" Company called in medevac for ARVN hurt in traffic accident at BT 103512.

"A" Company received sniper fire at BT 219359. Fire was returned; security set up. Negative casualties.

30 December 1968 "D" Company discovered culvert blown at BT 117492. Charge was an artillery round rigged as demolitions. One load of fill needed to repair.

31 December 1968 1/1 Cav unit declined to provide proper security in accordance with orders from their squadron at BT 198389.

"D" Company found dirt barrier four feet high across road at BT 155447. Barrier was removed.

"D" Company found culvert blown at BT 119489. Charge was estimated 70 lbs requires 105 loads of fill to repair.
