

PART II

During the month of January 1969, the 9th Engineer Battalion, LtCol D. U. DAVIDSON Commanding, continued as its primary mission the maintenance and upgrading of RVN Route #1 from Chu Lai (BT 520044) to the Song Cau Lau (BT 091554). The maintenance of road networks for the Americal Division, Supply Company (Rein) FLC, plus Engineer Support of Free World Forces in the Chu Lai TAOR continued to require a significant engineer effort.

Company "A" (-), located at Hill #10 (BT 199390), was in the process of maintaining and upgrading RVN Route #1 from Tam Ky to Thang Binh (BT 175418), a distance of 14 miles. Between Tam Ky and Thang Binh (BT 175418), the "A" Company personnel expended 2,417 man hours and 912 equipment hours in hauling and placing 1,317 cubic yards of rock, 1,352 cubic yards of sand and spreading 6,000 gallons of pentaprime.

Company "B" was located at Chu Lai (BT 520044) and is engaged in vertical construction in that area. It also is paving RVN Route #1 from Chu Lai (BT 520044) to Tam Ky (BT 330209), the "B" Company personnel expended 7,431 man hours and 2,250 equipment hours in spreading 7,130 tons of asphalt concrete. Assisting in the paving operations were personnel from MCB-74. When completed QL-1 will have a 24 foot traveled way 2 $\frac{1}{2}$ " thick. At the end of this period a total of 7.6 miles conformed to the above standards.

Company "C" Motor Transport is currently upgrading RVN Route #1 from Ky Khoung to Tam Ky a distance of 5 miles. Between Chu Lai (BT 520044) and Tam Ky (BT 300209), the Company "C" personnel expended 5,441 man hours and 1,728 equipment hours in hauling 12,543 cubic yards of rock, 3,806 cubic yards of sand and spreading 32,000 gallons of pentaprime.

Company "D" continued maintenance and upgrading of RVN Route #1 from Thang Binh (BT 175418) to the Song Cau Lau (BT 091554), a distance of 11.1 miles and engaged in construction in support of Free World Military Forces. Between Thang Binh (BT 175418) and the Song Cau Lau (BT 091554), the Company "D" personnel expended 3,009 man hours and 1,124 equipment hours in hauling 1,601 cubic yards of rock, 261 cubic yards of sand and spreading 1,430 gallons of pentaprime.

Company "B" maintains from BT 325180 to BT 330207 a distance of 2 miles for CAP Unit 1-1-2/1-1-3, also Route #22 West from BT 512053 to BT 493037 and Route #22 East from BT 538027 to BT 549049, a distance of 2.2 miles.

1. Civic Action

During the month of January, this command treated 584 Vietnamese men, women and children on the MEDCAP Program. Also immunizations and innoculations against cholera, plague and tetanus, were given to the children and nuns of the "New Life Catholic Orphanage" in An Tan. Movies were shown twice during January in conjunction with the 7th Psy-Ops Battalion, Psy-Ops Team, U. S. Army.

3 January 1969 "D" Company sweep team found hole blown in road at BT 157445.
"A" Company sweep team found a 20 lb. pressure type mine in road at BT 122486. It was removed with a grappling hooks and destroyed.
4 January 1969 "D" Company sweep team received 50 to 60 rounds small arms fire 200 meters from LZ Baldy. Two USMC WIA'S, two VC suspects captured.
6 January 1969 At BT 093543 Commanding Officer 7th Engineer Battalion was ambushed by command detonated mine. Negative casualties.
8 January 1969 "A" Company sweep team received one round sniper fire at BT 296254. Fire was returned and sweep continued.
11 January 1969 "D" Company sweep team found rock and bamboo barricade across road at BT 101517. Barricade was removed.
13 January 1969 "D" Company sweep team found 15 lb. mine on west side of road at BT 120487. Mine was destroyed.
"D" Company sweep team found 20 lb. mine in road at BT 118480. Mine was destroyed.
14 January 1969 "D" Company sweep team found crater blown in road at BT 093535. It required 2 loads of fill.
15 January 1969 "D" Company sweep team triggered a booby-trapped grenade at BT 167423. One USA and one USMC WIA.
"A" Company sweep team found ammo can booby-trapped with M-26 grenade at BT 217357. It was destroyed in place.
16 January 1969 "D" Company sweep team blew in place a 20 lb. mine at BT 106504. This mine was pointed out by a VN Civilian.
"D" Company sweep team found 30 lb. command detonated mine at BT 093534. Wires led 100 meters west of road. Mine was destroyed.
17 January 1969 "D" Company sweep team medevaced a VN Civilian suffering from shrapnel wounds at BT 102510.
19 January 1969 "A" Company sweep team found three 15 lb. mines in road at BT 282246. All mines were burned.

20 January 1969 "D" Company sweep team found a 13 year old civilian with six M26 grenades, one M33 grenade and other assorted military gear. I.D. card believed to be false. He was turned over to U.S. Army authorities at BT 136472.
"A" Company sweep team found one 20 lb. concrete mine in road at BT 282246. Mine was burned in place.
"D" Company sweep team brought wounded VN boy to Hill #63 hospital. He was suffering from shrapnel wounds.
"D" Company rock crusher site at BT 110430 received 250 to 300 small arms fire. In the ensuing fire fight, USA and USMC personnel killed two V.C., four V.C. probable KIA's, and three PW's.

21 January 1969 "D" Company sweep team found barricade at BT 119489. Barricade was composed of rocks, dirt, pieces of culverts, and tree limbs. Sweep team removed barricade.

22 January 1969 "D" Company sweep team found culvert blown at BT 119429. It required 3 loads of fill.

23 January 1969 A VN civilian tripped a booby trapped grenade at BT 102515. Two VN civilians KIA, 16 VN civilians WIA.

24 January 1969 "A" Company sweep team found 40 lb. nitrostarch pressure detonated mine at BT 268274. Mine was blown in place.

27 January 1969 "A" Company sweep team found one booby trapped M79 round on side of road at BT 246308. It was blown in place.

31 January 1969 "D" Company sweep team received sniper fire at BT 099519. One VN civilian male was killed.
