

PART II

1. During the month of February 1969, the 9th Engineer Battalion, LtCol D. U. DAVIDSON Commanding, continued as its primary mission the maintenance, upgrading, and asphaltic paving of RVN Route #1 from Chu Lai (BT 520044) to the Song Cau Lau (BT 091544). Engineer support of Free World Forces in the Chu Lai TAOR continued to require a significant engineer effort.
2. Company A (-), located at Hill #10 (BT 199390) was engaged in the process of maintaining and upgrading RVN Route #1 from Tam Ky (BT 330209) to Thang Binh (BT 175418), a distance of 14 miles.
3. Company B was located at Chu Lai (BT 520044) and is engaged in vertical construction in that area. It also carries the Battalion's primary task of paving RVN Route #1 from Chu Lai (BT 520044) to Tam Ky (BT 330209).
4. Company C (-) Command Post was located in the 7th Engineer Battalion Compound, Danang, RVN. The company is engaged in directsupport vertical construction for the 1st Marine Division. The Motor Transport/Heavy Equipment section is located in Chu Lai, RVN (BT 520044) and is currently upgrading RVN Route #1 from Phu Khe (BT 368184) to Tam Ky (BT 330209).
5. Company D, located at Landing Zone Baldy (BT 136448) continued maintenance and upgrading of RVN Route #1 from Thang Binh (BT 175418) to the Song Cau Lau (BT 091554) a distance of 11.1 miles and engaged in construction in support of Free World Military Forces.
6. During the month of February, upgrading and repair of RVN Route #1 was broken down into three main areas of responsibility: Chu Lai to Tam Ky; Tam Ky to Thang Binh; and Thang Binh to the Song Cau Lau.
7. Between Chu Lai (BT 520044) and Tam Ky (BT 330209), elements of C Company, and Service Company expended 3,794 man hours and 2,016 equipment hours in hauling 8,684 cubic yards of rock, 7,081 cubic yards of sand, and 5,310 cubic yards of laterite.
8. In this same Area of Operations, Company B personnel expended 5,587 man hours and 2,093 equipment hours in paving RVN Route #1

from Chu Lai (BT 520044) to Phu Khe (BT 368184) spreading and compacting 6,610 tons of asphaltic concrete. Assisting in the paving operations were personnel from MCB-58. When completed RVN Route #1 will have a 24 foot traveled way 2½ inches thick. At the end of this period a total of 11.5 miles conformed to the above standards. In addition to paving, Company B hauled 3,150 cubic yards of rock in the upgrading of RVN Route #1 and spread 22,700 gallons of MC 250/RC800 in priming for asphaltic paving.

9. Between Tam Ky and Thang Binh, Company A personnel expended 2,075 man hours and 1,226 equipment hours in hauling and placing 862 cubic yards of rock, 4,476 cubic yards of sand and spreading 7,100 gallons of peneprime.

10. Between Thang Binh and the Song Cau Lau, Company D personnel expended 2,186 man hours and 1,288 equipment hours in hauling 868 cubic yards of rock, 235 cubic yards of sand, 1,579 cubic yards of laterite, and spreading 9,000 gallons of peneprime.

11. All upgrading in the assigned areas will conform to MACV standards for military roadway. Materials are provided from quarries operated in Chu Lai by RMK-BRJ, laterite and sand pits operated by the 9th Engineer Battalion at Hill #54 and a newly opened rock crusher site (BT 109429) operated by Company D, 9th Engineer Battalion.

12. During the month of February, 9th Engineer Battalion installed the following culverts, which required 26 feet of 60 inch, 96 feet of 48 inch, 250 feet of 36 inch, 100 feet of 18 inch, and 50 feet of steel plate arch culvert.

13. In addition to the major road and bridge construction being done on RVN Route #1, the 9th Engineer Battalion was responsible for the repair and maintenance of other sections of road as shown below:

a. Headquarters Company Heavy Equipment Platoon retained the responsibility for upgrading the CP roads in the MAG-12 and MAG-13 areas.

b. Company B maintains from BT 325180 to BT 330207, a distance of 2 miles for CAP Unit 1-1-2/1-1-3; also Route #22 West from BT 512053 to BT 493037 and Route #22 East from BT 538027 to BT 549049, a distance of 2.2 miles.

14. Since 1 February 1969, the 9th Engineer Battalion has provided the following additional Engineer Support for the U. S. Army, U. S. Navy, U. S. Marine Corps, and the Korean Marine Corps units within its area of responsibility.

Movies were shown on three occasions and four propaganda broadcasts were conducted in conjunction with the 7th Psy-Ops Battalion, 1st Psy-Ops Team, U. S. Army, in the Binh Sa and Tich Tay areas.
