

PART II

1. During the month of March 1969, the 9th Engineer Battalion, LtCol D. U. DAVIDSON Commanding 1-20 March 1969 and LtCol B. F. VISAGE Commanding 20-31 March 1969, continued as its primary mission the maintenance, upgrading, and asphaltic paving of RVN Route #1 from Chu Lai (BT 520044) to the Song Cau Lau (BT 091544). Engineer Support of Free World Forces in the Chu Lai TAOR continued to require a significant engineer effort.
2. Company A (-), located at Hill #10 (BT 199390) was engaged in the process of maintaining and upgrading RVN Route #1 from Tam Ky (BT 330209) to Thang Binh (BT 175418), a distance of 14 miles.
3. Company B was located at Chu Lai (BT 520044) and is engaged in vertical construction in that area. As of 14 March 1969 the Company completed its primary task of paving RVN Route #1 from Chu Lai (BT 520044) to Tam Ky (BT 330209). The Heavy Equipment/Motor Transport Platoon is now part of a task organized element currently upgrading and paving RVN Route #1 from Tam Ky (BT 330209) to Hill #10 (BT 196391) and is responsible for maintaining RVN Route #1 from Chu Lai (BT 520044) to Tam Ky (BT 330209).
4. Company C (-) Command Post was located in the 7th Engineer Battalion Compound, Danang, RVN. The company is engaged in direct support vertical construction for the 1st Marine Division. The Motor Transport/Heavy Equipment section is located in Tam Ky, RVN (BT 294232) and is currently upgrading RVN Route #1 from Tam Ky (BT 312227) to Hill #10 (BT 196391).
5. Company D, located at Landing Zone Baldy (BT 136448) continued maintenance and upgrading of RVN Route #1 from Thang Binh (BT 175418) to the Song Cau Lau (BT 091554) a distance of 11.1 miles and engaged in construction in support of Free World Military Forces.
6. During the month of March, upgrading and repair of RVN Route #1 was broken down into three main areas of responsibility: Chu Lai to Tam Ky; Tam Ky to Thang Binh; and Thang Binh to the Song Cau Lau.
7. Between Chu Lai (BT 520044) and Tam Ky (BT 330209), elements of C Company, and Service Company expended 3,482 man hours and 1896 equipment hours in hauling 6120 cubic yards of rock, 416 cubic yards of sand, and 3814 cubic yards of laterite.

8. In this same Area of Operations, Company B personnel expended 3779 man hours and 1901 equipment hours in paving RVN Route #1 from Phu Khe (BT 368184) to Tam Ky (BT 330209) spreading and compacting 5710 tons of asphaltic concrete. Assisting in the paving operations were personnel from MCB-58. When completed RVN Route #1 will have a 24 foot traveled way $2\frac{1}{2}$ inches thick. At the end of this period a total of 13.5 miles conformed to the above standards. In addition to paving, Company B hauled 1300 cubic yards of rock in the upgrading of RVN Route #1 and spread 12,750 gallons of MC 250/RC 800 in priming for asphaltic paving.

9. Between Tam Ky and Thang Binh, Company A personnel expended 2219 man hours and 1358 equipment hours in hauling and placing 4487 cubic yards of rock, 6148 cubic yards of sand, 4978 cubic yards of laterite, and spreading 6600 gallons of peneprime.

10. Between Thang Binh and the Song Cau Lau, Company D personnel expended 1148 man hours and 786 equipment hours in hauling 335 cubic yards of sand, 753 cubic yards of laterite, and spreading 19,800 gallons of peneprime.

11. All upgrading in the assigned areas will conform to MACV standards for military roadway. Materials are provided from quarries operated in Chu Lai by RMK-BRJ, laterite and sand pits operated by the 9th Engineer Battalion at Hill #54, a newly opened rock crusher site (BT 109429) operated by Company D, and a newly opened borrow pit in Tam Ky (BT 290233) operated by the 9th Engineer Battalion.

12. During the month of March, 9th Engineer Battalion installed the following culverts, which required 50 feet of 24 inch, 50 feet of 36 inch, and 64 feet of 18 inch culvert.

PART III

Sequential Listing of Significant Events

1. Civic Action.

a. During the month of March 1969 this command was assigned a new area of responsibility for Civic Action, this being Ky Lien Village. Since being assigned this area of responsibility, the Civic Action team, drawing support from Engineer Capabilities within the Battalion, has assisted in construction of three schools, two temples, and various small projects including the provision of scrap lumber. A team of twenty volunteer Marines participates every Sunday afternoon in a Boy Scout program dealing with Vietnamese boys aged 7 to 17 years.

b. The MedCap team as an integral part of the Civic Action operation treated 445 Vietnamese men, women, and children within the new A. O.. This team has inoculated 100 children against cholera, tetanus, and smallpox at the New Life Catholic Orphanage in An Tan.

c. The local villagers have been the recipient of three movies and seven propaganda broadcasts supplied to this unit by the 7th Pay-Ops Battalion, Psy-Ops Team, U. S. Army.

3. Engineer Operations.

a. 1 March 1969.

(1) D Company sweepteam found a wire barricade in roadway at BT 094544. The obstacle was removed and the area swept with negative results.

(2) The Song Ba Ren Bridge within the D Company TAOR received five rounds of 82mm mortar fire, six rounds of B-40mm rocket fire. This resulted in two ARVN KIAs, two ARVN WIAs.

(3) A Company sweepteam found one 20 pound nitro-starch mine buried in roadway at BT 273267. Mine was removed and destroyed.

(4) D Company sweepteam found 2'x4' crater in roadway at BT 101517. Obstacle filled in and road immediately passable.

(5) A Company sweepteam found one 20 pound nitro-starch mine in roadway at BT 274268. Mine was removed and destroyed.

(6) USMC M-51 Dump Truck detonated mine between asphalt and shoulder of roadway at BT 406134. Roadway reswept with negative results and road repaired.

(7) VC destroyed VN flag with flagstaff erected by D Company at BT 101516. Area swept with negative results.

(8) D Company sweepteam received three rounds sniper fire with no known friendly or enemy casualties.

(1) A Company sweepteam repaired large hole in roadway at BT 258289. Hole believed to have been caused by U.S.A. tank retriever.

(2) U.S.A. towed trailer detonated mine in roadway at BT 261285, negative casualties. Area reswept with negative results.

d. 4 March 1969.

(1) 9th Engineer Battalion Radio Relay station received five 122mm rocket rounds at BT 238317. Negative friendly casualties.

(2) A Company sweepteam encountered large crater, believed to be caused by shell burst in roadway, at BT 236327. Roadway immediately repaired.

e. 5 March 1969.

(1) D Company sweepteam delayed by fire fight at BT 093544 negative friendly casualties.

(2) D Company encountered propaganda leaflets in English and Vietnamese. Area policed up and swept with negative results.

(3) A Company sweepteam found one M-79 round pointed out by VN civilian.

f. 6 March 1969.

(1) VN civilian truck detonated mine at BT 119489. There was one ARVN WIA. Road repaired and truck removed from traveled way.

(2) MRS-200 detonated 40 pound mine in roadway at BT 248308. One USMC WIA. Area reswept with negative results and roadway repaired.

g. 7 March 1969.

(1) VN civilian vehicle detonated mine in roadway at BT 248308. Negative casualties. Area reswept with negative results and road way repaired.
