PART IINARRATIVE SUMMARY

1. During May 1970, the 9th Engineer Battalion was under the command of Lieutenant Colonel John P. KRAYNAK. The Battalion continued its primary mission of maintenance and upgrade of Vietnam Route #1 from Tam Ky (BT293240) north to the Ly Ly River (BT145457), and deliberate minesweeps from the end of the pavement to the Song Ba Ren Bridge (BT102510). The Battalion continued engineer support to the Free World Forces in the northern Americal Division area of operations. The Battalion has also been assigned new projects in the First Marine Division area of operations.

2. Company "B", located at Hill #10 (BT196389), continued their primary mission of minesweeps, and maintenance and upgrade in the preparation for asphaltic paving of Vietnam Route #1 from the end of the pavement to the Ly Ly River, a total of approximately 8 miles. The company continued construction support to the Free World Forces throughout their area of operations.

3. First Platoon, Company "C" turned the Chu Lai compound over to Americal Division and rejoined Company "C" in the Battalion Compound at DaNang (BT981746) on 16 May 1970. The company's primary mission continued to be hauling base rock in preparation for asphaltic pavement of Vietnam Route #1 from the end of the present pavement to the Ly Ly Bridge.

4. Company "D" located at Landing Zone Baldy (BT136448) continued the primary mission of daily minesweeps on Vietnam Route #1 from the Ly Ly Bridge north to the Song Ba Ren Bridge (BT102510) a distance of 4.8 miles, and haul support from the end of the pavement to the Ly Ly Bridge. The company also has the responsibility for material and haul support to the 10th ARVN Group on Route #535, and continued engineer support to Free World Forces throughout their area of operations.

5. During the month of May 1970, the Battalion continued to stress its primary missions of minesweeps, upgrading and haul support to Vietnam Route #1.

a. The upgrading and maintenance tasks on QL-1 were concentrated toward support of MCB-7, USN in preparation for paving of with asphaltic concrete from the end of the present pavement to the Ly Ly Bridge.

b. During the reporting period, the following mineral products were emplaced on QL-1 in accordance with assigned tasks from Tam Ky to the Ba Ren Bridge: 5414 tons of two inch minus base rock placed on QL-1, 3100 tons of two inch minus hauled to the stock pile at MAT-8 in support of QL-1, 70 tons of asphaltic concrete in support of MCB-7 for paving of QL-1.

6. The Second Provisional Land Clearing Company, with the following supporting security, the company itself consisting of elements of 7th and 9th Engr Bn's FMF, and elements of 26th and 39th Engr Bn's, USA, with the command group from 9th Engr Bn, was disbanded on 27 May 1970 in accordance with CG XXIV Corps msg 271605Z May70.

d. 09 May 1970

(1) 090325H at BT514041 2nd Flt Company "C" Battalion Rear in Chu Lai observed four figures approaching, compound held fire, figures veered off, disappeared. Chu Lai Defense Command notified.

(2) 090920H at BT108504 Company "D" Sweep Team medevaced one Vietnamese civilian with shrapnel wounds to RAS at Hill #63 by M-51.

(3) 090935H at BT104508 Company "D" Sweep Team picked up one PF with gun shot wounds, medevaced by M-51 to RAS Hill #63.

e. 10 May 1970

(1) 100750H at BT132474 Company "D" Sweep Team reported Vietnamese civilian truck hit mine, resulting in 2 civilian KIA. Estimate 60lb explosive in mine. Local PF's took charge of casualties.

(2) 100950H at BT102509 Company "D" Sweep Team picked up four Vietnamese civilians, two females, two males with shrapnel wounds, medevaced to Hill #63 RAS by M-51.

(3) 101554H at BT181506 Land Clearing Company reported USA security personnel tripped a M-26 SFD; one USA WIA, medevac called.

f. 11 May 1970

(1) 110735H at BT230370 Company "B" Sweep Team reported four civilians brought to team with shrapnel wounds; medevac called.

(2) 110845H at BT177416 Company "B" Sweep Team found 1 - 51b nitro starch box mine with wooden pressure plate in middle of road, blown in place road repaired.
