2. Commander's Narrative Summary of Significant Events

The Advance Party of the Battalion, under Major J. C. FLOYD, S-2/3, flew into Vietnam on 23 May 1966. The next element to arrive was part of Service Company aboard USS Mathews, AKA-96, on 27 May 1966. The Battalion Headquarters, Headquarters Company and Company B plus elements of Service Company and Company D arrived on 6 June 1966 aboard USS Ogden, LPD-5.

Companies A and C arrived on 15 June 1966 aboard USS Gunston Hall, LSD-5, and USS Fort Marion, LSD-22. Company D (-) arrived on 17 June 1966 aboard USS Stone County, LST-1141.

Company A reembarked on 25 June and proceeded to Da Nang under OPCON 7th Engineer Battalion. The remainder of the Battalion is OPCON III MAF, ADCON 1st Marine Division (REIN).

The Advance Party picked the Battalion camp site from two areas which were available, and had the camp laid out by the time the main body arrived. Work began immediately to make the area, colloquially known as the "Gobi Desert", into a home for the Battalion. The camp was located just west of Route 1 approximately a quarter-mile southeast of the Chu Lai "New Life" village. The area is covered with a fine white sand.

Concurrent with camp construction, equipment and personnel were gradually but increasingly absorbed by outside projects and work orders. By the end of the third week in June the Battalion was fully employed, with the vast majority of its efforts being spent in support of the 1st Marine Division (REIN).

091000	June 1966	Coordinated defense with 11th Marines and 2nd Battalion, 7th Marines.
14-19	June 1966	1stLt KOSCIW and SSgt SMITH flew to Okinawa in connection with ADM.
151530	June 1966	Companies A and C arrived and disembarked.
160730	June 1966	FMFPAC Engineer Officer visited CP.
170843	June 1966	One platoon of Company B put in a five ponton ferry across VINH AN River (BT 378175) while another platoon of Company B installed a treadway on the bridge across TRAU River (BT 430109)
171100	June 1966	Company D arrived in Battalion area after debarking
18-21	June 1966	Installed tramway at (BT 378174)
19-20	June 1966	Detachment Company C constructed a 38'-4" fixed balk bridge at BT 219359 (16 km northwest of Tam Ky) in support of OPERATION KANSAS.
20	June 1966	Company B began improvement of Route 1 from Route 20 north to TAOR.
20	June 1966	Began pre-cutting and stockpiling of cantonment materials for other units.
21	June 1966	Constructed three ponton ferry across TRAU River (BT 430109) when existing bridge collapsed under 155 Gun (SP).
22-23	June 1966	Converted railroad bridge across TRAU River (BT 430109) for vehicle Traffic.

241000 June 1966 Cut the fence in Company B area to allow five Vietnamese to exhume and move a body from a grave inside the perimeter.

251800 June 1966 Company departed aboard USS Summit County, LST 1146, ETA Da Nang 260600H.

291130-1700 June 1966 Airfield reconnaissance team made recon of QUANG NGAI airfield for Joint Airfield Survey Team, at III MAF's request.
