		Summary 6 Sept 69:					
		Security of QL #1 by B & D Companies and Recon platoon continued. All convoys are cleared of highway by 1700 hrs, 2nd & 3rd platoon, minus one squad to secure heavy packs moved to bridge 104 and prepared for a combat assault. At 1800 hrs the 2nd & 3rd Platoons & the 1st Co CP along with 6 Duc Pho Provincial Reconnaissance Unit personell and three advisors combat assualted into a three sepearte landing zones in vicinity of 885309. The LZ was not fired on by artillery prior to landing of helicopter.

Summary 6 Sept 69 (cont'd)

Movement of indigenous personnel on the ground indicated complete surprise. The LZ was cold (no hostile fire) and the PRU personnel moved in rapidly as the two rifle platoons, established a cordon of the target hamlet. Two Viet Cong Infostures were captured. Negative friendly or enemy casualties. A Troop 1/1 Cav was placed OPCON to the Battalion and were on stand by to react if a reported NVA platoon (28 men) were in the area. and heavy contact was made. H Troop night logged at the base of FSB Debbie.
