1. Co A: Continue to secure IZ WEST; conduct search and destroy operations in assigned area (ANNEX A, Operations Overlay).
2. Co B: Attack in zone from generally West to East to PL BLUE; direct coordination is authorized and directed with Co C/4-31 in order to move "on line" and to facilitate artillery support; upon completion of attack to PL BLUE (ANNEX A, Operations Overlay) move back to area of night defensive activities (ANNEX B, Night Activities).
3. Co C: Co (-) attack in zone from generally West to East to PL BLUE; direct coordination is authorized and directed with Co B/4-31 in order to move "on line" and to facilitate artillery support; upon completion of attack to PL BLUE (ANNEX A, Operations Overlay) move back to area of night defensive activities (ANNEX B, Night Activities); 1 plat/Co C upon release from defense of IZ SIBERIA, airlift to HIEP DUC Soccer Field and proceed to attack and secure OBJ X (ANNEX A, Operations Overlay), and link up with parent unit upon return of Co (-) to night defensive positions.

1. Co A/4-31: Conduct airlift from PZ (LZ WEST) to LZ Y at time TBA and in conjunction with Co C/2-1, sweep along assigned route to secure OBJ A (ANNEX A, Operations Overlay).
2. Co C/2-1: Support by fire link up of Co A/4-31 with Co C/2-1, and in conjunction with Co A/4-31, sweep along assigned route to secure OBJ B (ANNEX A, Operations Overlay).
