AT YOUR SERVICE

Q. I was told recently discharged veterans have 120 days after separation to convert their servicemen's Group Life Insurance. Does that mean they have no coverage between time of separation and actual date of conversion?

A. The group term-coverage automatically continues for 120 days after discharge with no cost to the insured, with one exception. Veterans who are totally disabled at separation have up to one year while still totally disabled to convert their SCLI.

A PILL A DAY KEEPS \_\_\_\_\_ AWAY!

ARMY WARNS THAT BAD DISCHARGES REALLY ARE.

WASHINGTON (UPI)---The Army warned Thursday against a rising tide of rumors that a soldier can misbehave to get out of the Army early with a less-than-honorable discharge, then have his record cleared easily by congressional pressure or by paying a lawyer \$500.

"These are absolutely false rumors," one high-ranking official said. "Too many of our youngsters are listening to the ill-informed coffee house speakers or to the 'guardhouse lawyers,' rather than to the properly constituted authorities who have the right answers."

Officials said the rumors first appeared about a year and a half ago and have since spread to U.S. military installations all over the world.

"Reports from the legal officers in the field indicate that many soldiers are laboring under the mistaken impression that it is fairly easy to have the character of an unfavorable discharge changed following separation from the service," one official said.

"Rumors are circulating that it is easy to have a discharge changed (to honorable status) if a member of Congress intercedes or if a fee of \$500 is paid, or if one waits six months at which time unfavorable discharges will automatically be changed to honorable."

On the contrary, officials said it is rare that an unfavorable discharge is ever changed to honorable. They said congressional pressure makes no dif-

ference, that there is no automatic change after any period of time and that hiring a private lawyer provides no guarantee of favorable appeal action.

Appeals are allowed for 15 years from the time of separation from the service, they said. But appeals are considered only when there is evidence of fraud or improper procedure, or when policies underwhich the original discharge was issued have changed.

Of the 1,688 appeals considered in 1969 by the Army Discharge Review Board, only 79 were changed to honorable and only 114 were changed to the somewhat less desirable category of general discharges. There were almost 20,000 discharges of less than honorable status issued by Army boards during that period, and another approximately 15,000 bad conduct or dishonorable discharges ordered by courts martial.

Officials said a soldier who fails to get an honorable discharge may later find himself unable to obtain the job he wants or get a promotion because of his record.

NEW YORK (S&S)---Vietnam based troops may now include Chicago and New York as destinations in their "Operation Reunion" 14-day leave plans. United Service Club, which last week announced a lowcost round-trip fare between Vietnam and the west Coast, has now completed arrangements with Pan American for flights to Chicago and New York, and hopes to announce soon a furtherextension to Atlanta.

The round-trip fare to Chicago will be \$442 and to New York \$479. The west coast fare is \$369. All fares include United Services Club membership, one nights lodging in the U.S., a stateside meal and transportation to ongoing travel connections. Soldiers who do not wish the ground accomidations will get a refund of about \$15.

Gen Creighton Abram's original plan for "Operation Reunion" was to permit troops in Vietnam with more than four months but less than eight to fly " space available

to the west coast provided they could show a confirmed return reservation via commerical aircraft. The commerical economy fare, Los Angles to Saigon, is \$510, one way.

It soon became evident that "space available" could accomidate only a small percentage of those desiring stateside leave, whereas USC and Pan American teamed up to offer the lowest flights.

Travelors may purchase there roundtrip tickets at any of 20 Pan American ticket offices in Vietnam, or there famlies may purchase an open-date ticket at any Pan Am office in the U.S. for transmittal to the soldier, who then would work out a firm date with the nearest ticket office.

Trips tp all three areas will start next week. A USC spokesman estimated there would be more than 100 flights during December, each plane carrying from 180-250 passengers.
