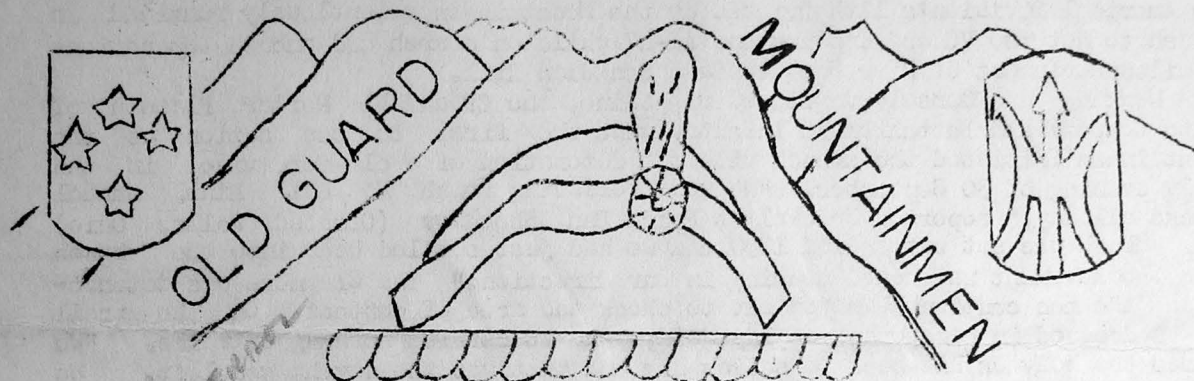

The Old Guard Mountainmen wish to take this opportunity to welcome Lieutenant Colonel Albert F. Coast to the 4th Battalion 3d Infantry. LTC Coast took command of the 4th Battalion 3d Infantry on October 5, 1970, with 15 years of experience and prior service.

AMBUSHES PAYOFF FOR DELTA

The swift rains of the beginning of monsoon didn't stop the Infantrymen of the Americal Division's 11th Brigade as the Mountainmen relentlessly remained in ambush to net two VC and capture one AK-47 while on search and ambush operations 11 miles northwest of Fire Support Base San Juan Hill.

Working on a densely vegetated ridgeline, the CP and 81 Mortar Platoon of Delta Company 4th Battalion 3d Infantry were the first to see action as the Mountainmen initiated the ambush with the detonation of a claymore mine, in the early evening of 30 September. "We were following fresh Ho Chi Minh sandal tracks all day," reported Specialist Four Dan Shockley (Olmsted Falls, Ohio) "The ambush was set out around 1730 and we had just settled back into the brush when the movement was heard coming in our direction." The Claymore was detonated and the men cautiously moved out to check the area of contact. On the trail one VC, dressed in black pajamas lay dead, the VC carried nothing of value. "We turned the body on his back to search him and that was the way he was left. We moved back into the ambush position and heard nothing the rest of the night. The next morning the body was turned over on his stomach with his hands spread under him. We didn't move him because we were afraid someone may have booby-trapped the body during the night," added Specialist Shockley.

The First Platoon of Delta Company set their ambush about the same time as the CP and 81's did but did not see action until late that night. Working the same ridgeline about 500 meters below the CP group the darkness of the night shook with the detonation of a claymore mine. The area could not be checked out until early the next morning so the men waited restlessly through the night. When first light arrived the men moved to check out the area of contact. To their surprise nothing was found on the trail. "It was raining pretty hard so that (Continued on page 4, Column 1)

BRAVO FINDS BASE CAMP

Enemy base camps whether old or new are plentiful in the AO of the 11th Brigades 4th Battalion 3d Infantry. Most are small with a few bunkers and hooches. Recently, however the members of Bravo Company came across an enormous, Battalion size base camp while operating on Iron Mountain 9 miles northwest of Fire Support Base San Juan Hill.

While moving along a trail on the western slopes of Iron Mountain the point Specialist Four James Ambrowick (New Berlin, Wisc.) spotted freshly cut bamboo along the side of the trail. Proceeding cautiously along, a large combination base camp and training area was found. "The base camp was new and being rebuilt, it had been cleared out in the last five days," said Lt. Michael Monaghan (Satellite beach, Fla.) Platoon Leader of the Second Platoon. The base camp contained 50 hooches and bunkers, (Cont. on pg. 3 Col 1)

A BEAR VISITS CHARLIE

Human beings are not the only creatures which utilize the numerous trails in Vietnam as was learned by Charlie Company 4th Battalion 3d Infantry when the Mountainmen bagged a bear while working in ambush four miles north of San Juan Hill.

"It was late at night when we heard someone stomping down the trail towards us," said Staff Sergeant Hayes (Rocky Point, N.C.). "At that very same moment movement was also heard to our rear. Since our claymores were facing the trail only a few men opened up with the claymore and M-16's while the rest of the Squad sprayed the area to our rear." Being too dark to check out the area, the Squad spent a very restless night in ambush waiting for daylight to break. When dawn finally arrived the men moved out onto the trail only to find to their surprise a 150 pound bear lying in their midst.

classrooms, a mess hall and combination sapper training area and obstacle course made of barbed wire. Numerous documents were found in the camp along with one RPG round, two Bangalore Torpedos, 50 pounds of corn, binoculars, and numerous other small items. Among the documents, attendance records and photographs were confiscated. All hooches and bunkers were destroyed and the platoon moved on in hopes of finding traces of the occupants.

LOCK IT UP

As of late numerous items have been reported missing or stolen in the rear of the 4th Battalion 3d Infantry and on San Juan Hill. The Battalion Executive Officer Major Jew stresses that all items of value such as radios, tape players, and cameras should be locked up when not in use. Each company provides a safe in its orderly room for those who do not possess secure space of their own. Serial numbers of weapons and other government property issued to the individual should be recorded for your protection. The serial numbers of MPC in denominations of ten dollars and higher should also be recorded as well as any other serial numbers of personal items.

These precautions are outlined for your protection and in hopes that the number of missing articles in the Battalion can be reduced.

RECON NETS I

A stay behind ambush pays off as the Mountainmen of the 11th Brigade net one VC while working three miles north of Fire Support Base San Juan Hill.

Securing the Command Group and Four Duce Mortar Platoon, while the Battalion was operating in the area of the 516 valley; Recon 4th Battalion 3d Infantry, remained behind as a stay-behind ambush after the Command Group was removed from the hill. Set back in the woodline approximately 50 meters from the old NDP, on the morning of the 3d of October, Recon spotted 3 VC in the old sight. PFC Douglas Leifleit (Yorkville, Ill.) was the first to sight the enemy and quickly informed the other members of the platoon to move up on line. In an instant the firing began as the men unleashed the power of their M-16's and 79's. Reconning as they moved down to the sight of contact the men found one VC dead and the blood trails of another. Following the trail of the wounded VC the men were unable to find the body. Searching the dead VC's body the men found nothing of substantial value, thus moved back into ambush.

might have been the noises we heard on the trail," reported Specialist Four Steven Ball (Carteret, N.J.), "We set another claymore and moved back into our ambush position to eat breakfast." As the men ate movement was again heard on the trail to their front. Quietly the men waited. Another claymore initiated the action as the men moved out reconning with M-16's. Lying wounded and moaning on the trail was one VC, an AK-47 lay to his side. The medic was called as was a dustoff, however the VC died before the dustoff could arrive.

Confiscated from the scene was one AK-47, one magazine containing 30 rounds of AK ammunition and some food. All was evacuated to LZ San Juan.
