



b. Intelligence:

(1) Primary sources of intelligence information for Headquarters Battery during the reporting period was the G2 section, XXIV Corps Artillery. Batteries A and G/65 received intelligence information from the S2 section, 1st Brigade, 5th Infantry Division (Mechanized). Battery B was given intelligence information from the 2nd Battalion, 94th Field Artillery. Battery C received intelligence reports from the G2 section, Americal Division. G2 of the 101st Airborne Division (Airmobile) sent intelligence summaries to Battery D. Battery G, 29th Artillery received intelligence information from the S2 section, 11th USMC Regiment, 1st USMC Division. Supplementary information was received from XXIV Corps in the form of intelligence summaries and periodic intelligence reports and estimates from field commanders of supported units.

(2) Two tropical storms, KATE and LOUISE, struck the coastal areas on 25 October 1970 and 27 October 1970 respectively and resulted in light damage to bunkers on outlying fire bases from KATE and heavy flooding from LOUISE.

(3) Enemy Activity: Reduced drastically as a result of the storms and flooding.

(a) Mining incidents were moderate during the reporting period.

(b) Stand-off attacks increased toward the end of the period but were generally light.

(c) Enemy ground activity remained light throughout the reporting period.

c. Operations:

(1) General: The mission of the 1st Battalion (AW)(SP) 44th Artillery and Battery G (MG) 65th Artillery, continues to be general support of XXIV Corps. Battery G (SLT) 29th Artillery continues the mission of providing battlefield illumination to XXIV Corps.

(3) Significant Events:

(a) On 5 August 1970 at 1640 hours, the Dusters at FSB Dragon were firing suppressive and protective (S&P) fires. Impact of rounds started fires on a hill which in turn caused 10 to 15 secondary explosions, believed to be enemy mines and booby traps.

(b) On 23 August 1970 at 0730 hours, two Dusters from Battery C, 1st Bn (AW)(SP) 44th Arty conducted a "Duster Raid" on Hill 59. The Dusters fired 1389 rounds in the combat exercise. Results of the raid were two secondary explosions. (See para 2c(2))

(c) On 5 September 1970 at 1350 hours, two Dusters at An Do (T-Bone) were requested for support on a contact mission approximately 2,500 meters in front of their position by ARVN's. Dusters fired 350 rounds. There were 9 NVA KIA: 3 AK-47's and 3 B-40 rockets captured.

(d) On 8 September 1970 at 0213 hours, movement was spotted thru a starlight scope to the north front of the Duster position at FSB Cindy. The 2 Duster crews, C121 and C122, proceeded to fire a total of 120 rounds at the enemy movement. At 0420 hours, FSB Cindy, the Special Forces Compound and the local MACV Compound came under simultaneous mortar attack. At 0440 hours, these three areas were hit by a heavy ground attack from the 406th NVA Sapper Battalion. C121 and C122 laid down a heavy volume of fire at suspected and known enemy concentrations. The enemy succeeded in overrunning both the Special Forces Camp and MACV Compound but were turned back in their attempts to breach the wire at FSB Cindy. The Duster crewmen were given official credit for 26 enemy KIA. The men of Battery C, 1st Battalion (AW)(SP) 44th Artillery sustained no injuries or damage.

(e) On the morning of 9 September 1970, PFC Howard E. CHENAULT, Jr. asked for and was granted permission to search the river bank in front of the gun positions for dead or wounded enemy. Approximately 500 meters outside the wire and on the river bank, PFC CHENAULT spotted two Viet Cong hiding in the brush. He succeeded in capturing one enemy soldier while the other evaded deeper into the brush. Vital information was obtained from the prisoner about the attack of the night before and subsequent attacks planned by his unit, the 406th Sapper Battalion. The prisoner

stated that the failure of the attack on FSB Cindy was due in a large degree to the heavy volume of fire put out by the Dusters. The early spotting of the enemy troops and subsequent fire brought upon them threw the enemy battalion into a state of confusion and disrupted their planned attack.

(f) On 17 September 1970 at 1015 hours, personnel from Battery A, while running a resupply mission to A-2, hit an unknown type of mine on QL1, in the vicinity of Gio Linh (V). Results were a 2½ ton truck combat loss and 4 US WIA.

(g) On 3 October 1970 at 0835 hours, a Duster from Battery C, while on a mine sweep operation from FSB 411, hit a command detonated plastic mine. Results were 1 M42A1 Duster combat loss, 1 US KIA and 3 US WIA.

(h) On 6 October 1970 at 2050 hours, MACV personnel stationed at An Do (FSB T-Bone) spotted unknown number of VC southwest of their position. Duster fire was requested. Dusters fired 240 rounds. Results were 8 VC KIA confirmed by MACV personnel.

(i) On 9 October 1970 at 0700 hours, a section of Dusters from Battery B, 1st Battalion (AW)(SP) 44th Artillery stationed at FSB Baldy went on a reconnaissance by fire with a Marine Combined Unit Pacification Program (CUPP) team. The patrols discovered caves with clothes, empty C-ration cans and other materials, including one cave apparently configured as a classroom. Booby traps were set up. After the patrols returned to the CP, the Dusters fired 300 rounds into the area leaving it in smoke.

(j) On 17 October 1970 at 0905 hours, elements of the 1st Battalion (AW)(SP) 44th Artillery stationed at FSB Nancy received a call from elements of the 14th Combat Engineers who were on a mine sweep to FSB Barbara. They were caught in an ambush by approximately two platoons of the 31st NVA Company. Two Dusters from FSB Nancy reacted in five minutes and within 18 minutes were at the site of the ambush. Also responding to the request was the truck mounted Quad 50, also stationed at FSB Nancy. The high volume of fire from the Dusters and Quad 50 broke up the ambush. The Dusters fired 1,000 rounds and the Quad 50 fired 12,000 rounds. Results were 2 US KIA, 3 US WIA, 12 ARVN WIA and 11 NVA KIA.

(k) On 23 October 1970 at 0100 hours, the Duster crewmen on Nui Yon spotted a VC company moving 800 meters to the southwest of their position. The two Dusters fired a total of 900 rounds at the enemy. Results of the firing were; 5 enemy KIA, 1 each AK-47 rifle and 120 kilos of rice captured.

(l) During the reporting period elements of this battalion

1. supported 24 convoy security missions and 89 minesweep operations.

2. Withstood 51 stand off rocket and/or mortar attacks with a total of 356 enemy rounds received. The size and number of rounds were: 60mm mortar - 62; 82mm mortar - 143; 122mm rocket - 75; 140mm rocket - 14; 58 unknown size mortars and 4 unknown size rockets

3 Responded to a total of 3 radar or sensor targets with a total of 185 rounds expended.

(i) The Searchlight Battery continued to perform its mission of perimeter defense for guarding fire support bases, logistical outposts, bridges, roads and other key installations with illumination (visible and infrared) in support of night operations in the XXIV Corps AO. This has resulted in 16 searchlight assisted enemy contacts resulting in 41 enemy KIA, 1 boat destroyed and secondary explosion.

(1) Two memorial services were held.

(2) During the reporting period, the Battalion Chaplain conducted 70 worship services as follows:

(a) Base Camp - 30.

(b) Field Locations - 40.

(3) Special Activities:

(a) During August and September, the Battalion Chaplain served as Compound Chaplain during the absence of the Viking Compound Chaplain

(b) During the reporting period, the Battalion Chaplain began relocating the Battalion Memorial Chapel from Dong Ha Combat Base to Viking Compound located at Red Beach, Da Nang. The memorial items were removed from Dong Ha and will be placed in the chapel at Red Beach when construction is completed.

f. Medical:

(1) During the reporting period, there were 370 out-patient visits to the aid station, and 1370 immunizations given. The majority of which were given during an influenza program where the entire battalion was immunized.

(2) The most common and frequent diseases were skin diseases, acute respiratory infections, diseases of the ears, nose, throat and various injuries, mostly minor. There have been no cases of typhus, cholera or plague seen in the battalion. There have been two cases of malaria during the reporting period. Both men have returned to duty.

(3) Sanitary inspections are conducted by the battalion surgeon or other medical personnel once a month. During the reporting period, all inspections have been satisfactory.

(4) A drug amnesty program was initiated during the reporting period. After initially encouraging results, there has been no obvious improvement in the drug situation. The program will continue.

g. Civil Affairs: When the move from Dong Ha to Da Nang was completed, the 1st Bde, 5th Inf Div (Mech) took over the Civil Affairs Program of the 1st Bn (AW)(SP) 44th Arty, which consisted mainly of MEDCAP's in the Dong Ha/Gio Linh area.

h Education:

(1) 1st Bde, 5th Inf Div (Mech) Education Center, Quang Tri Combat Base administers all courses and tests for Battery A and Battery G, 65th Arty.

(2) The 80th Support Group, Da Nang, administers all courses and tests for HNB, Battery B and Battery G, 29th Arty.

(3) The Americal Education Center in Chm Lai administers all courses and tests for personnel of Battery C.

(4) The 26th General Support Group, Phu Bai Combat Base, administers all courses and tests for Battery D.

2. (C) Lessons Learned: Commander's Observations, Evaluations and Recommendations:

a. Personnel: None

b. Intelligence: None

c. Operations:

(1) Top door cover safety:

(a) Observation: This unit has experienced trouble with the top door covers on M42A1 Dusters blowing open during firing.

(b) Evaluation: Command Emphasis was placed on this safety hazard and it was determined by the firing sections that the top door cover latch would vibrate to the open position during firing. This was caused by the locking pin being too short to withstand the vibration caused by firing.

(c) Recommendation: That a safety wire ring be attached to the cover latch lever and the handle, thus keeping the lever in the locked position. When opening the top door cover, the latch lever is brought back counter-clockwise and the safety ring is removed. The lever is then moved clockwise to open the top door cover.

(2) Duster raid concept:

(a) Observation: This unit has experienced outstanding results by utilizing the Duster in a bold, sudden direct fire attack against known or suspected enemy locations in the vicinity of friendly fire bases or base camps.

(b) Evaluation: In many cases, more effective fire can be brought to bear against moving or entrenched enemy forces, cache sites, etc., by using rapid direct fire rather than indirect fire. Because the Duster Raid involves line of sight, speed and surprise are of greatest importance. Rapid deployment utilizing unlikely routes of approach to the raid site will

CONFIDENTIAL

lessen the probability of ambush or mines and lend to the element of surprise. Upon arrival at the raid site, the personnel will immediately set up perimeter security and commence firing at preplanned targets and targets of opportunity. Upon completion of firing, perimeter security will withdraw and the Dusters will depart the area with the security element being last to leave. The amount of time spent on the raid site will be dependent primarily on available targets and standby support. The smallest recommended Duster Raid consists of two Dusters and one APC. The APC is used as a command post and as a means of transportation for the infantry security force. Two additional Dusters should remain in a relatively secure area with the mission of providing covering fire and standby support to the main force as well as to replace either one or both of the raid Dusters in the event of breakdown or damage. During daylight hours, one squad of infantry with on-call artillery and ARA is considered to be sufficient local security for the raid. Long duration raids and night raids require a larger security force, the size of which would depend on the nature of the raid.

(c) Recommendation: That the Duster raid concept be initiated and utilized in like units and integrated in their plans of operations.

- f. Organization. None
- g. Communications:

(1) Observations: At present, the Battalion Headquarters is located in the Da Nang area with its northernmost batteries at Dong Ha, 142 km away and its southernmost battery at Chu Lai, 70 km away. Elements of the battalion are located at 58 sites throughout the 1st Military Region. The primary means of tactical communications is FM radio (secure). To reach all the batteries, it is necessary to employ a retransmission station located at Hai Van Pass, 10 miles north of Da Nang. The distance required to communicate with the batteries greatly exceeds the planning range of the VRC 12 series radios. The USMC logarithmic periodic antenna (bi-directional, vertically polarized) provides the best results. The retransmission station gives dependable communications with the battery in Chu Lai, and the battery in Phu Bai, but FM communications with the batteries at Dong Ha is marginal. To circumvent this, an AM radio (AN/GRC-106, voice, non-secure) is employed between Dong Ha and Da Nang. The batteries are faced with the same problem on a smaller scale. Due to the nature of the mission of this unit, the batteries are also spread beyond the normal disposition for a battery. One battery in particular, G/29 (Searchlights) is spread throughout the 1st Military Region.

(2) Evaluations: The authorized communications equipment was not allocated with the concept of such widespread deployment. Consequently, it is not sufficient to insure dependable tactical communications. The present deployment makes it necessary to employ retransmission stations. This unit is not authorized the necessary personnel, equipment or frequency allocations to install the needed retransmission stations. Frequency allocations

are the most crucial of these requirements. At present, the battalion is operating on seven frequencies. With six batteries and a battalion command net requiring two frequencies, current operations do not allow alternate frequencies, and two of the batteries are sharing one frequency. A temporary authorization for additional personnel, equipment and frequencies will enable the implementation of additional retransmission stations. An additional retransmission station for the battalion command net and one for each of the four batteries would provide reliable tactical communications. The logarithmic periodic antenna (USMC, bi-directional) has proven to be an effective antenna for extending the range of FM communications for directional employment.

(3) Recommendations: That a MTOE change be requested for this equipment upon the approval and return of the currently submitted detailed MTOE.

2. (C) Comments follow:

a. Reference item concerning "Top door cover safety," paragraph 2c(1), page 8: concur. Review of subject "fix" on site did not indicate any major problem in using the safety wire. Recommend continued use. Unit will be advised to submit an EIR with pictures showing the fix to CG, US Army Weapons Command, Rock Island, Ill. 61201.

b. Reference item concerning "Duster raid concept," paragraph 2c(1), page 8: concur. To date experience gained from this technique has been limited due to the small number of raids conducted, however results have been good. Special emphasis should be placed on protective measures to counter the enemy mine threat when planning raids in areas where mines are encountered.


1. This Headquarters has reviewed the Operational Report-Lessons Learned


