During the preparation, the men disassembled radio antennas, 81mm mortar equipment, tents, etc;. The equipment was then loaded aboard vehicles and convoyed from the area.</p> <p>During the preparation for redeployment, of the 4th Bn, 9th Inf, 25th Inf Div, elements of the 1st Bn, 508th Inf, 82nd Abn Div, moved into the area with their equipment and began setting up tents, 81mm mortar equipment, TOC, etc;. During their preparation, a portion of the 1st Bn, 508th Inf, 82nd Abn Div, participated in a Search and Clear Mission (S&CM), in a near by village.</p> <p>On 11OCT68, elements of the 4th Bn, 9th Inf, 25th Inf Div, located approx 16kms Northwest of Saigon (CU CHI), took part in a S&CM. Their movement was in a pear-shape, around their support base, covering approx 6000 meters. The elements discovered tunnel complexes and other bunker type locations utilized by the Viet-Cong. Booby-traps were found in the result of killing one man and wounding two others. A Medical Evacuation Helicopter was flown in to extract the men. Pulling back and marking out a new route, the elements continued the S&CM as artillery was then called into the booby-trap area.</p> <p>This footage depicts elements of the 4th Bn, 9th Inf, 25th Inf Div, in the preparation for redeployment. Members of the 1st Bn, 508th Inf, 82nd Abn Div, replacing the 4th Bn, 9th Inf, 25th Inf Div.
