THIS FILM CAN BE USED FOR HISTORICAL DOCUMENTATION, NEWS RELEASE, etc. THE STORY WAS PHOTOGRAPHED BY USING BASIC AND WELL ESTABLISHED MOTION PICTURE PHOTOGRAPHIC TECHNIQUES.</p> <p style="text-align: center;"><u>SUMMARY</u></p> <p>On Oct 1968, in Chu Lai, RVN, (approx 360kms NNE of Saigon), elements of the 126th Supply and Service (S&S) Company, continued their operation of Class I (Food), Class II, IV (Construction Type Materials), and Class III (Petroleum, Oil, Lubricants - POL), distribution, and a Quartermaster clothing issue.</p> <p>The 126th, commanded by CAPT Donald L. KEIL (Quincy, Ill.), was called for active duty for the Vietnam Conflict in April of 1968, and reported for active duty 13 May 1968.</p> <p>The unit arrived at its mobilization station, Ft. Carson, Colorado, from Quincy, Illinois, on 20 May 1968, for Preparation Overseas Replacement (POR) Training prior to shipment to RVN.</p> <p>Since its arrival in Chu Lai (approx 18 Sep 1968), the 126th has been participating in Supply and Service operations for elements of the Americal Division.</p> <p style="text-align: center;"><u>NOTE</u></p> <p>INITIAL COVERAGE OF THE ARRIVAL OF THIS UNIT WAS NOT MADE AS DASPO RECEIVED ONLY TWO (2) HOURS ADVANCE NOTICE OF ITS ARRIVAL, FROM UNIT MOVEMENT CONTROL AT LONG BINH, RVN.</p>

1. BASIC CAMERA TECHNIQUES

- a. Basic Sequence Completion of scenes is weak (Ex: Roll # 1 of boots and helmet liners)
- b. Cut ins and /or cut aways OK
- c. Choice of angles Poor angle on man at counter in Roll # 1.
- d. Length of scenes Too long of man at counter in Roll # 1., otherwise good.
- e. Story Continuity Inadequate (See below)
- f. Focus OK
- g. Exposure You needed a reflector(s) on this job, particularly on the truck loading sequences.
- h. Picture Steadiness Good
- i. Composition and Framing Good
- j. Panning and Tilting Nice zoom and pan on Roll # 1 (liners being loaded on ~~truck~~ truck.)
- k. Interior Lighting See "g" above
- l. Slates Good

2. CAPTIONS: Good except for para. 3 of Coverage Objective which doesn't really say anything definite about your planned photographic approach.

3. GENERAL REMARKS: Story planning was inadequate; this does not constitute a complete story of 126th Activities. (This is the first and only shipment on this project.) I have a feeling that a number of activities, particularly interior activities, were not covered and should have been. How about storage of Class I, II, IV materials? Stock

4. CONSIDERED FOR DASPO AWARD? YES NO ☒ records maintenance? Construction materials? Since the story is about the 126th S&S Company, you could have depicted
