1. The Department of Army Special Photo Office team (DASPO), which is presently in-country, is an element of the United States Army Photographic Agency (APA) under the Assistant Chief of Staff for Communications and Electronics. The team provides still and motion picture documentation of Army activities on a continuing basis for the Department of Army which is used in briefing the C/S, USA. The team's present assignment in Korea is to provide filmed documentation of DMZ incidents and activities, provide coverage of the present situation as it develops, and document the arrival of any new units and organizations.

2. The DASPO team recently completed an assignment in Korea, during which time it provided the Department of Army with motion picture color film, still photos and sound tape coverage of Eighth Army activities within the DMZ and Korea. Invaluable material was gathered and forwarded to Department of Army to help tell the Eighth Army Story.

3. The DASPO team is cleared to film classified material.

4. The primary mission of the DASPO team is to provide timely coverage of events as they occur and each commander and staff will insure that all available assistance and support is given them.

1. References:

2. In reference to paragraph 1a, coordination has been effected and approved by this headquarters. All subordinate commanders are requested to assist the DA Special Photo Office Teams (DASPO) in accomplishing their mission with the least possible delay consistent with defense security requirements.

3. The photo teams will be taking aerial, interior and exterior photographs and film of sites and activities assigned or attached to the USASTRATCOM Signal Brigade Command.

4. Teams will report to major subordinate commanders for coordination and access clearance to sites and activities. It is requested that major subordinate commanders insure that site and installation commanders are given timely advance notification to permit accomplishment of the DA Photo Team's mission.

5. Photo teams are cleared to film classified areas (paragraph 3, reference 1a) but will not be authorized access to CRYPTO areas or material. The individual's security clearance as indicated on his orders will govern his degree of access to classified areas for photographic or filming purposes.

6. It is anticipated there will be individual changes to the member composition of photo teams. Copies of an individual's orders indicating his connection to the DA Photographic Activities, and a valid identification card -- DD Form 2A, are sufficient to authorize access for accomplishment of the teams mission.
