1. The inclosed requests are returned without action.
2. Credit for Vietnam and short tour for each of the enlisted men concerned will be computed in accordance with Table 1-1, Rules 4 and/or 5, page 1-5, AR 614-30 dated 22 October 1968 by the custodian of the personnel records. Entries will be made on DA Forms 20 and Morning Reports crediting EM with either a short tour other than VN or a VN tour as appropriate and establishing the DEROS for credited short tour.
3. Since EM are presently serving on a long tour, the last sentence of footnote 3, Table 1-1, page 1-5, AR 614-30 applies and EM will continue to serve on present long tour, the DEROS for which will remain unchanged by this short tour credit computation.


