Dear Friend:

If you believe that federal bureaucrats have a moral or legal right to forcibly take and transport your own flesh and blood to an integrated school miles away --and then force you to pay for it by raising your property taxes--then don't read any further--you are already a slave.

Forced busing for racial integration is not just an unconstitutional violation of your natural right to decide for yourself how your children are to be educated, IT IS CLEARLY ILLEGAL AND CONTRARY TO LAWS PASSED BY CONGRESS!

In the 1964 Civil Rights Act, Congress said that nothing in that Act was to "empower any official or court . . . to issue any order seeking to achieve a racial balance in any school by requiring the transportation of pupils from one school to another." And in the Appropriations Act for HEW, Congress also said: "No part of the funds contained in this Act may be used to force busing of students."

### THE PEOPLE ARE AGAINST FORCED BUSING

The newest Gallup Poll admits that only 18% of adults favor forced busing. Most parents of all races want neighborhood schools. Any reasonable person can plainly see that busing creates racial tension, lawlessness and violence where none existed before. It contributes to the already-overpowering dope and VD problem among our youth and it is certain to lower educational standards in every school where it is enforced.

The public outcry against busing is so intense that it has forced President Nixon to say that he wishes to hold it to a minimum, and his Chief Justice has hurriedly concluded that there is nothing, after all, in the Constitution which requires a certain racial balance in public schools.

AND STILL BUSING CONTINUES. Parents demonstrate and are sent to jail. Many refuse to allow their children to attend integrated schools. Thousands flee from cities--the exodus is so bad that realtors complain that property values are depressed in whole sections of Pasadena. The Supreme Court's illegal "law" is an object of contempt; school buses have to be guarded day and night to prevent their destruction. Meanwhile, financially hard-pressed school boards look for money to buy more school buses. And Property taxes are raised to pay for it all!

Governor Wallace has said that inmates of an insane asylum could write better opinions than Mr. Nixon's Supreme Court. Indeed--the whole mess IS insane.

But let me ask you some questions. WHY this fantastic pressure for busing? And WHO is behind it all? And WHAT is their real aim?

I am sure you know the answer as well as I. The forces behind busing are the same Left-wing radical planners who have already led this Nation far down the road toward national destruction. Apparently they feel strong enough to drop their smiling, "democratic" mask and hardly bother to try and conceal their real brutalitarian nature as they arrogantly rearrange America's social, racial and cultural makeup prior to our planned "absorption" into a communistic world government.

BUT THEY HAVE GONE TOO FAR, TOO FAST! From Boston to Inglewood and San Francisco to Jacksonville a great spontaneous reaction has erupted which-- if it is mobilized and directed properly--can accomplish far more than merely stopping busing!

#### WHAT WE MUST NOW DO

The opportunity that awaits patriots is enormous and we must take the fullest advantage from it. Here is what we must do--and working through LIBERTY LOBBY we can do it because LIBERTY LOBBY is in an almost perfect position to accomplish what needs to be done:

\*In many cities (such as Pontiac, Michigan, from which I have just returned) the aroused parents and taxpayers are already organized. We should aim to tie them together with channels of communication. As a national "clearing house" of information, our SOS Project will supply them with vital facts they need about what's happening in other sections of the Country, and about important legislation in Congress. We will notify them of important congressional hearings, and insist that they send representatives to testify on pending legislation--and pay their travel expenses, if necessary . . .

\*We will assist the local groups in securing a pledge from their congressmen and senators to support H.J.Res. 30 and S.J.Res. 112--constitutional amendments aimed at stopping busing. AND WE WILL WATCH THESE CONGRESSMEN TO SEE THAT THEY KEEP THEIR PROMISE! . . .

\*We will help the local groups secure nationally-known speakers for local rallies and meetings, and use these rallies to recruit new people. . .

\*We will organize a national FREEDOM OF CHOICE rally in Washington for the purpose of exerting guidance to Congress and selecting objectives of the movement. . .

\*And we shall show these newly-aroused, concerned Americans how busing is really only part of a much larger picture--how busing, sensitivity training, experimental drugs, communal living, sex mis-education and racial integration is tied in with the United Nations plan for world government!

We have received an initial grant from LIBERTY LOBBY to get our expanded program under way but the rest is up to you. The scope of our activities and its ultimate success will largely depend on our budget. The elections are coming up. Properly financed, we can make forced busing such an issue that no politician would dare support it. We can augment the Conservative cause by many thousands.

The safety and the very lives of our children are at stake. Rape, robbery, extortion and terror are daily occurrences at highly integrated schools. The teachers themselves are often intimidated and many times make no attempt to protect children who are forced to attend classes with Negro children who have been indoctrinated with anti-White hate by Black Panther parents. In the worst of these schools, armed policemen are unable to keep order, yet we are told to send our helpless and unarmed children to these jungles.
