

THEY'RE TAKING YOUR GOLD!

Over the last ten days, LIBERTY LOBBY has conducted an intensive study of Congressional reaction to the proposed elimination of the gold reserve requirement on Federal Reserve Notes, a move endorsed months ago by international banker David Rockefeller.

Continuing, minute-by-minute reports from the Hill have been alarming, and are growing worse. It is now certain that an Emergency situation does exist.

Within two weeks, YOUR two senators and YOUR congressman may vote to surrender their very last measure of control over our money supply. Even worse, such an incredibly irresponsible step would deprive our Nation of one of its most vital strategic resources . . . a resource that will someday be essential to the preservation of the liberty of the American people in event of war; or the preservation of their lives in time of famine!

Our ten billion dollar domestic gold reserve is important in two ways. It not only serves as a barrier to printing-press inflation by a vote-hungry President; but it also is our only national supply of gold. Once the 25% gold reserve requirement is repudiated, our ENTIRE REMAINING GOLD STOCK automatically becomes the property of any foreign speculators who want it.

This is not a mere question of whether or not there should be any gold "backing" to the dollar. Rather, it is a question of whether or not this Nation should possess any gold at all!

"DOWN TO THE LAST BAR"

Administration spokesmen have repeatedly stated that they intend to pay out our gold to foreign claimants "down to the last bar." Yet everyone knows that this merely postpones the INEVITABLE DAY OF RECKONING when the Administration's long-standing fiscal irresponsibility will finally force us to raise the price of gold. SPECULATORS WILL THEN DOUBLE THEIR MONEY OVERNIGHT. NO WONDER THE INTERNATIONALISTS WANT THE REST OF OUR GOLD.

If you are utterly amazed that Congress would seriously consider such a proposal, remember that as usual, the "free press" is partly to blame. Only a few papers have editorialized against it, while the entire liberal establishment, taking its lead from the international bankers, has echoed the half-truths and lies about gold in a flood of propaganda.
