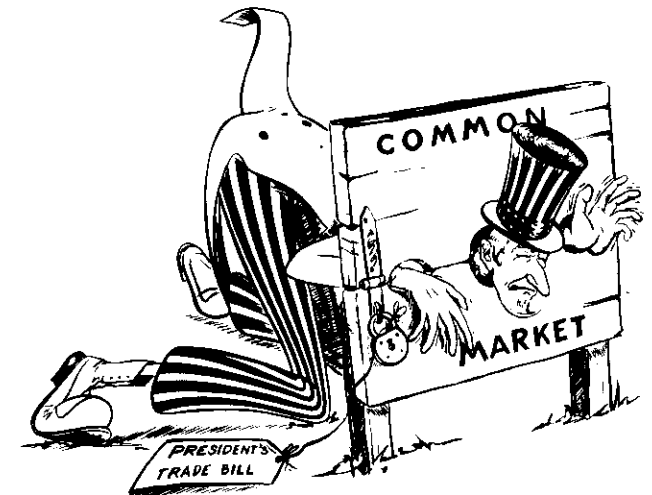

Trade Agreements First Step  
In Handcuffing United States  
To Crippling World Government

## DID YOU KNOW THAT—

- Since Congress “temporarily” gave up its constitutional authority over America’s economic sovereignty by enacting the so-called Reciprocal Trade Act in 1934, the Act has been renewed 11 times—each time on an “emergency” basis?
- During that time, tariffs on foreign imports have been reduced by 80 percent?
- United States tariffs are among the lowest in the world?
- President Kennedy not only wants the Reciprocal Trade Act renewed; he wants vastly increased power to lower tariffs in order to equalize our standard of living with the European Common Market?
- His “Trade Expansion Bill” gives him authority to cut tariffs another 50 percent and in the case of some items to completely eliminate tariffs?
- Wages in Common Market countries are much lower than ours—in Great Britain, for instance, they are only one-third as high as ours; in Italy, only one-sixth?

When protective tariffs are removed, cheap-labor goods flood the country.

Between 1953 and 1959, imports of foreign plywood increased 492 percent, from \$21.1 million to \$98.8 million.

In 1948, American firms had 91.4 percent of the American tuna fish market; in 1955, they had only 45 percent of it.

In every industry, imports are taking larger and larger chunks of American markets. Look at how rapidly imports are increasing:

The immediate results of lower tariffs are apparent—dwindling earnings for American firms, growing unemployment for American workers. But there is a long-range danger, even more ominous—

## “Euramerica”

“Euramerica” is one of the names suggested for a new Atlantic Community, a super-government which would abolish United States independence. Our great nation would be combined politically, militarily, economically and culturally with North Atlantic Treaty Organization countries.

*“Euramerica” is not just speculation. The Declaration of Paris, signed in January by the 15 NATO countries, calls for creation of limited world government within the next 10 years. An international court of justice would issue decrees superseding our own decisions. “Euramerica” would have a monopoly in heavy armaments, including all nuclear weapons. It would absorb U. S. armed forces.*

Some proposals would give “Euramerica” the power to levy taxes, issue currency, regulate commerce, fix standards for “social services” in all member countries, and accept other nations—presumably even Communist nations—as members.

“Euramerica” would put the United States in a political, economic and military straight-jacket. It would strip us of our national sovereignty.
