### "Dismantle the LEAA"

NEW YORK, April 10 -- The Boston City Council will open crucial public hearings on Tuesday, April 30, on the subject of "CIA infiltration of the police" in what is the immediate focal point of the most decisive battle in the history of North American politics. At the request of Boston City Councilman Dapper O'Neill, representatives of the National Caucus of Labor Committees will be the first scheduled witnesses. The NCLC will give concrete testimony documenting the role of the criminal CIA domestic police apparatus, the Law Enforcement Assistance Administration (LEAA), in the pervasive illegal takeover of legally constituted government in Boston. NCLC press conferences scheduled for Monday, April 15 in dozens of cities across the country will focus public attention on the upcoming Boston City Council hearings. With this step, the NCLC unleashes a multi-faceted counteroffensive against the heart of the CIA's domestic operations. Our aims are simple and precise. The total dismembering and liquidation of the LEAA and all its foul activities. From Boston, the site of the most blatant and advanced illegal activities by the LEAA, this campaign will immediately be spread to Seattle and New York City, consolidating political allies along the way. (Scores of other municipalities whose local elected governments are presently under severe attack by the LEAA's national Gestapo apparatus will extend the working class counteroffensive to every city and state slated for large scale military operations this year by the LEAA.) Negotiations with key politicians and local elected officials are presently underway, aimed at replicating the political conditions made possible in Boston by the hearings.

## THE PRESENT IS THE FUTURE

Parallels in Canada point to a more advanced network of special military counterinsurgency units set to implement regional military takeovers in the event of a "civil emergency." CIA forces are presently activating contingency plans for food and transport disruption and SLA type terrorist incidents in order to create immediate "civil emergencies." In Quebec, the Committees on Public Safety have set up local tactical units with the LEAA's "consultation." The immediate future of U. S. cities is determined in Canada.

## LEGAL SUIT TO DISMANTLE LEAA .

Additionally, the NCIC is in the final stages of preparing a legal suit. The suit will call for the liquidation of the LEAA based on evidence of its activities (evidence largely in the public domain) which are blatantly illegal under the following Federal and international laws: The Nuremberg Codes of International Law, prohibiting the use of brainwashing, behavioral modification techniques which are expressly designated as crimes against humanity; Federal criminal anarchy statutes; and the National Security Act of 1947, which explicitly forbids domestic operations by the Central Intelligence Agency..

### BOSTON

The LEAA network in Boston centers around "former" CIA official Robert Kiley and top LEAA police administrator Robert DiGrazia. Kiley, who is presently Deputy Mayor for Community and Social Services, has a CIA career going back to its infiltration of the National Student Association. His tenure of an officer's post in CIA headquarters in Langley, Virginia was followed by a stint as Director of the Police Foundation, the LEAA's "think-tank" predecessor. Most recently, Kiley has led a vicious psychological warfare operation in Boston, fermenting racial hysteria around manipulated diversionary busing/anti-busing "controversy." Kiley has personally provided assistance to the Block Association and right-wing vigilante cops in Dorchester, East Boston, South Boston, and Allston-Brighton for the purpose of molding Nazi-style blockwatcher networks. The LEAA's aim is to spark and organize race riots this spring and summer using the fertile ground of these Nazi networks to sow and spread classic rumors. Robert DiGrazia has openly presided at "community meetings on Crime" in both black and white neighborhoods for the express purpose of forming "community" vigilante police/auxiliary squads with funds and arms from the LEAA. DeGrazia himself is the product of thorough LEAA training in the job of "reorganizing the police" in St. Louis, Mo. Monday's NCIC press conference will detail other regional LEAA operations, naming the agencies responsible for these crimes. The extent of these operations can be summarized by noting that the LEAA over the past 5 years has invested \$2.4 billion in "criminal justice" projects in the U. S. The LEAA budget for fiscal 1974 alone was \$1 billion. This figure includes the entire 20 year figure for police and military training in Rockefeller owned Latin America by the CIA's murderer Agency for International Development. AID was a mere pilot project for the later development of the LEAA.

### POSSIBLE CIA SABOTAGE

In light of the politically explosive content of the upcoming Boston hearings and the NCIC's use of them as focus for a nationally-coordinated campaign, it is likely that the LEAA will attempt to sabotage them completely, by preventing the Labor Committees from giving testimony. It must be understood that any such attempt at sabotage is the work of the panicked Central Intelligence Agency.
