

S.L.A. EXPOSED AS C.I.A. HIT-MEN

NEW YORK, Feb. 16 -- The National Caucus of Labor Committees has now confirmed that the "Symbionese Liberation Army," kidnapper of Patricia Hearst, is a front for the Central Intelligence Agency, entirely under CIA and LEAA-affiliated control.

Since it is to the political advantage of the CIA and its masters to have Patricia Hearst killed following a build-up of national hope for her rescue, her murder is probable unless an immediate expose of CIA responsibility occurs.

On the basis of information collected from several kinds of sources, including police officers, we have been forewarned of an LEAA-CIA plan to organize ghetto riots and other killings leading up to a crescendo during early March of this year.

From its first appearance into prominence in press coverage during recent weeks, we have been carefully investigating the so-called Symbionese Liberation Army (SLA) as one of the CIA-LEAA created instruments for their campaign of terror. This investigation was initiated on grounds of ideological and modus operandi features of this operation.

The further information received during the past 48 hours confirms our initial suspicions. There is no doubt that the SLA is a CIA-LEAA front.

The principle evidence for this falls into two categories. Firstly, reports tracing members of the SLA to programmed behavioral modification units within prisons and similar institutions. The second type of evidence is epitomized by the SLA's use of the "Kawaida" symbol and ideology.

VACAVILLE

The two identified SLA, Donald David DeFreeze and Theo M. Wheeler, both "escaped" from prison last year. Both were inmates of California's Vacaville State Prison, site of notorious behavior modification programs sponsored by the CIA-run LEAA. Vacaville inmates are subjected to electric-shock of genitals, drugs which simulate drowning, and other elaborate tortures which make up the "aversive conditioning" routines.

This morning's New York Times reports that the Symbionese Liberation Army was born in special "sessions" and "classes of an official Vacaville prison program where political training was given.

KAWAIDA

Kawaida is not merely a symbol. Kawaida is a concept developed by Dr. John Rawlings Rees, of the Rockefeller funded Tavistock Institute, the OSS and the CIA.

Kawaida represents a set of indoctrinational precepts which in brainwashing technology would be identified as a "belief structure" to be imposed upon a brainwash victim.

The Kawaida system is identified with at least two other known CIA operations: Ron Karenga whose "US" operatives murdered Black Panthers on the UCLA campus; and LeRoi Jones, whom John Rees personally recycled into the CIA's Imamu Baraka in 1968.

SAVING HER LIFE

U. S. Attorney General Saxbe has apparently smelled a rat in the entire SLA affair. At a news conference on February 14 he suggested that police agencies, knowing the identities and whereabouts of the kidnappers, are derelict in their duty not attempting to effect Ms. Hearst's rescue and to bring the zombies to justice.

Publisher Hearst, as the aggrieved parent, made the understandable mistake of opposing Saxbe's public statement, obviously on the basis of false hopes that one can negotiate successfully with CIA-controlled zombies.

The only way in which we can reasonably expect that the SLA would be prevented from killing Patricia Hearst is to put pressure and responsibility on the group's masters in the CIA and LEAA. A full press exposure of these and related facts should be made immediately, and full cooperation should be given the US Attorney General's office in proceeding to safely extricate the victim from the zombies who are holding her captive.
