1) To be a clearinghouse for information concerning an individual's rights. This includes educating the public in constitutional and common law matters, and supplying information in cases where an individual's rights have been abused by government and its agents.

2) To provide legal services for the defense of individuals whose rights have been violated and for lawsuits against the government on behalf of individuals who have been subjected to undue harassment and violation of rights by government and its agents.

We are dedicated to the protection of an individual's rights.

Membership is open to individuals of any political persuasion, as this is a coalition, as long as they are willing to rebel against extortionary taxation. Meetings are open to the public.
